Tribal Elder Jesse Woodrow Overstreet, son of the late Lola Colbert and the grandson of the late James Colbert and Florence Walker, was born in Local (Atmore) Alabama on December 9, 1922 and lived here until 1940. He left just short of his 18th birthday for Oregon/California as a member of the Civilian Conservation Corp to work on building the Lava Beds National Monument in Tulelake, CA, the historic battleground site of the

Modoc Indian War. After that he served 2 1/2 years in the U.S. Navy on a ship in the South Pacific. After leaving the Navy he worked as a millright at local mills while rasing his family.

Jesse is 86 years old and lives in Klamath Falls, OR with his sons, Donald and Gary and daughter Evelyn. Peggy Overstreet, his wife of 60 years, passed March of 2007. Jesse always plants and cultivates a large garden and has been in good health until recently. He is currently hospitalized at the Marquis Care Facility in Klamath Falls where he is recovering from a recent illness.

An Introduction To The Planning Department

The Planning Department is one of the most vital Tribal departments yet it is one that most Tribal Members may not be aware of. It is through the Planning Department that additional funds are secured to enhance and support the services provided to Tribal Members by the 638 contracts and Tribal Government. The 638 contracts consist of base federal funding received and administered yearly through various programs of the Tribe.

The Planning Department is responsible for researching grant solicitations to identify grants that match funding needs and could enhance services provided to Tribal Members. After this extensive and sometimes tedious research, Kenny Shivers, Planning Director, and his staff will meet with the Grants Team to review all grant opportunities to decide which grants/funding are feasible and worth pursuing. The Grants Team is made up of the Planning Director, Community Development Planner, Administrative Assistant, Tribal Administrator, Special Assistant to the Tribal Administrator, Special Health Projects Coordinator, Federal Accounting Controller, CFO, Environmental Director, Education Executive Director, and the Economic Development Coordinator for CIE. After the Grants Team examines and discusses the grant opportunities, Tribal Resolutions are prepared for selected grants and presented to the Tribal Council for approval prior to submitting grant applications to the appropriate funding agencies.

Along with Kenny Shivers, Planning Director, Denise Young, Community Development Planner, is responsible for the preparation of grant applications and proposals. Anna Wilson, Administrative Assistant, is responsible for all administrative support functions, including the maintenance of grant files, processing purchase orders, assisting with budget and financial

records, and many other duties. Ellen O'Barr, Land & Real Estate Coordinator, is responsible for maintaining all Tribal land files and records, which includes deeds, coordination of tax payments, maps, and other land documents.

Kennv and his staff work closely with Tribal Administration, Department Directors and program staff in the development and submission of the grant proposals. In 2008, the Tribe submitted nineteen grant applications; eleven were awarded. When asked about the award vs. application ratio, Kenny said "We always hope to see at least a 50% award ratio, hopefully higher! Last year was a very good year for the Tribe in terms of grant awards. Arelene Mack, Special Health Projects Coordinator, is no longer in the Planning Department but in Health Administration. However Arelene is still very active in writing grants. Last year the Tribe received grant awards that have helped staff a full-time paid fire department, purchase new communications equipment for Tribal police and firefighters, provide assistance preparing income tax returns, fund youth programs, library services, cultural programs, enhance eye care services and new cooking equipment for the SAIL Center. This year looks to be a good year as well. With the economic stimulus recovery program, funding

opportunities have drastically increased. We have submitted fourteen grant applications so far this year; we expect to easily exceed last year's number of submissions by the end of June. Once grants have been submitted it is usually a three to six month waiting process before we receive award notification. We expect Tribal programs will greatly benefit from the economic stimulus recovery program."

In addition to his duties as Planning Director, Kenny is responsible for the administration of the Other Aid To Tribal Government (OATTG) 638 contract that provides supportive services to Tribal Government. He is also the project manager for the Tribal Archive Project funded through the Institute of Museum and Library Services. It is through this grant that important Tribal historical records and artifacts will be identified, collected, recorded and archived. A new Tribal Archives will be located in the new Community Cultural Education Center/Museum that is currently under construction. He is also project manager for the Indian Community Development Block Grant (ICDBG) that is providing partial funding for the construction of that building. "Most of the Tribal buildings have been constructed through ICDBG grants, or through partial payments through ICDBG."

In closing Kenny says "Although the work we do is often tedious and time consuming, it is great to look out and see the end result of our hard work. We are proud to look out and see the new full-time fire fighters. We enjoy seeing our youth participating in sports activities as well as the after school, summer youth and cultural programs. My staff and I are all proud to have been instrumental in some small way of securing funding that is needed to enhance the services provided to our Tribal Members that enable them to improve their life styles and provide for their children."

Summer LIHEAP Program

The Family Services Department received additional LIHEAP funding this year to help Tribal families who are experiencing high utility bills. Application for the Summer LIHEAP program from Tribal Member households will be accepted on the following days: Monday, June 15, 2009 and Tuesday, June 16, 2009

Applications will be for the payment of current unpaid energy bills for a maximum amount payable of \$300.00 and will be accepted at the Family Services Department located in Building 500 at 5811 Jack Springs Road, Atmore, Alabama.

Please refer to the priority application schedule below to plan to put in your application. If you cannot apply during the dates provided, *follow-up* applications will be accepted June 22, 2009 through August 31, 2009 by appointment only, Monday through Thursday of each week during regular office hours. The Summer LIHEAP program will end August 31, 2009.

Note: Priority assistance for the Summer LIHEAP Program will be given, as always, to the following applicants. The priority applicants will be provided the opportunity to be served first.

Senior Citizens (Age 55 or older),

Families with legal custody of children 5 years old and under, and Households currently receiving food stamps or TANF benefits.

Please adhere to the following schedule to make your LIHEAP application. All applications will be accepted on a *FIRST COME FIRST SERVE* basis according to the following priority schedule (no appointment required). If eligible, you will be given time to bring in your <u>June</u> or <u>July</u> bill. <u>NOTE: LIHEAP funds will not cover late charges on energy bills.</u>

All other LIHEAP applications will be accepted by appointment only from June 22, 2009 through August 31, 2009.

LIHEAP Guidelines

- You must be a Tribal Member Household,
- You must meet the income guideline of 60% of the State Median Income,
- You must be responsible for payment of some type of heating or cooling bill, and
- You must reside within the five county service area.

Eligibility for the LIHEAP Program is based on the criteria of Tribal Membership, income, and need. All applicants should bring to the interview: 1) verification of identity; 2) verification of Tribal Membership; 3) verification of monthly income and non-income for adults 19 years of age or older (verification of non-income should be in the form of a statement signed by three people with telephone numbers who are not living in the household and can verify the situation); and 4) the current unpaid electricity or heating bill. If the utility bill is not listed in the name of the applicant, a signed statement from the person listed on the bill is necessary to establish resident's responsibility for paying the monthly utility expense.

ETHICS CORNER

Greetings from the Ethics Board:

Time seems to be flying by. Here we are already into June with family vacations and reunions right around the corner. We hope everyone is able to get outside and enjoy this beautiful weather we are having



Financial fraud/or financial impropriety is one or more intentional acts developed to deceive other people and cause them financial loss.

Did you know?

- 1. The estimated cost of fraud in America exceeds \$100 billion annually.
- 2. 85% of fraud against companies involves former or current employees, suppliers, or customers.
- 3. Organizations lose approximately 6% of their revenue to occupational fraud and abuse.
- 4. Cash is the most frequent targeted asset.
- 5. Majority of occupational frauds are ongoing.
- 6. Most effective way of detecting occupational fraud is through tips and complaints.

What are some ways fraud occurs?

- 1. Forging or unauthorized alteration of a document or account.
- 2. Forging or unauthorized alteration of a check, bank draft, or other financial documents
- 3. Misappropriation of funds, securities, supplies, assets, including employee time.
- 4. Improper handling of money or reporting of financial transactions
- 5. Profiting as a result of inside knowledge of company business and activities.
- 6. Unauthorized disclosure of confidential information to outside sources.
- 7. Unauthorized disclosure of investment activities that the company is currently engaged in or is being considered.
- 8. Accepting or seeking anything of material value from contractors, vendors, or other persons providing services or materials to the company, except as permitted by policy.
- 9. Inappropriately destroying, removing, or using records, furniture, fixtures or equipment.
- 10. Failure to provide financial records when requested.
- 11. Failure to disclose conflicts of interest.
- 12. Any other dishonest act regarding finances of the company.

This is just a short list of items which are defined as financial impropriety.

One of the standards of conduct in the Ethics Code is Financial Disclosure. The standard states:

Any Tribal Official or key employee against whom an ethics complaint has been filed alleging FINANCIAL IMPROPRIETY shall file a financial disclosure statement on a form approved by the Tribal Council. Upon review of the financial disclosure statement, the Ethics Officer may seek an order from the Ethics Board for an audit of the Tribal Official's or key employee's finances. Failure to file the financial disclosure statement, submit to an ordered audit, or provide truthful information on the financial disclosure statement shall be a violation of this Code.

You may obtain a copy of the ethics code or request an advisory opinion form as well as complaint form by contacting the Chairman's office, Tribal Court, or Legal Department.

Puckett Named NRCS State Conservationist for Alabama

Dr. William E. Puckett has been named the State Conservationist for the Natural Resources Conservation Service (NRCS) in Alabama. He succeeds Gary Kobylski who retired April 3.



As a career conservationist, Dr. Puckett has extensive experience working with NRCS at the local, state,

regional, and national levels. He currently serves as the Deputy Chief for Science and Technology in Washington, D. C. Dr. Puckett holds a Bachelor of Science degree in agronomy and a Master of Science degree in soil physics and mineralogy from Auburn University. He received a doctorate in soil genesis and classification from the University of Florida.

He will be the seventh State Conservationist to serve Alabama since the 1935 creation of the Soil Conservation Service, now called NRCS. Dr. Puckett began serving as State Conservationist on April 13th.

Rare Orchid Found

Poarch Creek has some unique plants. Recently, this orchid was found growing in one of our pitcher plant bogs. One pitcher plant bog is located across the road from the new waste treatment plant and the other one is located at Magnolia Branch. The Environmental Department has to burn them off each year before the new growth begins to alleviate a lot of the noxious weeds around them.



Pitcher plants are getting pretty rare so the department is really trying to preserve what we have. Now if we can just get more orchids growing that will be great. This is just one of the many things the Environmental Department does that many people are not aware of.

We are constantly helping the contractors at Wind Creek to meet all compliance regulations also and that helps the Tribe as it grows to let the Federal officials know Poarch Creek is "on top of things".
