POARCH BAND OF CREEK INDIANS REVOLVING LOAN PROGRAM

The Tribal Council would like to announce that applications are being accepted for the Revolving Loan Program.

Tribal members meeting the eligibility requirements below are eligible for a signature loan subject to terms and conditions listed for any purpose.

Loans will be awarded on a "FIRST COME, FIRST SERVE" basis.

Eligibility Requirements:

- Must be a tribal member of the Poarch Band of Creek Indians and 21 years of age.
- Must have a minimum credit rating of 500.
- Must have household income above 50% of the U.S. Median Income.
- Must not be in default on any tribal loan or past due with any obligations to the Tribe.
- Future per capita distribution must be free and clear of any encumbrances.
- Must not be currently participating in this program.

Terms and Conditions:

- Loans will be issued up to \$5,000 depending upon individual credit worthiness.
- Maximum payback period=5 years
- Interest rate=2%
- Individuals are eligible for only one outstanding Revolving Loan at a time.

Applications are available through the Housing Authority or can be downloaded from the Housing Authority page of the Tribe's official web site at www.poarchcreekindians-nsn.gov. Please provide a copy of your driver's license, social security card, tribal id, and proof of income with your completed application.



Creating a Positive Place For Our Future The Poarch Creek Boys and Girls Club

Striving to make the Poarch community a better place, members of Poarch Creek Tribal Youth Council rolled up their sleeves and got to work. On April 22nd, in honor of Earth Day, the council prepared brochures telling how to save money and the environment all from home. Members then trekked through all of the subdivisions on a 5-mile walk personally handing out the information to tribal households.

On May 24th, the youth council took another initiative and conducted a clean-up of Lynn McGhee drive and the Manac subdivision. With the assistance of the Public Works and Public Safety Departments, members disposed of roadside trash and debris and helped make the community cleaner and safer. On June 15th, during the USET cultural night at the powwow grounds the tribal youth council helped serve food to hundreds of visitors and community members.

It is extremely rare to see people, let alone teenagers, work for the greater good and not receive a dime in payment. Since its creation the Poarch Creek Tribal Youth Council has helped bring about a positive change within the community. They do not work hard for profit, for recognition, or to pay back a debt; they do this because they love their community and the people in it. Today, the youth council stands strong against the many adversities that affect Native American Youth. They have become a family and will most definitely be the next leaders of the tribe.

The Poarch Band of Creek Indians is proud to announce the opening of the very first Poarch Creek Boys and Girls Club. Opening in the early fall of 2010, the club will open its doors to the community and give tribal youth a fun, safe and healthy place to attend after school and during the summer and winter holidays. Poarch tribal youth, ranging from ages 6-17 will be able to call the Boys and Girls club home and experience the Native American youth programming at its finest.

In addition to the club's innovative programming, the Education Department, Wellness and Activities, and the Cultural Authority will be providing instruction and activities for participants to give them a wide array of things to do including educational, cultural, and recreational activities. The Boys and Girls Club members will be broken down into three categories: 6-8, 9-12, and 13-17, giving isolation to specific age groups so lessons and activities can be geared toward each age-range.

The club itself will be headquartered at the old school house located on the powwow grounds. Details concerning transportation to the club from local schools are still being worked on; they will be publicized as soon as they are finalized.

Keeping our children safe and healthy is of the upmost importance to the tribe; they are the future. With this in mind, the Tribe wants to make sure that all tribal families can afford for their children to attend; membership into Poarch Creek Boys and Girls Club will cost very little and scholarships will be available for those who cannot afford the nominal fee.

Details and specifications of the club are still being worked on diligently by the Board of Directors for the Poarch Creek Boys and Girls Club and respective staff. As more information becomes available, it will be sent through mail-outs and/or the Poarch Creek News.

Learning The Songs Of Our Ancestors And Giving Praise To God Poarch Creek Gospel Hymn Classes

Before the Indian Removal Act of 1830, which forced the majority of the nation out of the southeast, Muscogee Creek people worshiped God with both ceremonial traditions and newly composed songs of praise that were used in Indian churches. Many attended both freely and celebrated both traditions, new and old. All that changed when Andrew Jackson forced the "savages" of the five civilized tribes, Creek, Choctaw, Cherokee, Chickasaw, and Seminole, out of their ancestral homelands east of the Mississippi River. In what was once called Indian Territory, now called Oklahoma, these songs of praise and ceremonial customs were able to become a part of daily life once again for their respective tribes.

Those Native American families who were able to stay in their homelands through treaties and hiding weren't so fortunate. Indian communities of the late 1800's all the way up to the late 1970's faced a great deal of adversity for simply being exactly what God made them to be: Native American. Forced assimilation and prejudice prohibited Native American families from practicing cultural customs, speaking their God-given tongue, and even forbidding them to worship in their own way.

Since its creation in 2006, the Poarch Creek Cultural Education program has begun to reclaim what was taken from this community so long ago; identity and pride. Through April and May of this year, tribal members and families came to learn Creek gospel hymns. These wonderful songs of praise taught tribal members the values that their ancestors held dear as well as the Creek language.

The hymn classes proved to be a great success and everyone had a wonderful time attending and learning. We hope that everyone will get a chance to take advantage of the opportunities to learn about their heritage and culture in the very near future. MVTO!



Tullis Wins-At-Large Seat, Run-Off For Secretary & Treasurer Seats

A total of 1,054 votes were cast in the 2010 Tribal Elections. and there were 709 General Council Members who voted in All three proposed Amendments to the Tribal Constitution person on Election Day. The required number needed to have passed. Of the ten candidates for the open At-Large seat on a valid election for the Constitutional Amendments is 824. the Council, Eddie L. Tullis received a total of 282 votes, narrowly upsetting incumbent Tribal Council member Helen & Hallman, who received 196 votes. Mr. Tullis will take his place at the Council table after being sworn in at the June 17th Tribal Council meeting. Helen has been a long time voice for the people on the Council and we would not be surprised to see her name on next year's ballot.

No candidate running for the Tribal Council Secretary or Treasurer seats received a majority (51%) of the votes cast during the election process, which will necessitate a runoff between the two candidates with the most votes for each position. This run-off has been scheduled for September 4, 2010. The two run-off candidates for Secretary are Incumbent David Gehman, with 318 votes, and William Lawrence Bailey (Bubba), with 177 votes. The two run-off candidates for Treasurer are Incumbent Robert "Robbie" McGhee, with 379 votes, and Amy Nelson Bryan, with 350 votes. For your convenience, the run-off notice and Request for Absentee Ballot has been included and is posted on the Tribe's official web site at www.poarchcreekindians-nsn.gov.

This year's Tribal Elections were an experience that many will never forget. For those who do not live in the area, we have had extremely hot weather since the end of April. The heat of Election Day was so overwhelming that the voter line was moved into the SAIL Center to help prevent voters from becoming overheated. The overwhelming turn-out on Election Day started early; the polls opened at 8:00 a.m., with the first vote being cast at 8:04 a.m. From the time the polls opened until around 4:30 p.m. there was a line of voters, the majority of the time the line was out the door and appeared to wrap around the building at times.

The annual Health Fair was held in the gym and Tribal Administrative information booths were set up to distribute information about their programs to Tribal Members. Representatives from AE COM (formerly Gladding Jackson) were on hand and gave an update on the Master Plan and encouraged Tribal Member input in the Master Plan project, A Place Called Poarch.

Do you know how much money this Tribe generates on an annual basis? I don't, but I should, and so should every member of this Tribe.

My name is Amy Bryan and I am a candidate for Treasurer of the Tribal Council. I would like to introduce myself to any tribal member who may not know me. I am the daughter of



Gloria Sells Krafka and Rick Nelson, the granddaughter of the "late" Eugene Sells, the "late" Roberta Sells and the "late" Marlon Nelson and Mary Nelson. I am the niece of Garvis Sells, Toney Sells, Harold Sells, Dewitt Sells, Julius Sells, Jerry Sells and Donny Nelson.

If elected I promise accountability and transparency of all Tribal Funds including funds generated by Creek Indian Enterprises and PCI Gaming. As Treasurer I could accomplish this by providing every General Council Member audited financials on an annual basis. In addition, I would be accountable to you, the general council, for every dollar spent and earned.

If you are an enrolled member of the Poarch Band of Creek Indians you are a shareholder of the Tribe's assets. Currently there are 3011 tribal members. Each tribal member has one share...nothing more, nothing less. As a shareholder, you are entitled to complete transparency in tribal activities, spending and decisions where tribal member's lives are directly impacted. The best run government is the most informed government.

Each shareholder should receive a copy of the Tribe's audited financials from a third party CPA firm. These financials should include the government branch, and more importantly the gaming and economic development branch of our Tribe. Otherwise there is no way you can determine whether the tribal leadership you have elected is making responsible business decisions on your behalf and in the best interest of the people.

The Tribe is now generating hundreds of millions of dollars and the benefit to provide audited financials to every General Council Member would far out weigh any associated cost. Let me use the "real world" as an example. In any multimillion dollar corporation, shareholders receive annual financial statements on its revenue and expenses. There is an annual shareholders meeting and voting by proxy is the norm. If elected as Treasurer, I will ensure Tribal members be

given a copy of proposed budgets each year from each of its enterprises, prior to them being approved, and a public hearing be held to go over each budget. Our Tribe has members all over the world with their own unique situation which should be considered prior to budgets being approved.

I also support:

- Reducing the senior benefit plan to 55. (This is promised every year by the candidates running, but I assure you I will fight to make sure this is implemented.) As treasurer I would have access to the financials to ensure this is feasible and will vote in favor of making this happen.
- Adding enforcement provisions to the Ethics Procedures, including separation of powers between executive, legislative and judicial branches.
- Building an assisted living facility on the reservation for our elders. While we are investing in many "for profit" projects on the reservation, we also need to invest in projects, where the return on investment is not always a financial gain, but in the human interest. An assisted living facility will give all tribal members the opportunity to return to the reservation with a peace of mind knowing they will be taken care of for the rest of their lives, regardless of their income.
- The construction of a middle and high school for our tribal member and Indian descent students living on the reservation.
- Tribal Member preference in employment and contracting for tribal members, Indian descent and tribal-member spouses.
- Employment advancement when opportunities exist for tribal members when experience is equivalent to the required education. As a sovereign nation, we have an inherent right to protect our own, and a special consideration to make decisions based on the individual needs of ALL our people;

One of the reasons I love political campaigning so much is that it is republican democracy in its purest form. Candidates make their case over several months and the people they will ultimately represent get to decide which one of them gets the opportunity to actually do so. It's why I am strongly opposed to any and all restrictions that are unconstitutional for our people. Please contact me at 251-583-0071 if you would like to discuss any tribal issues.

ROBERT "ROBBIE" MCGHEE

First, I would like to say THANK YOU for allowing me to serve as your council member over the last six years. I can honestly say it has been the most challenging, yet rewarding experience and opportunity provided to me thus far. During the past six years, we have seen many improvements – both in our community and in terms of benefits provided to our Tribal members. I



would like to have the opportunity to not only continue, but expand the work I have done for you.

Many of you may know me already. However, for those of you who may not, let me introduce myself. My name is Robert "Robbie" McGhee. My parents are Bobby Lawrence and the late Doris Daughtry McGhee. My grandparents were the late Roy Lee and Opal McGhee and the late Adam and Inez Daughtry. I am also the great-grandson of our late Chief Calvin McGhee and Joyce McGhee.

Like the generations who came before me, I believe it is crucially important that our Members have access to good education. I feel blessed to have had the opportunity to earn a Bachelor's degree from the University of South Alabama, a Bachelor's degree from the University of Alabama, and a Master's Degree from Washington University in St. Louis, Missouri.

Before coming back home, to work for the Tribe, I held several positions in federal government which included working on Capitol Hill in Washington, DC. That experience, combined with my service on the Tribal Council, has allowed me to become involved in the local, state and national concerns that affect our Tribe at all levels of government. Each of these positions has allowed me opportunities to educate myself on all issues that could possibly impact our Tribe and to advocate for Poarch in local, state, and national forums.

Currently, I am serving my second term as your representative to the Poarch Band of Creek Indian's Tribal Council. I also have the honor of representing the Tribe on the Executive Board of the United South and Eastern Tribes (USET) and as the Eastern Regional Director of the National Indian Gaming Association. In addition, I serve as the Council representative to the Creek Indian Enterprises Development Authority, (the economic development and management entity of the Tribe) and as the Chairman of the Budget and Finance Legislative Committee.

In my role as Chairman of the Budget and Finance Committee, I am responsible for reviewing, modifying, and offering recommendations to Tribal Council for all Tribal Government, Creek Indian Enterprises Development Authority, and PCI Gaming Authority budgets. Once these budgets are approved

and or modified by the Legislative Committee, our recommendations are provided to the Tribal Council for the appropriate action.

I believe that serving in these capacities, coupled with my experience as President and CEO of Creek Indian Enterprises and Tribal Administrator, makes me uniquely qualified to hold the office of Treasurer for the Poarch Band of Creek Indians – a position that is crucially important to our Tribe's financial health and well-being.

In the past six years I have served on the Tribal Council, there have been many changes to the Tribe, and I am proud of the increased services that we have been able to extend to Tribal Members. For example, every Tribal member now has the opportunity to receive a college/vocational education. Recently, we increased, by 100%, Tribal scholarships that are available to Indian-descent children. Universal Health Care is now accessible to all Tribal members who don't have existing health coverage. And we also approved funding for a financial health supplement to Tribal members who have their own insurance to assist them with offsetting their current medical costs. While the Tribal Member is the main beneficiary, they can use this benefit for themselves or anyone living in their household. Even with these added benefits the Tribal Member Birthday Check has increased by over 600%!

These definitely have been exciting times for the Poarch Band of Creek Indians. However, these opportunities exist only because you have entrusted the Council with making the tough decisions to financially plan for the future of our Tribe, Tribal members and other members of your household.

I remain determined and committed to making a real difference in the lives of fellow Tribal members and I would ask you to once again give me the opportunity to work for you. I want to contribute to the overall welfare and continued success of the Tribe by serving you again as your Council member.

When I look back over the last two elections and my campaign platform, I am happy to see many of those things that I ran on have been accomplished and I was able to list previously. However, much more needs to be done.

We still need to continue to focus on the diversification of our financial resources so we continue to provide education and health care without relying solely on our Gaming revenues. With that said, we have begun to develop, with your input, the Master Plan for the Tribe.

Once completed, the Master Plan will provide a framework for the Tribal Council as it considers various opportunities aimed at enhancing the quality of life for our Tribal members such as providing assisted living, and building a grocery store and Tribal school. It will allow the Council to explore various diverse economic opportunities. On a personal note, I will continue to search for the financing to build a nursing home facility for our Tribal elders in need of care. We have begun the process to determine the feasibility and sustainability of a Tribal School that will educate all our children without having to send them to area schools that are not focused on the well-being of our children.

With your support and continuous guidance, we, as a people, can continue to accomplish great things for our Tribe. I have always been told that every effective leader is ever-mindful of two important truths; you are chosen by the people and you must always strive to serve the best interest of those people. I pledge to continue to do both for you.

I ask respectfully that you entrust your vote to me, Robert "Robbie" McGhee, on June 5, 2010. Give me an opportunity to work with you and the Tribal Council to grow and protect the financial assets of the Tribe as your Tribal Treasurer.

Thank you so much for the trust you placed in me three years ago when tribal voters elected me to represent them and their families on the Tribal Council. Now I am asking for your vote and active support so that I may continue serving you as Secretary of the Poarch Band of Creek Indians. Having the opportunity to serve the members of our tribal family has truly been one of the highest honors of my life, a privilege that I have never taken for granted. There has never been a time in the history of our tribe where the future looks brighter, but we must always remember that our strength lies in our faith, our families and our traditions.

Improving and increasing services to our tribal members has been and will continue to be my focus for serving you. Consider the remarkable progress that has been accomplished:

- Health Insurance is now available for all uninsured tribal members ...no matter where they live.
- The Health Department will soon have an additional physician on staff providing more appointment opportunities.
- Tribal Health Reimbursement Cards are coming. Tribal Members not currently participating in the Tribal Health Insurance Plan will soon receive a Tribal Health Reimbursement Card that can be used to pay doctor visits, copays, pharmacy co-pays and qualified medical supplies. This is a \$50 per month benefit that will be accepted at locations across the U.S.
- The first Annual Tribal Report including the Tribal Financial Report was sent to you this year.
- Tribal debt is being paid down faster than expected due to strong revenues from PCI Gaming. Hopefully if the present success continues, we can eliminate the entire debt and once again be debt free.
- Birthday checks have grown and everyone also received a Christmas check.
- Housing opportunities are expanding with the purchase of land in Monroe County, Alabama and in Escambia County, Florida.
- Tribal Employment Rights Organization (TERO) is now available to protect Tribal Member employment and business contracting rights within the Tribe and its enterprises.
- Magnolia Branch Wildlife Reserve has been significantly

improved. There are many recreational opportunities now available while we protect our most basic natural resource.

- Direct election of tribal officers is now your privilege. Last year you elected the Vice-Chairman, this year you will elect the Secretary and Treasurer. Lord willing next year you will elect the Chairman. These are in addition to the at-large council seats.
- There will be a Constitutional Amendment on the ballot this year, that if Tribal Members vote to approve, will require Public notice and community meetings when the Tribal Council considers offering Constitutional Amendments. Knowledge is power and this is a step toward making Tribal Council actions more transparent.

With the amazing success we have enjoyed, it is more important now than ever for our Tribal Leaders to clearly define our future goals and actions that must be accomplished by our Tribal Leadership and our Tribal Members in order for those goals to be realized. Tribal Master planning will be completed soon. The results of your suggestions and input along with the work of our professional planners will create a new vision for a "place called Poarch". As we grow our community we will have a plan that will guide us in our efforts to be one of the best communities in our State.

I am asking for your Vote and your active Support so that I can continue to work for you with a focus on:

HEATHCARE:

- Conduct the feasibility study for a full-time nursing care center, an assisted living center, and provide Senior day care services.
- Home Health services for Seniors...no matter where they live
- Health Benefits for all Tribal Members no matter where they live.

ECONOMIC DEVELOPMENT:

When it comes to investing tribal moneys into economic development projects, I will continue to insist that any tribally funded developments either provide jobs for tribal members, or provide a needed service to tribal members or generate income that can be used to improve services for tribal members. We must continue to develop our gaming business but at the same time diversify our economic development to create more jobs and opportunity. Let us recruit the next car manufacturing plant and build it here on Tribal land. Let us return textile manufacturing that has been lost overseas and compete globally from Poarch, Alabama. Let the Poarch Creek Indians lead the way in generating clean power and create jobs and income.

GOVERNMENT TRANSPARENCY

Over the past three years, I have supported more openness or transparency in the actions of the Tribal Council. I will lead support for A Notice of Proposed Rule Making (NPRM) policy that would require community meetings are held and proposed ordinances published within a 60 day period prior to Tribal Council voting an Ordinance into law. This is especially important when proposals involve significant debt, whether by Resolution or Ordinance.

TRIBAL CONTRACTING

We must insure that contracting opportunities for tribal member businesses are fair and the Request For Qualifications (RFQ's), Request For Proposals (RFP's), Bidding, Awarding, and Performance process is open and transparent.

EDUCATION:





DOTTIE PADGETT LEAVES LEGACY OF CARING

You may not have known Dottie Padgett, but if you or any of your family members had surgery at the hospital in Atmore over the last five decades, chances are she was there. Dottie was an operating room nurse at Lisenby Hospital, and at Greenlawn Hospital which became Atmore Community Hospital. For 45 years, she worked full-time, the last eight years part-time when she was needed.

Dottie passed away Friday evening, May 28, following a brief illness. At her service Monday afternoon, former Atmore Community Hospital Administrator Bob Gowing said Dottie was proud of her profession, that she was truly an old-school nurse. "The Good Lord gifted her with a caring spirit and a servant's heart," he said.

In September 2001, Dottie was honored as a Baptist Health Care Legend of Atmore Community Hospital, an honor not lightly bestowed. This was said of Dottie: "... Dottie's love for her patients and co-workers is expressed through her selflessness and kindness. Patients are her first priority and 'do whatever it takes' is her motto. For example, many times patients have no way of getting to the hospital for surgery. Dottie either picks them up herself or sends someone to get them. Afterward, she sees to it that they get home. In the middle of the night, Dottie has waited at the bus station to pick up special equipment or supplies needed for the next day. When faced with challenging situations requiring a quick decision to save the patient, Dottie comes through while giving the credit to someone other than herself.

"Dottie is known for her unselfish nature, always putting the needs of others before her own. She consistently volunteers to take call or work when one of her staff members needs to be off. Her smile, compassion for others and attitude of 'nothing is impossible when we work together as a team" make her a joy to work with. She has devoted her life to serving others, giving of both herself and her time every day."

In 2003, the Atmore Area Chamber of Commerce presented Dottie with the Lifetime Achievement Award. In atmore magazine, then-Chamber Executive Director Emilie Mims wrote of Dottie, "I imagine Dr. J. Otis Lisenby must have recognized Dottie's potential when she began working at the old Greenlawn Hospital back in the 1950s. With this support and encouragement, Dottie completed

nursing school at Baptist Hospital
in New Orleans and returned
to Atmore where she began a
forty-five year career in nursing.
Introducing Dottie's award,
Bob Gowing, administrator of
Atmore Community Hospital,
spoke of her selfless commitment
to co-workers and patients "... Our
community and healthcare system are
so fortunate to have a true servant leader such as Dottie
Padgett among us."

Dottie is survived by her husband of almost 48 years, John, and two daughters, Kelly and Tracy.

Walking On: Aunt Eunice Dees Griffin (1920-2010) With deep sadness, I heard the news of Aunt Eunice walking on at age 89 this spring. Aunt Eunice, Poarch Creek (Muscogee), was born on October 8,

1920 in Jeddo/Uriah and died on May 15, 2010 in Newport News, Virginia. She is the sister of my father Otis Dees of Uriah who preceded her in death in 1984 and is buried with the Dees family at Poplar Springs. She is the youngest of the Dees children born to Pauline Bell Dees and Charlie Suwanee Dees of Uriah, so it is fitting that she is the last one of the siblings to pass on. Aunt Eunice spent her life in service to others as a healer who worked in the nursing profession. It is interesting to note that she was the salutatorian of the class of 1938 at J.U. Blacksher in Uriah, Alabama, an exhilarating fact that I did not learn about until I was probing for information about her after her death.

She was preceded in death by the lovely Dees sisters Willie Dees, Pearl Dees, Ruby Dees Sessions, and Birdie Dees Haynes/Jackson, respectively, and twins who died shortly after birth. They are survived by their daughter Florence, son Dan, grandchildren, and nieces and nephews. Seminole, Miccosukee Probes Underscore Federal Scrutiny

Two separate government investigations of the Seminole and Miccosukee tribes in South Florida reflect stepped-up scrutiny of excessive personal spending of gambling profits by tribe leaders....Miami Hearld

The Miccosukee Tribe, whose recently deposed chairman is under investigation by the IRS, has never submitted a federal plan required of Indian tribes that distribute gambling profits to members, regulators say.

Yet the West Miami-Dade tribe has handed out casino proceeds to its members -- including one who received \$168,000 in 2008, according to court records and people familiar with the Miccosukees.

In a separate matter last week, the National Indian Gaming Commission accused the Miccosukees' tribal neighbor to the north -- the Seminoles in Hollywood -- of breaking the law by spending hundreds of thousands of dollars on jewelry, vehicles and other personal expenses for a half-dozen members.

The Gaming Commission's crackdown on the Seminoles -coupled with the IRS investigation of former Miccosukee Chairman Billy Cypress for alleged misuse of his tribe-issued credit card -- reflects stepped-up federal scrutiny of excessive personal spending by tribe leaders. The two tribes' annual revenues total about \$2 billion.

Indian tribes are sovereign nations with the right to selfgovernment. But they are also subject to federal laws and regulations and must follow the Indian Gaming Regulatory Act when spending gambling profits. The 1988 act specifies that revenue must be spent on tribal or local government operations, economic development, charitable contributions and the general welfare of tribal members.

The law also allows tribes to distribute gambling profits to individual members under a federally approved "revenue allocation plan."

In the United States, 242 of 564 tribes have gaming operations. One-third of those -- the major Indian casino operators -- have a so-called "RAP" allowing them to distribute payments to members.

The Seminoles' plan, approved by the Bureau of Indian Affairs in 2005, pledges to hand out gambling proceeds in equal shares. The 3,500-member tribe operates the popular Las Vegas-style Hard Rock Hotel and Casino in Hollywood and Tampa.

In its enforcement action, the Gaming Commission accused the Seminoles of spending gambling profits on impermissible

and depriving the tribe of operating income. The agency can fine the Seminoles \$25,000 for each of six violations or even close its gambling operations. The tribe said it is "intent" on resolving the offenses.

The worst offender, according to the Gaming Commission: Seminole Tribal Council member Max B. Osceola Jr., who stands accused of charging more than \$85,000 for jewelry, a Harley Davidson motorcycle, stereo equipment and more on his tribe-issued American Express in 2006.

UNCOMMON ACTION

Only one other tribe in the United States has been slapped with a similar violation, records show: Last year, the Yakama Indians in Washington state were fined \$5,000 for giving more than \$20 million in gambling profits to 10,000 members without federal approval. Tribal leaders had characterized the payments -- distributed around Christmas 2008 -- as stimulus money to help members in tough times.

But the Gaming Commission said the tribe's one-time payment violated the law because it was made before the Yakamas' revenue allocation plan was approved.

The IRS civil probe of the Miccosukee Tribe's longtime former chairman, Cypress, also is uncommon: the Justice Department has rarely brought civil or criminal actions against individual tribe members for failing to report or pay taxes on income received from Indian gambling profits, government and legal authorities say.

In April, the IRS issued a civil summons to Morgan Stanley Smith Barney, the tribe's Miami bank, seeking Cypress' credit card statements and other records from 2003 to 2005. The IRS summons also demand the tribe's credit card records and the names of members authorized to use the Morgan Stanley account for the same three-year period.

According to sources, Cypress regularly used his tribe-issued American Express credit card for trips to casino resorts in Las Vegas, Atlantic City, Biloxi, Miss., and Foxwoods, Conn. Public records also show he owns as many as 10 residential properties in Miami-Dade, each valued between \$236,000 and \$435,000.

The Miccosukee Tribe is seeking to quash the summons in Miami federal court, saying that as a sovereign nation it doesn't have to turn over records. The tribe's lawyers did not return calls for comment.

Unlike the Seminoles, the Miccosukees have never submitted a "revenue allocation plan" to outline their distribution of gambling proceeds to tribe members, according to the U.S. Bureau of Indian Affairs. The 650-member Miccosukee personal expenses for certain members, exceeding their shares Tribe has bingo-style slot machines and poker at their casino

off Tamiami Trail. According to court records and people familiar with the Miccosukees, the tribe has handed out cash to members for years.

PROBLEMATIC SYSTEM

Shawn Pensoneau, a spokesman for the National Indian Gaming Commission, declined to comment about the Miccosukee Tribe or the IRS case targeting its former chairman. But Pensoneau said "giving cash gifts to tribe members from net gaming revenues without a federally approved plan is problematic."

In several divorce cases reviewed by The Miami Herald, the issue of Miccosukee Tribe cash payments has been at the center of disputes about alimony and child support. In mixed marriages between tribe and non-tribe spouses, the Indian spouse asserted in court that such payments were "gifts" -- not income -- and need not be divided with the ex-spouse.

That was the argument in a 2008 Miami-Dade divorce case, when non-Miccosukee spouse Fancy Smith-Cypress claimed that her husband, Miccosukee Tracey Cypress, earned about \$168,000 a year in "tax-free income" from the tribe in addition to his annual maintenance worker salary of \$30,000. The case was settled.

Attorney Mary Streitz, a legal specialist in Indian tax issues, said that tribal gifts such as blankets or holiday baskets are not considered income, but gambling profits distributed to all tribe members are taxable income.

"I would probably not advise a tribe that its \$168,000 distribution of cash to a tribal member is a 'gift' for federal income tax purposes," said Streitz, a partner with the Minneapolis-based law firm, Dorsey & Whitney.

"If a tribe made a substantial distribution of cash to every tribal member, the federal government would have a good argument that it's a taxable per-capita payment," she said. "Indians are generally subject to federal income taxes unless there's an exception that applies."

In a similar 2005 divorce case between a Miccosukee woman, Jolene Marie Story, and her non-Indian husband, Michael Van Slogan Story, the wife won the argument over "gifts" when a judge found that the cash distributions ``shall not be considered income for purposes of an award of alimony." But an attorney for the husband, who had worked as a chef at the tribe's casino, asserts that characterizing Miccosukee cash payments to members as "gifts" is just an attempt to circumvent the laws governing Indian gambling profits and tax obligations.

"I think they take care of their own people, and they do it by breaking the law," Miami attorney Kurt R. Klaus said. "They're not hiding the money. They're just not declaring it."

LEGAL SERVICES PROGRAM

The Tribal Council is currently considering a new tribal member benefit—the establishment of a Legal Services Program that would provide certain types of legal services to individual tribal members regardless of his or her location or income. For example, the Legal Services Program could assist you with wills, power of attorney forms, deeds, divorce proceedings, child custody disputes, criminal defense, or other legal matters. *We need your help* in determining what types of legal services are most needed by tribal members. SIGNIFICANT COURT CASES

T.J. Johnson Holdings, Inc. v. Poarch Band of Creek Indians, PCI Gaming, and CIE

On October 22, 2009, T.J. Johnson Holdings, Inc. ("Johnson") sued the Tribe, PCI Gaming and CIE in state court, claiming that the parking deck in Wetumpka that serves Riverside Entertainment Center encroaches onto Johnson's portion of River Oaks Drive, which runs in front of the parking garage. On January 5, 2010, the state court granted the Tribe's motion to dismiss one of the three claims. The parties engaged in mediation on May 5, 2010, but the mediation was unsuccessful. Since that time, the parties have settled the case.

Alabama Department of Transportation v. Poarch Band of Creek Indians d/b/a Wind Creek Casino & Hotel, PCI Gaming, CIE et al.

On April 15, 2010, the Alabama Department of Transportation ("ALDOT") sued the Tribe, PCI Gaming, CIE, and each entity's Chairman in Escambia County for alleged illegal advertising on the Tribe's water tower located next to Interstate 65. ALDOT wants the Tribe to remove "Wind Creek Casino and Hotel" from the signage on the water tower. The Tribe filed a motion to dismiss based on sovereign immunity. The hearing on the motion to dismiss has been set for July 6, 2010.

ACE Warning against Online GED® Testing

The GED Testing Service® (GEDTS), a program of the American Council on Education® (ACE) and architect of the Tests of General Educational Development (GED Tests), is aware of various entities claiming to offer GED exams online

Please be advised that the GED credential cannot be earned via the Internet nor through correspondence programs. The GED Tests, developed by GEDTS, require extensive preparation and the demonstration of a high level of high school knowledge and academic skills

Any services that purport to offer a GED credential through any other means are NOT affiliated with GEDTS or ACE, may be of dubious value, and may deliver a product that is not accepted by employers, colleges and universities, or the military.

Hiring personnel, college admissions officers, and military enlistment personnel: To verify the authenticity of an individual's GED credential, please contact the appropriate jurisdictional agency that administered the GED Tests. **The Education Department has received several calls telling them that people are paying for the online GED certificates thinking they will be accepted at local colleges. They have heard from Tribal Members and Tribal descendants that who have paid from \$200, \$400 to \$600 for the fake certificates, and then learn that the certificates are not accepted by employers or colleges. The last one said, "It's accredited." The company selling the certificate says it is accredited; but it is worthless. **

The Hard Road To Federal Recognition

Over the past few years we have had inquires from Tribal Members wanting to learn more about the Tribe's Federal Recognition process and the historical information that was provided to the Federal Government for Federal Recognition. The Tribal Council would like to share this information with you. It will outline the struggles and hardships that as a community we have experienced. However, as you will see in future articles, it was these struggles and hardships that kept our community together which was essential in our Federal Recognition.

In the early 1980's the Poarch community and its leadership came together to work closely with attorneys Barry Margolin and Tom Tureen, anthropologist Tony Parades, and many others to prepare the Petition for Federal Recognition. Many sacrifices were made and many hours were put into preparing the document. On December 29, 1983 John W. Fritz, Deputy Assistant of Indian Affairs forwarded the Petition to Kenneth L. Smith, Assistant Secretary of Indian Affairs and recommended that the Poarch Band of Creeks be acknowledged as an Indian tribe with a government-to-government relationship with the United States and be entitled to the same privileges and immunities available to other federally recognized tribes by virtue of their status as Indian tribes. In the Petition it stated that the contemporary Poarch Band of Creeks were a successor of the Creek Nation of Alabama prior to its removal to Indian Territory and that the Creek Nation had a documented history back to 1540.

The Poarch Band of Creeks began as an autonomous town in the late 1700's with a continuing political connection to the Creek Nation. The Poarch Band remained in Alabama after the Creek Removal of the 1830's, and shifted within a small geographic area until it settled permanently near present-day Atmore, Alabama. The Band has existed as a distinct political unit under the jurisdiction of the Federal Government since before the Creek War of 1813-14. It was governed by a succession of military leaders and prominent men in the 19th century. From the late 1800's through 1950, leadership was clear but informal. A formal leader, Calvin McGhee, was elected in 1950. The group's by-laws describe how membership is determined and how the group governs its affairs and its members. Virtually all of the Band's 1,470 members can document descendancy from the historic Creek Nation and appear to meet the group's membership requirements. No evidence was found that the members of the Poarch Band of Creeks are members of any other Indian tribes or that the tribe or its members have been terminated or forbidden the Federal relationship by an Act of Congress.




