

No phone or oral submissions will be accepted.

Birthday/Anniversary Wishes are limited to Tribal Members, spouses, first generation descent, and those living in the Tribal Member's immediate household. These requirements apply to Birth and Wedding announcements as well. Birthday/Anniversary Wishes can be published the month before, the month of, or the month after the birthday/anniversary as long as established deadlines have been met. This may mean you will have to publish a birthday/anniversary wish prior to any party planned for the event. Birthday wishes are limited to no more than four (4) sentences. Birth/Wedding Announcements will be published as long as the birth/wedding announcement is received by the last working day of the month immediately following the birth/wedding. Obituaries/Family Thanks will be published as long as the information is received by the last working day of the month immediately following the death. Photos, due to space limitations, photos may be limited to one photo per article.

## Resignation Of Tribal Council Member Berry L. Ross

The Poarch Band of Creek Indians (PBCI) Tribal Council held a special called meeting on April 13, 2011

to address impeachment of Tribal Council Member Berry L. Ross.

Mr. Ross had previously been censured for a violation of the Tribe's Personnel Policies and Procedures.


The Tribal Council became aware of further actions by Mr.

Ross which the Tribal Council believed to be conduct unbecoming a Tribal Official and worthy of impeachment. The Tribal Council, including Mr. Ross, believed it was in the best interest of the Tribe to avoid the impeachment process. Therefore, Mr. Ross tendered his resignation effective immediately; his resignation was accepted by unanimous vote of the Tribal Council.

Mr. Ross was serving a three year term that began when he was elected to office on June 6, 2009. The next step for the PBCI Tribal Council is to fill the position that has been left vacant by Tribal Council Member Ross. According to the PBCI Tribal Constitution, Mr. Ross' position will be filled by the candidate who received the next highest amount of votes in the last Tribal Council election. Helen Hallman is the candidate who meets the criteria and will be sworn into office at the next Tribal Council meeting, April 21, 2011. Ms. Hallman will serve in this position until the June 2011 election, at which time the members of the General Council will elect a candidate to serve the remainder of Mr. Ross' term.

### Submission Criteria Established

Due to the ever increasing number of birthday wishes submitted, effective March 2011 birthday wishes will be limited to Tribal Members, spouses, first generation descendent, and those living in the Tribal Member's immediate household. This criteria applies to anniversary wishes as well as birth and wedding announcements. *All submissions must be submitted in writing. Birthday wishes should be limited to no more than four (4) sentences.* For verification purposes, the submission must include contact information, the Tribal Member's roll number or Tribal affiliation in the case of Tribal Member spouse, first generation descent, or those living in the Tribal Member's immediate household.



### Tribal Member Family Pass Available for Magnolia Branch


Tribal Members are admitted free to Magnolia Branch Wildlife Reserve with proper identification, i.e. Tribal Member ID Card, Tribal Member Youth ID Card, or Tribal Member Family Pass. A Family Pass allows a Tribal Member, a Tribal Member's spouse, and all children under the age of 18 who are living in the household, to enter the park free of charge when presented at the front gate entrance; *if you do not have proper identification or a Family Pass, you will be expected to pay regular admission charges.* All applicable fees apply for all additional park amenities.

Tribal Member families that had a Family Pass made last year will not be required to get a new pass this year unless there has been a change to the family makeup, i.e. divorce, marriage, birth of child, child reaching age 18, etc. or if they have lost their Pass. A maximum of two (2) Family Member passes will be issued per household per year.

Effective March 1, 2011, the Tribal Member Benefits Office will issue Family Passes on Friday's between the hours of 10:00 a.m. and 4:00 p.m. Be sure to bring all required documentation to your appointment; Passes will not be issued without proper documentation. Documentation required includes Tribal ID, birth certificates for all children under the age of 18 living in the household, and marriage certificate, if applicable. # Education, News & Updates

### Honor Students from Lower Income Families Can Afford to Attend Harvard University



Harvard does not require a family contribution for families with incomes of \$60,000 or less and they have reduced the family contribution for families with incomes of up to \$80,000. Harvard's definition of income includes all sources of support available to a family, both taxed and untaxed income. Retirement accounts or home equity is not considered as income when deciding the amount the family

would be required to contribute.

Families that have incomes between \$60,000 and \$80,000 are expected to contribute 10% of their income to the student's costs at Harvard. The Tribal Tuition Payment funding could help with this cost. Harvard is replacing loans with need-based scholarships. A student can arrange to work on campus to cover the cost of their expected contribution. Harvard will then meet the rest of the student's financial aid needs through their institutional scholarships, federal grants, and state grants.

# Legal Update

### SIGNIFICANT TRIBAL LEGISLATION

#### Election Code

On April 1, 2011, the Tribal Council approved revisions to the Tribe's Election Code. After last year's Constitutional amendment enlarging the size of the Election Board to five members, the Election Code was revised to be consistent with the Constitution. Other revisions to the Election Code included clarifying that an individual is a candidate for office once the qualification fee is paid, requiring the Election Board to hold a meet-and-greet on the second Saturday in May and a debate for any run-off election, clarifying that the Election Board had the duty to investigate campaign violations, establishing procedures for hearings and issuance of sanctions and penalties relative to campaign violations, adding additional reasons for requesting an absentee ballot, and shortening the walk-in voting period to ten days and one Saturday.

### Tribal Council Bylaws and Committee Rules

On April 7, 2011, the Tribal Council approved revisions to the Tribal Council Bylaws and Committee Rules. The revisions included adding a code of conduct for Tribal Council Members and specifying what actions constitute a breach of fiduciary duty, conduct unbecoming a Tribal Council Member, and high crimes and misdemeanors committed by Tribal Council Members.

### Ethics Code

On April 7, 2011, the Tribal Council approved revisions to the Tribe's Ethics Code. The Ethics Code now requires that applicants for boards or committees disclose to the Tribal Council any contractual and business relationships with tribal entities when applying to serve on the tribal entity's board or committee and prior to participating in a solicitation with the entity if the individual is already a board or committee member. The Code also directs that similar business disclosure provisions for Key Employees be added to the respective personnel policies and procedures.

Sex Offender Registration Code

On April 7, 2011, the Tribal Council approved the Tribal Sex Offender Registration Code. The Tribe previously elected to become a registration jurisdiction pursuant to the Sex Offender Registration and Notification Act (Title I of the Adam Walsh Child Protection and Safety Act of 2006 P.L. 109-248), 42 U.S.C. §16911 et. seq., as amended. This Code requires sex offenders register with the Public Safety Department if they are convicted of a sexually-based offense under Tribal law, reside on the Reservation, work on the Reservation, or attend school on the Reservation. This Code also creates a Tribal Sex Offender Registry and website. The website will have a function that enables the general public to request e-mail notification when a sex offender commences residence, employment, or school attendance with the Tribe, within a specified zip code, or within a certain geographic radius. Written notification of the sex offender's registration or update of information with the Tribe will be provided to all schools located on the Reservation and Tribal agencies that have regular contact with children.

### Criminal Code


On April 7, 2011, the Tribal Council approved revisions to Tribe's Criminal Code. As part of the Tribe's commitment to establishing a tribal sex offender notification law, the Code was substantially revised in order to update the sexually-based offenses and to establish laws against child pornography. Also, the drug offenses in the Criminal Code had not been updated since 1999; therefore, these offenses were substantially revised in order to address new substances and charges.

# Social Security Reps visit Poarch

Health Administration recently assumed the duties and responsibilities of assisting Tribal Members with Social Security Benefits. To help Tribal Members better understand the Social Security process, Health Administration arranged an open meeting with Tribal Members and Social Security representatives to explain the Social Security process and to answer any questions Tribal Members may have. Kylle' McKinney of the Montgomery office and Randy Wahl from the Andalusia office conducted the meeting. Mr. McKinney presented a slide show that explained the Social Security process which included Social Security history and solvency, full retirement age, how benefits are figured, Medicare and the taxation of benefits.



Although the full retirement age is rising, you should still apply for Medicare benefits three months before your 65th birthday if you do not have health insurance benefits through your employer or other source. Be aware that if you wait longer, your Medicare medical insurance and prescription coverage may cost you more money. If you lose your health insurance after age 65, you have 8 months in which to apply for Medicare without receiving a penalty; after the 8 month period, you may still apply but there will be an increase in cost.

Some Social Security benefits are taxable. You will have to pay taxes on your benefits if you file a federal tax return as an "individual" and your total income is more than \$25,000. If you file a joint return you will have to pay taxes if you and your spouse have a total income that is more than \$32,000.

After the presentation, the floor was opened for questions and answers. Several different questions were asked, but the most prevalent was the question of how Tribal Member per capita (birthday checks) payments would affect SSI recipients. Supplemental Security Income (SSI) is a Federal income supplement program funded by general tax revenues

(not Social Security taxes) designed to help aged, blind, and disabled people ages 18-64 who have little or no income. If you receive SSI benefits, you must report any earning from work or any other money or help that you, your spouse, or children living in your household receive; this includes any type of per capita payment. You must report this income within 10 days of receipt of payment. If this puts your income over \$647, you will be ineligible for SSI for that month; you lose your Medicaid benefits as well for that same month. Can you bank any of the income for future use? If you deposit your per capita payment into the

bank and it brings your balance above \$2,000, you will be ineligible for SSI and Medicaid until your balance is below \$2,000.

### Historical Tribal Election Scheduled for June 4, 2011

This year's Tribal Elections will be another historical election year. In 2009 the General Council directly elected the candidate for the position of Tribal Council Vice Chair. In 2010 the General Council voted to directly elect the candidates for the positions of Tribal Council Secretary and Treasurer; this election also necessitated the first runoff election in the Tribe's history. This year the General Council will directly elect the candidate for the position of Tribal Chairman.

The two men with the most experience and deepest roots in Tribal Council history are vying for the position of Tribal Chairman, current Tribal Chairman Buford L. Rolin and former Tribal Chairman Eddie L. Tullis, who currently holds an at-large position on the Tribal Council. If no additional candidate steps forward, the top vote getter is determined to be the winner. If another candidate steps forward, the winning candidate must receive 51% of the vote. If there are three or more candidates and no candidate receives 51% of the vote, there will be a run-off election between the two candidates receiving the most votes. Anyone interested in running for the position of Tribal Chairman may still submit their Letter of Candidacy by 5:00 p.m. (CST) Thursday, May 5, 2011; however, they will be considered a write-in candidate and their name(s) will not appear on the official ballot.

The General Council will also be voting to fill three \* at-large seats on the Tribal Council. Incumbents Arthur Mothershed and Garvis Sells have announced their candidacy along with Clayton Coon, Helen Hallman, Sandy Fretwell Hollinger, Edie Jackson, Daniel Winston Lambert, Paul Lundy, Eialeash (Leasha) E. Martin, David Morris, Arthur Ray Patrick Jr., Debra Rolin Strickland, William L. Vickery, and Carolyn McGhee White. Anyone interested in running for one of the at-large positions on the Tribal Council may submit their Letter of Candidacy by 5:00 p.m. (CST) Thursday, May 5, 2011; however, they will be considered a write-in candidate and their name(s) will not appear on the official ballot.

There will also be a proposed Constitutional Amendment addressing an Oath of Office for Tribal Council Members. Thirty percent of the eligible voters are required to vote for the successful/unsuccessful passage of the proposed amendment. You may view this proposed Constitution Amendment on page four (4) of this Election Insert. For your convenience, the Election Notice has also been included on page one (1)

of this Election Insert as well as a Request for Absentee Ballot on page two (2).

The Election Board has scheduled a Meet & Greet with the candidates immediately following the State of the Tribe on Saturday, May 14th in the Family Services Auditorium. The State of the Tribe meeting is scheduled for 10:00 a.m.

# Proposed Constitutional Amendment

### RESOLUTION FOR A CONSTITUTIONAL AMENDMENT TO INCLUDE OATH OF OFFICE

**WHEREAS**, the Poarch Band of Creek Indians is a federally recognized Tribe organized pursuant to 25 CFR Part 83;

**WHEREAS**, the Poarch Band of Creek Indians Constitution does not have an oath of office for Tribal Council members; and

WHEREAS, the Tribal Council desires to include an oath of office that reflects the values and mission of the Tribal Council

NOW THEREFORE BE IT RESOLVED that the Tribal Council authorizes the following proposed amendment to Article VII of the Poarch Band of Creek Indians Constitution, which shall become effective when approved by a majority of the qualified voters voting in the 2011 annual election, provided that at least thirty percent (30%) of those qualified to vote cast their ballots:

### Section 5. Oath of Office

Prior to assuming the elected office, the individual elected shall take the following oath of office:

I, \_\_\_\_\_\_\_, do solemnly swear or affirm that I will support and defend the Constitution of the United States and the Constitution of the Poarch Band of Creek Indians; and that I will faithfully, honestly and impartially discharge the duties of the office of the Chairman/Vice-Chairman/Secretary/Treasurer/Tribal Council to the best of my ability, so help me God.

As proud leader of our Tribe, my integrity demands that I be true to who I am. My integrity is the foundation of my love for my family and our community, which strengthens my faith and commitment to do what is right for the Tribe. I will further the legacy of self-determination and self-reliance inherited from our elders by investing in the progress and driving a vision for the future that leads to our prosperity. I understand that I am beholden to the electorate and to the other Tribal Council members. To that end, I shall conduct myself in a manner which will foster respect and dignity.

**BE IT FURTHER RESOLVED** that the Tribal Council directs the Election Board Chair to assign a ballot number for the proposed constitutional amendment on the election ballot for 2011 annual election and set forth on the ballot the following:

Proposing an amendment to Article VII of the Poarch Band of Creek Indians Constitution, to require an oath of office for Tribal Council members that reflects the values and mission of the Tribal Council.

If approved, the following section would be included as part of Article VII:

### Section 5. Oath of Office

Prior to assuming the elected office, the individual elected shall take the following oath of office:

I, \_\_\_\_\_\_\_\_, do solemnly swear or affirm that I will support and defend the Constitution of the United States and the Constitution of the Poarch Band of Creek Indians; and that I will faithfully, honestly and impartially discharge the duties of the office of the Chairman/Vice-Chairman/Secretary/Treasurer/Tribal Council to the best of my ability, so help me God.

As proud leader of our Tribe, my integrity demands that I be true to who I am. My integrity is the foundation of my love for my family and our community, which strengthens my faith and commitment to do what is right for the Tribe. I will further the legacy of self-determination and self-reliance inherited from our elders by investing in the progress and driving a vision for the future that leads to our prosperity. ### **CLAYTON COON**

I, Clayton Coon, do here by submit my candidacy for a seat on the Tribal Council. I have been happily married for 21 years to Debra Rolin Coon (daughter of Clarence and Dianne Rolin of Atmore, Al). I am the father of four children; Kaweta Jack Coon (20), Cedo Calvin Coon (19),



Noah John Coon (15) and Emerie Grace Coon (11). I am the son of Rickie and Rose McGhee Coon of Atmore, Alabama and the grandson of the late Curtis McGhee, Pearline Daughtry McGhee, Buford Coon and the late Olean Driskell Coon. I am also the great grandson of the late Chief Calvin and Joyce McGhee and the late Jack and Nora Daughtry.

First, I would like to tell you a little about my present and past work experience. I am currently the Planning and Events Coordinator for the Calvin McGhee Cultural Management Authority (CMCMA); my job is primarily based around our Annual Thanksgiving Powwow and Calvin McGhee Memorial. In my first year managing our powwow I wrote a proposal to the Tribal Council to allow me to create a Powwow Support Staff and pay them a stipend (like a board or committee) for daily services. Prior to 2009 if you worked for the Poach Creek Indians' Administration or Tribal Government, it was mandatory that you worked the Annual Powwow. By the council approving this proposal all tribal employees were able to receive their Thanksgiving Holiday and the powwow staff was reduced from 200 plus to fewer than 60 people. This proposal also provided an opportunity for a tribal business to employ approximately 20 people, mainly tribal youth, to manage the cleanup and beautification as well as provide parking assistance for the two day event. This was a small but effective way to help people that wanted to earn extra revenue for Christmas and to give tribal employees the opportunity to enjoy their Thanksgiving with their families. I am also the graphic designer for the brochures, booklets, posters, Powwow tee-shirts '05,'06, '07, '09,' 10, Calvin

McGhee Memorial shirts, and 2011 Powwow website; per the approval of the CMCMA. Prior to employment with the authority, I was the chairman of the CMCMA, and designed and oversaw the restoration of what is today the Pickrell House located on the powwow grounds. I also served on the Powwow Committee where I designed and oversaw the construction of our new powwow arena. Prior to working for our tribe I mainly worked construction; carpentry, oilfield and gas line welding and fabrication. I believe that I have worked with some of the most talented and well-rounded people in this country and the majority of them are members or descendants of the Poarch Band of Creek Indians. Those were some of the things that I have been able to accomplish based on preparation and presentation of ideas and designs which were passed by governing bodies.

While these are all things that the Tribe as a whole has benefited from, there is so much more that I would like to see happen. What I am proposing to you the General Council is not a per capita payment and will not take the place of our birthday checks or any future per capita payment; the sole purpose of this idea and program is to give each individual the incentive and motivation to apply themselves, and to continue contributing to our community and the communities that we live in. This is what I'm planning to present to you the tribal members and to the Tribal Council if elected. Prosperity and Self **Determination Incentive Program** or (PSDI Program). This program will be a new program (much like the Education Programs or Family Service Programs) and will give each individual an opportunity to better themselves at any level of education or financial status: the program will provide any and all tribal members of the Poarch Band of Creek Indians that can obtain a work permit or that can show taxable income, an additional wage of \$6.25 and hour for every hour worked, up to 160 hrs per month. (\$1000 per month max). College Students / GED participants 18 or older will also receive \$6.25 per hour he/she attends class. This is the basic concept of the program, there will be many provisions made in the policies and procedures for certain circumstances such as online registration and updating for members that live outside the Poarch area, business owners, ministers, salaried employees, truck drivers, active military personnel and the occasional unemployment situations. I will mail out more information before election about my goals and objectives as your Tribal Council Member and to give everyone interested a better understanding of this program and how we can use a portion of tribal revenue to provide individuals the ability to assist themselves and their families. I believe with the additional income tribal members can afford to spend money( a stimulus so to speak)

therefore creating jobs for contractors and revenue for businesses thus boosting the economy, also tribal members with first generation children can use the extra revenue toward their children's education. This is a program that will help each tribal member help themselves in Seeking Prosperity and Self Determination as an individual. I also would like to increase the Elderly Benefits Program payment to \$1500 per month and add the legally disabled tribal members to the Elderly Benefits Program as soon as possible. This will ensure that our senior citizens have some type of retirement and our legally disabled will have better financial independence. There are a total of 2771 eligible voters making the maximum estimated cost of both programs \$3,000,000 per month, \$36,000,000 per year. If we have to, we can earmark \$18,000,000 or more in the year 2012 and \$20,000,000 or more in 2013. This will allow us to fully fund both programs in the year 2013, the future of the programs will hinge on the success of our enterprises and gaming industry and the management and spending of tribal revenue. I believe that there are Tribal Council Members that truly have you, the General Council Member as their main concern and I believe that your council member will support the PSDI program and the Elderly Benefits Program changes, if someone will set down and write out a proposal, have all legal issues resolved and present it to the table ready for approval. Talk to your Council Representative or to the candidate that you are supporting and let them know how you feel. I believe that he/she would proudly speak for you.

Currently, I am employed as the Family Services Specialist within the Family Services Department at the Tribe. In this position, I have been committed to assisting in meeting the varied needs of tribal members to the best of my ability. Unfortunately, I see tribal members EVERY day that are struggling in this hard economic time. It's so hard to listen to their stories knowing that I won't be able to help much. In fact, knowing the kind of crisis situations our tribal members are experiencing and not being able to do anything about it is one of the reasons I decided to run for tribal council. I KNOW where my fellow tribal members are coming from.

It is a blessing that Wind Creek Hotel and Casino has been paid off so soon. I realize the tribe needs to invest some of the profit to be profitable; however, it is now time to share the wealth with our tribal members. With the rising cost of gas, groceries, utilities and other household expenses, I would love for every tribal member to receive a monthly per capita check. Knowing that so many of our tribal members are in need, it would be wonderful to be able to help them with some extra assistance. If I am elected I will work to raise the Revenue Allocation Plan to get us more than 20% of the profit. This has to be passed by the Council and then presented to BIA for approval.

Education benefits for our Indian children will always have my support. I am ready to see a tribal school for our children so they can learn more about our culture and our heritage while receiving a quality education not to mention extra fun activities for them. As a mother of three, it is my prayer to keep them focused on education, sports and church activities. In this day and hour there is so much for them to get into. Our children are our future and we need to ensure they succeed. We need to keep them involved with social activities and as a tribal council member I will work towards creating more safe social activities for our youth.

With two of my three children attending public schools, I am thankful that we have been able to support our local schools through generous donations. It is great that we can better the education needs for our Indian children enrolled in the public school system. I have no problem with that

until we have a tribal school in place. What I do have a concern about is all of the other tribal donations being made. There are donations made that are not helping our tribal members at all (or providing any services to any tribal members). Donations are being made to local governments who are not willing to recognize how much the tribe has done for the local community and to that I say if they are not willing to help the Tribe then cut off all donations to them. The television ad states that we are neighbors, but it seems the City of Atmore is totally against us. Why do we keep lending out helping hands to them? The City and the local area would struggle financially without tribal jobs, revenue and donations. If elected, I will carefully consider limits on outside donations.

And let me not forget about our seniors. They are truly my heart. Our seniors have paved the way for us and we should take care of them as much as we possibly can. I want to actively pursue establishing an extended living facility/nursing home for our senior tribal members who are unable to live independently. It breaks my heart to see the seniors that are capable of living on their own barely surviving on low fixed incomes; never having any extra at month's end. I hope to be serving on the council that can see this happen for our seniors.

We must ensure that contracting for tribal member businesses are done fair and honest. I want to make certain that all tribal member owned businesses get their just reward not pushed aside. Indian preference in hiring should also be extended by contractors when they are hiring for each and every employment position that is available in the fulfillment of any contract with or services being provided to the Tribe.

I have a loving heart and want to see us all blessed and prosper. God has brought this tribe a long way. Our forefathers would rejoice to see what we've accomplished and where we are today. Again, it is my desire to help my people achieve their highest potential; promote our cultural and religious beliefs and to pass them to our children and future generations; and to protect the Poarch Band of Creek Indians from forces that threaten to diminish it.

I want to be a leader for you! I would greatly appreciate your vote, prayers and support for Tribal Council.

Greetings fellow Tribal Members:

Allow me to introduce myself. I am Ela Leasha Elizabeth Martin; most of you know me as "Leasha", your Library Clerk, friend or relative. After long consideration and deep thought I would consider it an honor if you would allow me to serve as your Tribal council Representative.

For those of you who may not know me, I am the greatgranddaughter of Alice Rolin-Martin-McGhee and R.O. Martin, the granddaughter of Elsie Martin-Holland and Wills McKinley McGhee, Sr. My parents are Douglas Martin and Dorothy Nelson-Martin. In 2009 a Tribal family entrusted me and blessed me with my son, Walker Martin. I have been truly blessed since my return home in 2005. I am employed with the Poarch Band of Creek Indians Education Department. I have a large family which I am able to visit often, but I am also part of something much bigger. I am a member of the Poarch Band of Creek Indians, how great is that? To know your history and family lineage is a great feeling. In doing my job, I am able to interact with Tribal members daily. You may think over the past several years, I didn't Listen; but I did! You were heard. So for you that know me, you know I'm not "quiet"! I have opinions, just like you. And I feel our opinions and ideas need to be heard. So if you'll allow me to serve as your voice on the Tribal council, we will be heard.

I would really appreciate your vote, but I'm not going to promise you \$17,000.00 or am I going to promise you per capita and I'm surely not going to tell you, you can give you tuition assistance benefits to your child. When, all governing boards and Tribal Council hasn't approved such issues. It takes a majority of the Tribal Council Members to approve any project, idea or bring a law into effect. - 1. Tribal Retirement-We are a government. Our people should have a retirement plan, not a fluctuating 401 K. With today's market our Tribal employees are losing money yearly. Give your people something to look forward to. You people have served you well show them you appreciate it.
- 2. Tribal Employee Daycare-Our tribe has several businesses, why not a daycare? This would not only be a lucrative business, but you would also raise employment

in our area and put your workers at ease. A daycare which provides 24 hour service would accommodate all Tribal Entities.

- 3. Senior retirement and assisted living facility-We've heard, we've heard, now let's do it! Our seniors have been hearing this for years. A senior care home is not only a sound investment, but it's a great source of added employment to our community. But most of all, it will be a relief to our seniors to know there is an alternative and answer to their care issues.
- 4. Tribal Council Salaries-While I do believe the Chairman and the Co-Chair deserve their pay, I don't believe General Council should be paid such astronomical salaries!! Come on you live in Atmore, Alabama. The cost of living is not that high. Your salaries should be based on the job and only receive a yearly cost of living increase of no more than 4% like your fellow Tribal Employees. What's fair for one is fair for all. If elected I will remain at my job and keep my normal salary in the Education Department.

Church. I am the son of Hattie Lou Morris and the late M.C. Morris. I am the youngest of 8 children. I have 2 brothers, Mack Morris, and Mack Jr. Morris and 5 sisters, Mary Belle McGhee, Marilyn ross, Annette Nall, Lanette Turberville, and Gailette Moore.

Although I do not have much education, I do have good common sense. I am self-employed and have owned my own business for the past 6 years. My construction company is called David Morris Construction. Even through the recession, my company has remained afloat, but not without the help of an awesome God. Throughout this entire time, I have only had 2 constructions jobs contracted through the tribe and they were by homeowners request. The other remodeling job I did about 3 years, the homeowner did not have to pay any money back to the tribe. I think each tribal member should be treated equally. Another reason I wanted to run is I believe that the general council should be able to vote on certain decisions dealing with our tribal people. For example, a tribal member with a felony that is over 19 years old should be allowed to run for office or be placed on a board. I also believe that the people should have the right to vote on whether or not the council should have limited terms. My personal opinion is that a council member should be allowed to serve 2 consecutive terms then have to wait for 5 years before being able to run again. This rotation of new members would allow new ideas to be brought to the table and would hold the tribal council more accountable. The people should also be allowed to vote on projects that are going to cost over \$1 million.

I think there should also be more help for our youth of the tribe. If a child is representing our tribe, they should not be expected to pay their own way or have to fundraise. The tribe should provide funding for these trips. I realize there are funds for our children to go to school, but what about the extra-curricular activities? Our youth are the future generation of our tribe and should have the chance to take part in every opportunity given to them.

Senior citizens, you have seen this tribe through the good times and the bad. I want to help you in any way I possibly can. All you have to do is let me know your concerns.

Since we just held a big celebration for the Wind Creek Casino and Hotel being paid off there is no reason our people should not be able to receive a monthly check. I will remind our council everyday that our people deserve to benefit from this accomplishment.

Do you ever want to speak you mind, but are afraid to approach the Tribal Council? I will rent a building to hold monthly community meetings off the reservation to be able to listen to what you have to say. I want our people to be able to talk with me without worrying. I will take your concerns to the council and fight for you.

Just remember I am only one person and it does take a majority. I cannot promise you everything will go our way, but I can promise you I will FIGHT FOR YOU every day.

### VOTE ARTHUR MOTHERSHED June 4th, 2011

My name is Arthur Mothershed and it has been a privilege to serve you these last six years. I am the son of Deloris McGhee Kelley and the late Carl Mothershed. I am the grandson of the late Levi



and Treacy McGhee. I am married to Samantha Canova Mothershed and we have three beautiful daughters; Katie age 19, Shelley age 15, and Kamryn age 11. I have a Bachelor's in Business Administration from Faulkner University and a Master's in Business Administration from the University of Alabama. More importantly to me, I have over eighteen years in management experience which has afforded me an education that could not be obtained in a classroom.

There are times in one's life when everything seems clear. Today my life as a Tribal Council Member has never been clearer. Politics has always baffled me. Promises are made to get elected but are rarely kept. Everyone talks about respecting our past and preserving our future but for most self preservation, not self determination wins out and our past and future become after thoughts. Self preservation is only about today. I cannot and will not make my political role about self preservation.

Recently I had the opportunity to address many Tribal

Members and their guests at the mortgage burning for Wind Creek Atmore. My message was simple: "Leave our Tribe better than we found it. Take advantage of the opportunities we enjoy today. "I said we are not a people of entitlement but of opportunity and that is my candidacy. Those opportunities range from healthcare to employment to per capita payments. Those programs are alive and vibrant today but we cannot foresee the future. If we become dependent and do not take advantage of the opportunity before us then we will have done ourselves and our Tribe an injustice.

My message does not mean that we should stop distributing a share of our good fortune in the form of per capita with the members. My hope is that every member will look at these times as an opportunity and not as an entitlement. Taking advantage of opportunities whether it is in the form of education, employment, health or cash benefits and prepare you for tomorrow. This is what I mean by being opportunistic. On the other hand, spending all of our resources today with no thought of tomorrow is entitlement. People of entitlement are bound to what others can do for them. They become dependent on those payments and when revenues decline they suffer. When we as a people become consumed with getting more today without thought of tomorrow then we will find ourselves in situations similar to other tribes who spent all their money and can no longer meet promises made to their people. I want our promises like caring for our seniors, providing health care, and educating our people to be kept.

As a Council member for the past six years I felt an obligation to promote programs that can and will survive after my time on the Council has passed. The elder benefits, education scholarships, burial benefits, and health insurance programs are vital to our Tribe. I emphasized these programs three years ago when I was up for re-election. I am proud to say we have made and continue to make progress in these areas. The burial benefits have been increased. Our education scholarships have been increased. The elder benefit has been increased and eligibility has been lowered to sixty-two. Over the next three years the elder benefit eligibility age will be further lowered to fifty-five. Health insurance for Tribal Members is now a reality.

Funding and enhancing these programs is essential to the long term success of our tribe. It is not fair to partially fund these programs today and let future tribal councils worry about keeping these programs alive tomorrow. More than seventy-five percent of our membership is over the age of thirty. One-third of our membership is over the age of fifty five. This means that as we take care of needs

today we must also recognize and plan to take care of our members in the future when there will be many more at or beyond retirement age. To assure that our members have assistance today and security tomorrow is essential but costly. I believe that once we start a benefit then tribal members should be able to count on those benefits. That's why I believe that we need to invest enough of our money today so that benefits will be here for our future. When we as a Council make these type decisions then we are taking advantage of the opportunity that we have today to make our tribe financially sound for the future AND better than we found it.

Three years ago I also emphasized economic development. We are still primarily dependant on gaming for most of our revenues The Council has approved segments of the master plan titled a "Place Called Poarch" which includes more diversified businesses including an entertainment facility that will have a movie theater, bowling alley, and arcade. Tribal Member employment continues to increase at PCIGA and other areas across the tribe especially at the staff professional and management levels. The Economic Development loan program continues to help business. TERO has been and continues to be a high priority for the Tribe. New revisions have been made and distributed for public comment because we know your input is crucial. It is crucial because we encourage transparency. Codes, Ordinances, and Constitutional Amendments are now put before the people for comment. May 14th of this year you will receive the audited financials of the tribe, another example of our commitment to transparency.

Cultural awareness was and is also a priority for me. We now offer more cultural classes than ever before, from basket weaving to language and almost everything in between. The Cultural Welcome center has opened and the museum design is underway. Anyone who wants to learn more about our culture or become more involved in the revitalization of our culture now has the opportunity.

Moving other initiatives forward is also important. An Assisted Living Facility and expanded health services clinic are very important. This past year the Tribal Council allocated almost eight million dollars to begin the expansion of our health clinic and begin work on the assisted living facility. We have promised these projects for a long time. The desire was there to build them but opportunity (in this case enough money) was not. We now have the money (opportunity) and the design phase of these programs has begun. Now we can make them a reality but neither the work nor the funding is complete. These projects will take more time and more money. We have allocated an additional three million dollars to build more rental units and home

ownership units so we are closer than ever to providing tribal members with housing opportunities. We are moving closer but we are not finished. These are all projects that will serve us today and serve us in the future.

This year we have a unique opportunity in front of us. The Tribal Council adopted a purpose statement and has voted to place that purpose statement on the ballot as a constitutional amendment. If it passes it will amend the current oath of office to read:

### Section 5. Oath of Office

Prior to assuming the elected office, the individual elected shall take the following oath of office:

I, \_\_\_\_\_\_\_\_\_, do solemnly swear or affirm that I will support and defend the Constitution of the United States and the Constitution of the Poarch Band of Creek Indians; and that I will faithfully, honestly and impartially discharge the duties of the office of the Chairman/Vice-Chairman/Secretary/Treasurer/Tribal Council to the best of my ability, so help me God.

As a proud leader of our Tribe, my integrity demands that I be true to who I am. My integrity is the foundation of my love for my family and our community, which strengthens my faith and commitment to do what is right for the Tribe. I will further the legacy of self-determination and self-reliance inherited from our elders by investing in the progress and driving a vision for the future that leads to our prosperity. I understand that I am beholden to the electorate and to the other Tribal Council members. To that end, I shall conduct myself in a manner which will foster respect and dignity.

We seek your endorsement of this commitment. These are words that I choose to adopt as my political and personal beliefs. It has been my pleasure to serve and has been an honor to be considered by you as a leader who has the best interests of our Tribe at heart. I believe our Tribe will make the right choice... Your voice is your vote. Do not sit in silence. I would love to continue serving you but no matter what your choice, please vote, because I believe in the collective wisdom of our Tribe.

I have been married to my wife Leslie Charlene Roberts Vickery of Troy, TX for 36 years. We attend New Home Church on Poarch Road. We have two children Randal Vickery and Jennifer Vickery Kelley. We have four (4) grandchildren-two (2) boys and two (2) girls.

I was raised in the Hog Fork Community. I attended Poarch Consolated Grammar School and graduated from Escambia County High School (Blue Devils) in 1969. I joined the U.S. Army in February, 1970 (this period of time was in the Vietnam era). The draft was still being used to place people in different branches of the military. I joined to keep from being drafted, to get a better chance at what I wanted to do in the military. In the early 1970's they ended the draft. In my opinion the United States made a mistake when they ended the draft, because I believe every young man or woman should spend at least two (2) years in the military. If the draft was still in effect I think society in the United States would not be in the shape it is in now.

I served one (1) tour in Vietnam and three (3) tours in Germany. I was stationed in numerous bases in the United States, (Fort Hood, TX, Fort Leonard Wood, MO, Fort Belvior, VA, and Fort Knox, KY.) I was a National Guard advisor in Grand Rapids Michigan.

Today you see lots of young people wanting things handed to them without having to work for it, like we had to do in the old days.

Some people are getting richer while others are striving to make ends meet. In this economy these days everything is costing a lots more to live on, and making a living is getting harder to do. A good paying job these days is hard to find and keep.

As a TRIBE we face challenges every day. We as TRIBAL MEMBERS should work together with the TRIBAL COUNCIL, to see that the things that we the people need are taken care of. I will work hard to move forward a plan to increase disbursements of the people's money and stop spending where it is not necessary. I will make known to all TRIBAL MEMBERS as to the TRIBES' assets and where the money is going.

In closing I would like to thank you for your time and consideration in voting for me on June 4, 2011. I will do my best to be a positive voice for the TRIBAL MEMBERS of the Poarch Band of Creek Indians.

So as TRIBAL MEMBER please exercise you right to vote and may GOD BLESS EACH AND EVERYONE OF YOU.

I am proud of the many accomplishments of the Department and would like the opportunity, with your vote, to expand my advocacy and community development activities to another level as a Council Member for the Tribe.

Community service activities include participating on various committees and Boards. I served on the Gaming Board for 10 years and the Best Western Board for more than 20 years. I currently serve on the Commission for the Tribal Equal Rights Ordinance, which was established in 2008.

My platform continues to be for increased communication between Tribal Council and General Council; focused emphasis on the rights of General Council; and expanded advocacy and development of comprehensive services for tribal members in need.

I will work diligently to improve communication and develop a system for ongoing consistent flow of meaningful information from tribal members to Tribal Council of what is needed and from the Council to the people of what is being planned and what actions are being taken in all areas of government. Another issue will be focus on the rights of General Council, as written in the Poarch Creek Constitution; and to ensure that their rights are protected and their voices are heard.

If elected, I would continue my advocacy to resolve tribal member issues at the Tribal Council table for the development of additional services for needy tribal families, disabled tribal members, tribal elders and their caretakers; as well as being committed to securing funds to develop wraparound elder services and an assisted living facility.

I support MONTHLY PER CAPITA PAYMENTS AT the full 20%. I am pulling for everything that would help you a tribal member with a better way of life. If the right leadership comes to office, especially in these hard times, there would be nothing our members would want for.

I am upset with the Tribal Council that common sense activities seems to be overlooked, except when it benefits them directly. I do appreciate that the council has to make decisions weekly that affect the Tribe as a whole, but giving yourself a 33 percent base pay increase is not practical; indemnifying yourself for \$13 million dollars in a lawsuit does not make sense; paying per capita at less than the 20% proposed rate is wrong. ### April Is Child Abuse Prevention Month & Sexual Assault Awareness Month

### Child Abuse Prevention Information

Pick up a newspaper, look on the internet, or simply watch the evening news and it becomes apparent child abuse and neglect can be found in every race and within every income level in our world. The impact of child maltreatment is profound and has life-long effects on the physical, psychological, and behavioral development of children. The good news is child maltreatment is preventable! We can honor our native heritage by building strong and supportive families who nurture and love our children.

Child abuse and neglect often takes place in the home and generally falls into four categories.

Neglect is the failure to provide for a child's basic needs, such as food and clothing.

Physical Abuse is causing physical harm to a child, such as hitting, kicking, shaking, or burning them. Sexual Abuse is any situation where a child is used for sexual gratification.

Emotional Abuse is any matter of behavior that impairs a child's emotional development or sense of self-worth, such as constant criticism, threats, and rejection.

Being a parent is a 24-hour-a-day job and it is normal for parents to feel overwhelmed at times. Parents can feel angry, lonely, and depressed while simply attempting to make ends meet. Don't let these feelings affect how you treat your children. You can: Talk to someone; Reach out to other parents; Call a help line (1-800-4-A-CHILD); Get babysitting help when you need a break; or Take a parenting class.

Prevention of child maltreatment includes five protective factors. First of all, **establishing a nurturing bond** between a parent and child will help the parent better understand, respond

to, and communicate with their children throughout life. Second, increasing parental knowledge of child and youth development will

help parents know what to expect as their children grow. Third, **parental resilience**, or the parent's ability to cope with stressors, is essential for parents to recognize about themselves, and to manage appropriately. Fourth, **establishing positive social connections** will enable parents to build support for themselves in times of need. And last, **having community support** is essential for parents to meet and better attend to their role as parents.

All children need to have strong parents who will love them and who will do what is in their best interest. Babies who have a loving bond with their parent will have a better chance to grow up to be adults who trust others and know how to return affection. As young children grow and develop, they need parents who will establish loving boundaries helping them to become independent and yet, safe. Teenagers need parental guidance and loving boundaries to guide them in their decision-making processes, their relationship choices, and their tendency to be risk-takers.

Children are a gift from God. They are the future hope of our tribe and of our nation. Take time to love them..

Treat them with dignity and respect. They will return your love and they will grow to respect you!



### THE FAMILY SERVICES DEPARTMENT HONORS OUR ELDERLY TRIBAL MEMBERS BY INFORMING OUR COMMUNITY IN HOW TO PROTECT "OUR" OLDER AMERICANS DURING OLDER AMERICANS MONTH.

What Is Elder Abuse? What Are the Warning Signs? Where Do I Go for Help?

**Elder abuse** is a term referring to any knowing, intentional, or negligent act by a caregiver or any other person that causes harm or a serious risk of harm to a vulnerable adult. Tribal Code and Legislatures in all 50 states have passed some form of elder abuse prevention laws. Laws and definitions of terms vary considerably from one state to another, or from Tribe to Tribe, but broadly defined, abuse may be:

- <u>Physical Abuse</u> inflicting physical pain or injury on a senior, e.g. slapping, bruising, or restraining by physical or chemical means.
- <u>Sexual Abuse</u> non-consensual sexual contact of any kind.
- <u>Neglect</u> the failure by those responsible to provide food, shelter, health care, or protection for a vulnerable elder.
- Exploitation the illegal taking, misuse, or concealment of funds, property, or assets of a senior for someone else's benefit.
- <u>Emotional Abuse</u> inflicting mental pain, anguish, or distress on an elder person through verbal or nonverbal acts, e.g. humiliating, intimidating, or threatening.
- <u>Abandonment</u> desertion of a vulnerable elder by anyone who has assumed the responsibility for care or custody of that person.
- <u>Self-neglect</u> characterized as the failure of a person to perform essential, self-care tasks and that such failure threatens his/her own health or safety.

#### WHAT ARE THE WARNING SIGNS OF ELDER ABUSE?

- Bruises, pressure marks, bedsores, broken bones, abrasions, burns, unattended medical needs, and unusual weight loss may be an indication of physical abuse, neglect, or mistreatment.
- Unexplained withdrawal from normal activities, a sudden change in alertness, unusual depression, belittling, threats, strained or tense relationships, frequent arguments between the caregiver and the elderly person or other uses of power and control by spouses may be indicators of emotional abuse.
- Bruises around the breasts or genital area can occur from sexual abuse.
- Sudden changes in financial situations may be the result of exploitation.





Chief Calvin McGhee in the Smithsonian!

Have you ever been to the National Museum of the American Indian at the Smithsonian? What a story the museum exhibits have to tell just like our museum will have a story to tell when it is complete. To assist me in the development of our new Office of Archives and Records Management at Poarch Creek Indians, I met with the Head Archivist at the National Museum of the American Indian at the Smithsonian in Washington, D.C. in February of 2011. Not only do the exhibits have a story to tell, but the books in the bookstore also have a story to tell. Upon browsing through the books on American Indians in the bookstore, I was delighted to find a book that has a write-up about our chief in it—Chief Calvin McGhee! So we could say that Chief Calvin McGhee is in the Smithsonian!

The book is titled The Columbia Guide to American Indians of the Southeast and it is written by Theda Perdue and Michael D. Green (2001). The authors say Chief McGhee "led the fight to win a settlement from the United States government in the 1940s and dominated Poarch Creek politics until his death." They talk about the importance of his attending the 1961 Chicago Indian Conference which enabled Chief McGhee to lead our Tribe out of isolation. The authors express that he gained audience with President John F. Kennedy and Lydon B. Johnson where he argued that "the Treaty of Fort Jackson of 1814 had been unfairly imposed."

The article marks Chief McGhee's lifespan saying he lived from 1904 to 1970, and notes that he was succeeded by his son Houston McGhee. It also says that the Poarch Creek Indians "earned federal recognition in 1984, the first such tribe in Alabama to do so."

There are other Muscogee (Creek) leaders written about in this stimulating book. For example, on the same page as Chief McGhee's write-up, the authors write about Alexander McGillivray who lived from 1750(?) to 1793 and who came from "the prominent Wind clan." He is noted as an important leader "who argued for more political cohesion in the Creek Nation to further collective interests."

Chief Waldo Emerson "Dode" McIntosh, who lived from

1893 to 1983, is also written about. Chief Dode McIntosh was from the Oklahoma Creek Nation and

our archives, we have a sympathy letter to our Tribe from Chief Dode McIntosh who lamented the untimely passing of Chief McGhee.

If this book sounds like a piece of history that you would like to own, you may call the book store at the National Museum of the American Indian at the Smithsonian at (202) 633-7030 to order a copy. I paid \$22.50 for my book and it was well worth the money to own a copy of

Chief Calvin McGhee in the Smithsonian.

## The Hard Road

During the Great Depression the Poarch Creeks were not well off in contrast to their non-Indian neighbors. The Episcopal Church entered their history at this point and documented the generally depressed conditions of the In the May issue of the 1930 Episcopal community. journal The Alabama Churchman ran a short feature entitled "Perdido Hills Indian Mission" which announced the beginning of the mission and clearly identified the Poarch area as an Indian community. In December of that year Robert C. Macy, M.D., a physician working in collaboration with the missionary arm of the Episcopal Church, wrote an article titled "The Indians of the Alabama Costal Plain" which was published in the Alabama Historical Quarterly. This article was the first major ethnographic work on the Poarch Band of Creeks and gives a full account of their constitution and living conditions. Macy makes a strong statement in the article about the leadership in the community: "I am unable to give any data concerning the Rollin ancestors, but the patriarch, and acknowledged chief of the Indians in this vicinity is an octogenarian, 'Uncle Alex' Rollin, as we call him." In the mid 1930's Anna C. Macy, Macy's wife, wrote a brief history of the Poarch Creeks. Although the document is not long, it is well detailed for that period of time and outlines the work that she and her husband had done for the community and the work that the Episcopal Church did on behalf of the Indians of the Poarch community. It does not include however, the consolidation of four Indian schools into one school meeting at St. Anna's Church. This happened in 1939 when the County Board of Education consolidated the Rollin, Poarch, McGhee, and Gibson Indian Schools. The new school, known as the Poarch Indian Consolidated School, was finally closed in 1970 as a result of the 1969 U.S. Supreme Court desegregation order requiring Alabama to desegregate its schools

The involvement of the Episcopal Church into the lives of the Poarch Creeks was to have many beneficial results for those in the community. It was decided to build a small church in the community itself, to be named St. Anna's Mission, with the first pastor being Rev. Edgar Van W. Edwards of Atmore. The March 31, 1932 edition of the Atmore Advance reported that "Sunday about noon a twister formed in the field of Frank Hixon, near Poarch, and leveled the frame work of the new church of St. Ann [sic] Episcopal, being built by Rev. Edgar Van W. Edwards for his Indian congregation at that place." This was only a minor setback, however because the Church was completed later that year. Edwards also undertook an extensive survey of the Poarch Creeks community

which, in final form was 17 pages in typescript listing all the Poarch Creeks and certain vital data. Other positive results of Edwards' service to the community was increased awareness in matters relating to health, education, basic rights, and employment.

In October of 1934, the first contact with the Bureau of Indian Affairs was made. Samuel H. Thompson of the Office of Indian Education visited the community and wrote a report of what he found. The report is not comprehensive, it deals mostly with the Indian schools at Poarch and the 130-40 pupils enrolled in them. However, Thompson makes a significant statement: "This group of Indians lives about nine miles out of Atmore, and they regard Will McGhee...as their leader." Both Will McGhee and Alex Rolin, it appears, had clear leadership roles in the early twentieth century.

In February of 1941 noted anthropologist Frank Speck visited the Poarch Creeks and made the first professional ethnographic study of the community. Speck published his findings in America Indigena under the title "Notes on Social and Economic Conditions Among the Creek Indians of Alabama in 1941." This study contains much valuable information about the community and cultural survival relative to customs, healing practices, and social behavior. Speck wrote that Fred Walker "... comes nearest to functioning as a leader of the Creeks at Atmore," and that "He is provisionally called 'chief'..."

The year 1947 marks the beginning of the modern period of history for the Poarch Band of Creeks. From this point on, the Poarch Creeks begin a series of struggles for their rights: rights of education, of equal opportunity, of sharing in Creek judgment awards, or recognition by state and Federal authorities. In this process, they "professionalize" and become more sophisticated in operating in a world of courts and bureaucracies. While these struggles each had different effects upon the community as a whole, the overall effect was one of providing points or areas of consensus around which communal singleness of purpose and unity would flourish.

In 1947 Calvin McGhee organized an informal committee of Poarch Creeks to meet with county school officials, civic organizations, and even the governor in order to improve conditions in the community. The county, it seems, refused to allow the Poarch Creek children bus transportation to the Junior High School in Atmore. In a daring confrontation, Jack Daughtry, a Creek from Poarch, stood in the path of a school bus and refused to move until the driver allowed the Indian children to board.

## To Federal Recognition

The outcome of this confrontation was a law suit. On December 2, 1948 attorneys Hugh Rozelle and C. LeNoir Thompson for the Poarch Creeks filed a petition for mandatory writ, Annie R. Walker, et al. v. O.C. Weaver, et al. They were ultimately successful in this suit, as they were in their second major legal battle in which they filed as interveners in the The Creek Nation v. United States before the Indian Claims Commission.

In 1950, in anticipation of the ensuing battle with the Indian Claims Commission and ultimately with the U.S. Court of Claims, the Poarch Creeks formally organized a council to deal with claims issues. From this point on, records of the council's actions are recorded in minutes.

On January 5, 1951 Poarch Creek, using the name "The Perdido Friendly Creek Indian Band of Alabama and Northwest Florida Indians" moved for leave to intervene in the case of The Creek Nation v. the United States (Docket 21) which the Creek Nation filed in the Indian Claims Commission on January 29, 1948. The suit was filed to recover damages for the acquisition by the United States of 23,267,000 acres of Creek lands in Alabama and Georgia under the Treaty of Fort Jackson. to be a roll created of all descendants of the aboriginal Creek nation to whom a distribution of funds was to be made in compensation of the expropriated land. This of course was the reason for the intervention by the Poarch Creeks but the Indian Claims Commission refused to allow the intervention on the grounds that they were not an "identifiable group."

Poarch Creek successfully appealed to the U.S. Court of Claims to allow the intervention. The Commission amended its findings and 52% of the current membership of the Poarch Creeks shared in the original judgment for only 8,849,940 acres of land. The Creek plaintiffs in Docket 21 were dissatisfied with the findings of the Indian Claims Commission, feeling that both the award and land compensated for were too small. They appealed to the U.S. Court of Claims and the U.S. Supreme Court, but were rejected in both.

On August 27, 1971 the council filed articles of incorporation as the Creek Nation East of Mississippi, which officially incorporated the Poarch Creeks into a non-profit organization. This pivot in the direction of their history changed their income pattern from small donations by community members to larger grants from various agencies, thereby having a significant economic

impact on the community.

In 1972 Professor J. Anthony Paredes of Florida State University began his extensive ethnographic research into the community, taking oral history and eventually writing half a dozen anthropological papers on the ethnohistory of the Poarch Creeks. Professor Paredes continues to be an important friend and asset to Poarch Creek.

On May 15, 1975, the Native American Rights Fund submitted a petition for Federal acknowledgment on behalf of the Poarch Band of Creeks. The petition asserted that a trust relationship exists between the Band and the United States. The main issue involved around an offer by the State of Alabama to deed the land upon which the Poarch Consolidated Indian School stood to the United States, to be held in trust for the Poarch community. At that time there were no criteria for Federal acknowledgment or any systematic procedure to evaluate such petitions, so no action was taken. This request precipitated a study to determine the legal status of the land and the history of its granting and transfer. After an exhaustive study by the Office of Trust Responsibilities in the Bureau of Indian Affairs, Commissioner Thompson issued a Memorandum to the Associate Solicitor of the Department of Interior stating that "a positive evidence of record" supports the claim that the March 3, 1817 statute had no application to the Lynn Mcghee reserved secured under the 1836 statute.

In 1976, Poarch Creek received a Federal grant of \$117,775 from the Department of Labor for a CETA grant due to the provision of awarding monies to American Indian groups. In the summer of 1979 two more large grants were awarded to the Poarch Creeks, one from the Department of Education under Health, Education and Welfare and one from the Administration for Native Americans (ANA). In 1982 the Poarch Band of Creeks received a "status clarification" grant from the ANA enabling them to hire professional researchers to help in the preparation of the second and revised petition for Federal Acknowledgment.

Next month's article will conclude this series of articles. We hope that you have enjoyed this series and have learned something new about your ancestors and the hardships and sacrifices they had to make to bring our Tribe to the place it is today.
