The Poarch Creek News is generated on a monthly basis by the Government Relations Department of the Poarch Band of Creek Indians at the direction/discretion of the Tribal Council to provide important updates, news, and information to Tribal Members. We reserve the right to edit or refuse any item for publication.

The Poarch Creek News is generated one month prior to the month of publication. The deadline to submit information to be published in the newsletter is the 10th of the month prior to the month of publication. If the 10th falls on a weekend or holiday, the deadline is extended to the next working day.

Due to space limitations, submitted articles should be limited to 500 words or less.

Obituaries/Family Thanks will be published if submitted by the last working day of the <u>second</u> month immediately following the death.

All other deadlines remain the same and are published in the appropriate sections of the newsletter.

Once the newsletter has been posted on-line, you can use the embedded hyperlinks to take you directly to articles/ pages, web sites, email forms, etc.

We have incorporated the use of the Muskogee language as much as possible in the newsletter. You will see examples in the numbers of each page as well as on the front cover.

INTERIOR CONFIRMS POARCH CREEK LANDS ARE PROTECTED BY FEDERAL LAW

Tribal Press Release dated June 6, 2012

The United States Department of the Interior, has sent a letter to the Alabama Escambia County Commission (Commission), decisively dismissing its contention that the Poarch Band of Creek Indians' (PBCI or Tribe) lands are not protected by federal laws.

In a June 4th letter, the Interior Department's Acting Assistant Secretary for Indian Affairs confirmed that PBCI's land was, indeed, taken "in trust by the United States in 1984 and proclaimed to be a Reservation in 1985" and that PBCI "enjoys all rights and privileges associated with having its Reservation held in trust." This letter shows that Chairman Stokes' attempt to tax the Tribe's trust lands is without merit.

Indian tribes are recognized several times in the United States Constitution. Most notably, the "commerce clause" acknowledges that tribes are considered separate, distinct governments as are states and foreign nations. Therefore, none of these entities, nor their lands is, subject to taxation by another form of government.

In April, Chairman David Stokes announced at a press conference that Brian Taylor, an attorney from Elmore County who once worked for former Alabama Governor Riley, had been hired by the Commission after convincing several members that PBCI's lands had not legally been taken into federal trust and were subject to the County's property tax. Under a written agreement signed several years ago, the Commission and the Tribe had agreed to sit down and discuss any potential problems or areas of concern. However, the Tribe was not notified of the Commission's action until Mr. Stokes' press conference.

"It is unfortunate that Chairman Stokes did not attempt to sit down with the tribe before taking this action," noted Robbie McGhee, head of the Tribe's Government Affairs office. He continued, "His move by the Commission has clearly strained our relationship. We have given the Commission hundreds of thousands of dollars to be spent on improving the county. We have paid millions in taxes, and created thousands of jobs that employ county residents and add to the tax base. This was a short-sighted attempt on the part of the Commission that we hope will not have a long-term effect on the relationship between our government and the County. "

Tribal Chairman Buford L. Rolin said, "We are committed to being good neighbors to Escambia County and throughout the State. We are pleased to be able to continue to create jobs, contribute millions of dollars to the schools, provide fire protection, public safety, and infrastructure

improvements in Escambia County, and serve as an economic driving force in Alabama."

The letter from the Department of the Interior, stating that the laws that have protected the Tribe's lands for over 25 years were never under question, reads as follows:

"Dear Chariman Stokes:

Thank you for your letter dated April 17, 2012, to Secretary Salazar requesting information about the Reservation for the Poarch Band of Creek Indians (Band). The Secretary has asked me to respond to your letter.

In response to your request, the Department of the Interior can confirm that the land referenced in your letter was accquired in trust by the United States in 1984 and proclaimed to be a Reservation in 1985. The Band's Reservation, including the portion of the Reservation that is situated within the geographical boundary of Escambia County, Alabama, is held in trust by the United States for the Benefit of the Band. As such, the Band enjoys all rights and privileges associated with having its Reservation held in trust by the United States under Federal Law.

INCUMBENTS RETAIN SEATS ON COUNCIL

Another Tribal Election is behind us; the General Council turned out in record numbers and voted to retain the three incumbents, Stephanie Bryan, Sandy Hollinger, and Keith Martin.

Stephanie was re-elected to the position of Vice Chair of the Tribal Council; Sandy and Keith were re-elected to their At-large seats on the Tribal Council. There was a total of 1265 General Council Members who voted in the 2012 Tribal election process; there were 185 Absentee Ballots, 534 Walk-In votes prior to Election Day, and 546 votes cast on Election Day, Saturday, June 2, 2012. The proposed Constitutional Amendment also passed with 848 yes votes.

This will be Stephanie's third term as Vice Chair. She is the first female to serve in this position and is the first person directly elected by the General Council to serve in this position, now twice in a row. With three seated Council Members running for the Vice Chair position, it was felt by many that this position would be filled after a run-off election. Stephanie never faltered in her determination to work and communicate with her fellow Tribal Members and was elected by a landslide of 758 votes; no run-off election required!

In addition to her other duties and responsibilities as Vice Chair, Stephanie serves as Chairman of the Tribal Gaming Commission and serves on the Education/Labor and the Housing/Health Legislative Committees of the Tribal Council.

Sandy Hollinger is a relative newcomer to the political arena. She was elected to a one year term in 2011 to complete the three year term of former Tribal Council Member Berry Ross. She gallantly campaigned for re-election and was elected to serve her first three year term with a record setting 729 votes; the most ever received by a candidate for an At-Large position on the Tribal Council. Sandy currently serves on the Governmental Affairs/ Rules Legislative Committee, and the Cultural/Community Activities Legislative Committee of the Tribal Council as well as serving as the Tribal Council representative on the TERO Commission and the Boys & Girls Club Board.

This will also be Keith Martin's third term on the Tribal Council. He was first elected to the Council in 2006. He has always campaigned on an agenda of family, tradition, and seeking opportunities to help carry the Tribe into an economically secured future. He serves on the Housing/Health, Land/Natural Resources, and Budget/Finance Legislative Committees of the Tribal Council as well as serving as Chairman of the Gaming Board.

The Constitutional Amendment which passed with 848 yes votes versus 339 no votes addresses the filling of positions on the Tribal Council that become vacant between elections. An updated copy of the Tribal Constitution will be published on the Tribe's web site in the near future for your convenience and review. Until that time, a general synopsis of the revision is as follows:

• In the event of the Chairman's death, resignation, or removal, the Vice Chair shall be duly sworn in as Tribal

Chairman at a special called Tribal Council Meeting within three days of the position becoming vacant; the Vice Chair shall serve in this capacity until the next election at which time the General Council will elect a new Tribal Chairman.

- In the event the Vice Chair, Secretary, or Treasurer positions become vacant between elections, the Tribal Council shall appoint from among its members a person to fill the vacancy. The Tribal Council Member appointed to fill such vacancy shall serve until the next election at which time the General Council will elect the individual to serve the balance of the current term.
- In the event any At-Large position becomes vacant between elections, the position shall remain vacant until the next election at which time the General Council will elect the individual to complete the current term.
- If the next annual Tribal Council election is more than 180 days after an Officer or At-Large position becomes vacant, a special election shall be held to fill the vacancy.

There were 18 candidates for the three positions to be filled during this year's election process. Each candidate is to be commended for stepping forth and voicing an interest in serving their fellow Tribal Members in a position of leadership.

The roll of leadership is a hard task, one that should not be taken lightly; there are sacrifices that must be made, including spending less time with family and loved ones. We thank each candidate for stepping forth and being willing to make these sacrifices. We encourage each of you that feel they can benefit the Tribe by serving in a leadership position to step forward when the election process begins again next year. Next year the positions of Tribal Council Secretary, Tribal Council Treasurer, and one At-Large Tribal Council position will be up for re-election. We do not know at this time if any of the incumbents will run for re-election.





Tribal Council Revises McGhee-Tullis Tutition Assistance Program

Please be advised that as of May 17, 2012, the Tribal Council of the Poarch Creek Indians approved revisions to the McGhee-Tullis Tuition Assistance Program.

If you are currently participating in or plan to participate in this program, it is *VERY IMPORTANT* you read the policy to find out how the following revisions will affect you. Major policy changes include:

A multi-tiered method for placing limits on tuition awards -

\$30,000.00 Associate's Degree/

Vo-tech/Certificate programs

\$50,000.00 Bachelor's Degree

\$75,000.00 Master's Degree

\$100,000.00 Professional Degree

These amounts are cumulative—if you spent \$40,000.00 on your Bachelor's Degree, you would have \$10,000.00 of your Bachelor's level allotment remaining, *PLUS* \$25,000.00 from the Master's level allotment, for a total of \$35,000.00 to be used for graduate studies.

- Academic achievement bonuses may now be received as a cash award at the end of each academic year.
- Student loan repayments are now structured in the same manner as the tuition limits above. Students who are repaying student loans should contact the Education Department to determine if they are eligible for additional assistance.
- The purchase of a second computer is now allowed if it has been 4 or more years since your initial purchase AND you are still enrolled in school a minimum of 6 semester hours and in good academic standing.

These changes are very important, and it is your responsibility to be familiar with them. All current participants will be receiving a revised policy by mail. It will also be placed on the Tribe's web page at www.poarchcreekindians-nsn.gov as soon as possible.

Housing Department Update

I mentioned in a previous newsletter that I would keep everyone up to date with our new TAHO program. At this time I can only update on the status. The Housing Authority Board has met and continues to meet on a regular basis to get this program created. I assure you that as soon as the program is ready for applications, every Tribal Member interested in the program will know about it.

In the meantime, I would like everyone to know about other programs available.

RENOVATION LOAN PROGRAM

The Renovation Loan Program provides Tribal Members with the opportunity to renovate their homes. This program is a repayment program. Loan amounts are available for no more than 50% of the applicant's total income and cannot exceed \$30,000.

The term of the loan will be in five (5) year increments not to exceed twenty (20) years and will have an interest rate of three (3) percent. Must have a credit score of 550 or higher.

This program has other eligibility requirements that must be met. This is only a few I've listed.

The program is nationwide for every eligible tribal member through the Poarch Creek Indians Housing Authority.

The Perdido River Farms (PRF) Enterprise would like to update Tribal Members on the volume of cattle that are currently being worked on the farm.

Brood Cows/Calves:

Year to date we have 630 brood cows that have produced a total of 608 calves. We have 53 replacement heifers that will be in the brood cow herd next breeding season.

The farm has purchased a small herd of brood cows from a local farmer that will bring our total brood cow number to 700 for the next calving season.

Bulls:

The farm is currently operating with 30 bulls, with two bulls in the sick pen nursing leg injuries.

Additional Acres of Pasture Land:

PRF is currently in the process of clearing off an additional 40 acres on Martin Road and an additional 25 to 30 acres on Bell Creek Road that will be put into pasture land.

TRIBAL MEMBER PROMOTED TO LIEUTENANT POSITION WITH TRIBAL POLICE DEPARTMENT

On May 20, 2012, Tribal Member Jeffrey Weaver was promoted to the position of Lieutenant with the Poarch Creek Tribal Police. Jeffrey is the first Tribal Member to hold this position and is the highest ranking Tribal Member in the department. As Lieutenant Jeffrey oversees all scheduled shifts and trainings for Tribal Police Officers and other Tribal law enforcement personnel to ensure they meet their required forty (40) hour continuing education requirements. He is also responsible for reporting all training certification to the Alabama Peace Officers Standards and Training Commission to ensure that each officer/law enforcement personnel

retains his/her Alabama Peace Officers Certification with the State of Alabama. He is responsible for maintaining morale among department personnel and the upkeep of all Tribally issued law enforcement related equipment.

Jeffrey is a long term Tribal employee, he first came to work for the Tribe in 1994 and worked in maintenance for the Housing Department prior to coming to work with the Tribal Police Department in 1996. He graduated from the Southwest Alabama Police Academy later that year and continued to work as a Public Safety Officer until March of



2006 when he was promoted to Corporal and assigned to the Creek Casino where he had the responsibility of overseeing at least ten (10) Public Safety Officers. 2007 Jeffrey left the department to join the PCI Gaming Commission staff as an Investigator. When an Investigator position became available in the Tribal Police Department in 2008, Jeffrey applied and was hired into the position and returned to the department.

After working with investigations for a period of time, Jeffrey decided he wanted to get back into the patrol side of things

so he stepped down as investigator and became the Patrol Sergeant. He continued his duties in this position until his promotion on May 20, 2012.

Jeffrey is the son of James "Red" and Charlene Weaver. He is married to Jackie Pittman Weaver; they have three children, Hunter, age 14; Hayden, age 9; and Hayla, age 7.

We would like to congratulate Jeffrey for his loyalty and dedication to the Tribe and the department and for his hard work in rising through the ranks to this new position. Keep up the good work Jeffrey, you are an inspiration to us all!!!

Family Services Department Updates Continued for July, 2012

2012 Summer LIHEAP (Low Income Home Energy Assistance Program)

The Summer LIHEAP program will run from May 1, 2012 through July 31, 2012.

The Summer LIHEAP program will be disbursed as follows:

- If you participated in the 2012 Winter LIHEAP program and have NO changes to your household constitution or in your household income
 you will need to do the following:
 - 1. Fill out a one page application which will be available in the Family Services waiting room.
 - 2. Attach your household's current energy bill to the application.
 - 3. Leave your application at the Family Services Department front desk.
 - 4. Your application will be reviewed and you will be notified of whether your application is approved or denied through an Awards Letter that will be mailed to your address.

*Note: If you participated in the 2012 Winter LIHEAP program and have had changes in your household constitution or changes in your household income, you will need to schedule an appointment for Summer LIHEAP.

• If you DID NOT participate in the 2012 Winter LIHEAP program, you will need to make an appointment for Summer LIHEAP.

**All Summer LIHEAP appointments will be made daily, (Monday through Friday), from 8 a. m. until noon during the designated months of May, June, and July. Please contact the Family Services Department at 368-9136, extension 2600 to schedule an appointment.

Approval amounts for Summer LIHEAP 2012 range from \$250-\$325 based upon eligibility. You will be responsible for any charges that are not covered by LIHEAP such as late fees, lights, etc. If your bill is less than the awarded amount, only the total amount of the bill will be paid.

Required Documentation for All Applicants

- Current energy or gas bill.
- Social Security cards for ALL members of the household.
- Tribal ID for applicant/head of household.
- Current income verification for all household members that are over the age of 19, such as paystubs, paychecks, letters of salary verification, etc...
- If anyone in the home is over 19 and is unemployed, you must bring a statement verifying they are not working. The statement must be signed by three people who do not reside in your household and must include their phone numbers.
- Current verification if receiving state unemployment benefits, food stamps, TANF.
- CURRENT 2012 Social Security or Disability Income Verification. We must have current income verification on file for all 2012 applications and services.
- If your power bill is in another person's name (family, landlord, roommate, etc.), must bring a written statement from that person verifying that they allow you to have the power bill and service in their name.

As a child of about five with those years under my belt, I was never really "wild" about the idea of school and what comes with it. I was scared of the other children and what they would say about me being the "poor girl". Or maybe even the fact that I wasn't the fastest learner we hoped we could have been.

Grade school was pretty tough for a shy girl like me. Bullies loved to hurt me, and everyone else never really knew I was there. I was like a mouse, tiptoeing when need be to not be seen by the sleeping family, only to be caught by the wicked cat. Somehow I made it through.

A few years fly on by me and it's time for middle school, time to build the young woman I am to become. I fight tooth and nail to get my grades afloat. But nevertheless they start hitting the bottom. Believe me, I tried not to be a lost cause, but I got tired of never getting anywhere. So I came to think of myself as a lost cause. I soon quit going to school. It felt like a waste of time. I couldn't learn! There was no future for someone of the likings of me. Just problems I couldn't solve, terrible troubles I couldn't overcome.

I lived like that for a good long while. If I'd have to guess, it was for two years at the most that I'd pulled

along that still healing wound of self-pity. Until one, boring run of the mill day comes along and "Bam" I sat my mind to getting my G.E.D. Then maybe I'll plan my life on a better foot, one that's planted on level ground. Maybe have a little more faith in what I am and what I can become than what the other kids think about me. Where were those kids when I was in that dark cave of pity? Laughing on the other side. Maybe if I believe a little harder, think a little more clearheaded, I'll have a chance to show the world and myself I'm not that same little girl.

So I bravely walked into the room that could mold me into the vision of me that only I dream of. I sat at the desk of the G.E.D. teacher and listened to every word she had to say. I didn't want to miss a thing! My life from here on out will be branded by the power to overcome rather than lack of education. Through having my G.E.D., I'll be giving myself something I took away, not the other kids. The hope that, no matter the mess we find ourselves in, through educating our mind we can find a way out of our darkness to a life as beautiful as we dream it to be. Because we have that power inside ourselves, if we believe it to be. I've learned a lot over eighteen

years on this green old earth and hope that when I'm eighty I'll still be learning the benefits of the education I'm laying out for myself today.

911 RATE INCREASE ON PHONE BILLS

To the citizens in Escambia County Alabama,

You may have noticed that your telephone bill has gone up slightly in the recent month due to an increase in the 911 tax. Escambia County has been fortunate enough not to have needed to raise the 911 tax since the creation of the Emergency Communications District in 1990. However, after much research and seeing that our rates have been lower than most other counties in Alabama, it was voted upon and agreed to by the 911 Board to increase this tax in a public meeting that was held on March 9, 2012.

As of April 1, 2012 the 911 tax was raised from 77 cents to \$2.00 for all residential lines and from \$1.96 to \$3.00 for all business lines. This 911 tax is collected on our behalf by the telephone companies and the monies are used to provide you, the citizens, with a life-saving 911 system. We are sorry for any inconvenience you may experience,

but this money is used for a vital service. The 911 Board is dedicated to providing a 911 service to the citizens of Escambia County. We are also responsible for assigning all address within the county and the promotion of Safety Education. Your money is used to train the 911 Dispatchers, purchase necessary equipment and the maintenance of that equipment.




