

### Newsletter Information & Deadlines

The *Poarch Creek News* is the official newsletter of the Poarch Band of Creek Indians. The newsletter is furnished to Tribal Members, widows/widowers of deceased Tribal Members, Tribal entities, and representatives of agencies providing funding, i.e. IHS, NRCS, and official representatives of other Federally Recognized Indian Tribes at no cost. Non-Tribal Members interested in receiving the *Poarch Creek News* must pay an annual subscription fee.

The Poarch Creek News is generated on a monthly basis by the Government Relations Department of the Poarch Band of Creek Indians at the direction/discretion of the Tribal Council to provide important news, updates, and information to Tribal Members. We reserve the right to edit or refuse any item submitted for publication.

The *Poarch Creek News* is generated one month prior to the month of publication. The deadline to submit information to be published in the newsletter is the 10th of the month prior to the month of publication. If the 10th falls on a weekend or

holiday, the deadline is extended to the next business day.

Due to space limitations, submitted articles should be limited to 500 words or less. Photos are limited to one photo per article submission. When forwarding a photo for publication in the newsletter, please be aware of the quality of the photo you are sending. We all want to look our best when we see ourselves in print! Over the past year we have received several photos that were of poor quality and did not publish well. If possible, do not use photos from a newspaper or magazine. If there is a photo in a newspaper or magazine that you would like to use, please contact the publication and ask them for a digital copy of the original. When using copiers or scanners to scan your photo, please check your settings. When using a scanner that gives you the option, please set the resolution at 300 pixels per inch. If all else fails, you can bring or send the original photo to the Poarch Creek News; it will be scanned, saved, and returned to you.

Submissions such as obituaries, birth announcements, wedding & engagement announcements, and birthday & anniversary wishes are limited to Tribal Members & spouses, First Generation & spouses, and those living in a Tribal Member household.

**Obituaries/Family Thanks** will be published if submitted by the last business day of the <u>second month</u> immediately following the death.

**Birth Announcements** will be published as long as the information is received by the last business day of the month immediately following the birth.

Engagement/Wedding Announcements will be published as long as the information is received by the last business day of the month immediately following the engagement/wedding.

Birthday & Anniversary Wishes may be published the month before, the month of, or the month after the birthday/anniversary. Birthday wishes are limited to 30 words or less, excluding name and birth date.

## **ELECTION RESULTS**

There was a total of 1289 General Council Members who voted in the 2013 Tribal Elections. There were 225 Absentee Ballots and 499 Walk-In Ballots counted with 565 General Council Members who voted in person on Election Day, Saturday, June 1, 2013.

This year the General Council voted to directly elect the Tribal Council Secretary, Tribal Council Treasurer, and one At Large position. To claim victory in the At Large position, the winning candidate had to receive the highest number of votes cast for that position. To claim victory for the Tribal Council Secretary and Treasurer positions, the winning candidates would have to have at least 646 votes, which is one vote more than 50 percent of the votes cast.

With a total of 241 votes, political newcomer Kevin D. McGhee was elected to the At Large seat previously held by outgoing Tribal Council Member Eddie L. Tullis. Mr. Tullis decided not to run for re-election after serving the Tribe for over 45 years.

Incumbent David Gehman received 413 votes for Tribal Council Secretary. David will face Tim Ramer in a run-off election on Saturday, August 3, 2013.

Incumbent Robert "Robbie" McGhee received 525 votes for the Tribal Council Treasurer position. Robbie will face Gia Langham in a run-off election on August 3, 2013 as well.

Saturday, June 1, 2013 was Tribal Election Day. When the polls closed at 7:00 p.m. and the votes were all counted, Kevin D. McGhee was announced as the candidate selected to fill the At-Large seat of previous Council Member Eddie L. Tullis who elected not to run for re-election.

Kevin, a life long resident of Poarch, is the son of Shirley Von and Eldnar (McGhee) McGhee. He is the grandson of the late Shirley McGhee, the late A.D. and Willie Lee (McGhee) Martin, and the late Levi and Tracey (Walker) McGhee. He is married to Tawana (McDuffie) McGhee, they have three daughters and one grandson.

After taking the Oath of Office at the June 6, 2013 Tribal Council meeting, Kevin took his seat at the Tribal Council table and participated in the rest of the meeting.

#### VICE CHAIR ATTENDS LISTENING SESSION

United South and Easter Tribes Press Release Submitted by Sharon Delmar, Public Relations Tribal Liaison

The U.S. Department of Education (ED) held a Tribal Consultation and Listening Session on Monday, May 13, 2013 leading up to the United South and Eastern Tribes, Incorporated (USET) Semi-Annual meeting. The meeting was scheduled to last throughout the day with an overview of American Indian Education in the USET region, comments from Tribal leadership in attendance, a report from the USET Education Committee, and for public comments.

Support for Native language, cultural concerns a activities, and Tribal history was the opening theme for educators who are taking the opportunity to speak during the consultation. "The concept here is that our Tribes need help with teaching the Native languages and cultural activity. It is shown that students show great signs of improvement when they learn about their culture, history, and know their language and improve their self esteem," says Seneca Nation of Indians Director of Education for the Allegany Territory Chanda Grey.

Poarch Band of Creek Indians Vice-Chair Stephanie Bryan built on Grey's comments by saying, "In our schools we allow Spanish and other foreign languages to be taught and count as credit for foreign languages. But we need to show more effort to support the language that is spoken by our Tribes. Statistics show that when we have cultural activities, teach the language, and our history, the dropout rate declines. Speaking of bricks and mortar, new buildings are nice things to have. But, it's not what the building looks like; it's what's in the building."

Speaking to the session USET President Brian Patterson commented "I thank you for coming to the ancient homeland of the Seneca Nation of Indians. Sometimes our people are left out of the processes. Even though it's a small group, yet we speak of an American value. America honored its veterans and low income. So to should it honor the American value of its trust responsibility to Indian Country. Our children are still being left behind."

Oneida Indian Nation's Kandice Watson noted some of the struggles USET Tribes have are the effects of

having a poor relationship with the state government. "We have a high truancy and dropout rate in Oneida (Indian Nation- New York). I think with us and a few other Tribes, it's the states' unwillingness to recognize the sovereignty of our nations. In most areas through out the USET region it has been difficult to get anywhere with the states where they reside," Watson stated.

Poarch Band of Creek Indian's Megan Young added to Watson's statement saying, "States don't realize that American Indians make up only one percent of the United

States population. In that perspective we are a national treasure. States don't see any value in bolstering our values and our educational systems. I want to propose an initiative to educate our state and state educators. We have to educate those who are educating our Indian students."

Also in attendance were Wampanoag Tribe of Gay Head (Aquinnah) Vice Chair Richard Randolph, Eastern Band of Cherokee Indian school board member Lori Blankenship, St. Regis Mohawk's Roderick Cook, and Seneca Indian Nation's Jeff Brown.

Office of Indian Education Director Joyce Silverthorne gave an overview of how the listening session and consultation was taking place. Director Silverthorne stated the Indian Education budget would not suffer from the federal sequestration for the current year (2013). However, if there are no changes to the current legislation regarding federal sequestration, Silverthorne says there will be a five percent reduction to the Indian Education 2014 budget.

OIE listening and consultation sessions are conducted by Director Silverthorne (Salish) and White House Initiative on American Indian and Alaska Native Education Associate Director Sedelta Oosahwee (Mandan, Arikara, Hidatsa, Cherokee). The next listening session and consultation is expected to be held in August in Northern California.

## TRIBE DONATES TO AREA ORGANIZATIONS

The Poarch Band of Creek Indians has announced a donation of more than \$300,000 to several area organizations. These contributions are part of the Tribe's ongoing Planned Giving Campaign for 2013. The Tribe's donations will fund a wide variety of community services and projects. The Tribe's contributions will offset funding cuts in organizations as diverse as the United Cerebral Palsy's Camp SMILE, the Westside Athletic Association, and the Lighthouse Counseling Center.

"We are thrilled to have the Poarch Band of Creek Indians join us in sharing a summer camp experience to children and adults with disabilities," says UCP President and CEO, Glenn Harger. "Camp SMILE serves more than 300 individuals each summer, and Poarch Creek's involvement will truly provide a positive impact and life-long memories for everyone involved."

The Tribe's donations include:

- \$100,000 to United Cerebral Palsy/Camp SMILE.
- \$100,000 to the New Beginnings Ministries, Inc.
- \$50,000 to the Lighthouse Counseling Center.
- \$40,000 to the Westside Athletic Association.
- \$12,199 to the Dozier Improvement Committee.

"I can't think of few better days than this one. It is an honor to be able to support these projects and help fund services that do so much for so many. If we can play some part in improving the quality of life for our neighbors in the community and our State, then we are truly blessed. We are committed as a Tribe and as individuals to helping those less fortunate where and when we can," said Tribal Chairman Buford L. Rolin.

## TRIBE DONATES TO LOCAL SCHOOLS

On June 6, 2013, the Poarch Band of Creek Indians donated more than \$200,000 dollars to schools in Escambia and Monroe counties in Alabama. The Tribe made the donation as part of its 2013 Planned Giving Campaign.

"At a time when budget cuts are infiltrating our schools, I am proud that we are able make this investment in the future of our children," noted Tribal Chairman Buford L. Rolin. "I believe knowledge that is gained through education is essential for children to reach their goals in life, and it will enable them to have limitless opportunities."

Discussion around the table got a little emotional at times, but everyone left with smiles on their faces and even posed for photos in the big rocking chair at David's Catfish.

Mr. Tullis attended his last Tribal Council meeting on June 6, 2013. After the completion of old business on the agenda, Mr. Tullis spoke to the Tribal Council and the General Council in attendance. He spoke of the past and the future. He ended his farewell speech by welcoming incoming At-Large Council Member Kevin D. McGhee. "I have no problems relinquishing my seat to Kevin. He has served on a number of boards for the Tribe and I know he has a heart for what is best for Tribal Members. I wish him the best of luck." Prior to taking his seat in the audience, the Tribal Council wished him well, thanked him for his years of dedication and service, and honored him with a Pendleton Blanket.

# The Importance of Strength Training

I grew up in the south and from a young age played sports, mainly track and football. Over the years I have witnessed people start many different exercise programs. I have also seen people get frustrated and stop exercising. But I have also witnessed people make complete transformations to their bodies by sticking to some basic training principles. How did 100% of these people reach success? Strength training. Strength training is the foundation for fitness and the key for fat loss. When looking at body transformation, we need to look at fat loss over weight loss. Strength training ranks number one as the best way to lose fat. Here a few reasons why strength training is the best for fat lost:

- 1.Strength training promotes or maintains muscle tissue. It is important in training programs to maintain or promote muscle because muscle will burn more calories than fat. Muscle is constantly being broken down and rebuilt. It needs calories to rebuild and to create movement. Every kilogram of muscle burns approximately 10 calories a day. On the other hand, fat does not burn calories. Muscle tissue is like an oven that melts our fat away. With more muscle, a person will burn more calories throughout the course of the day and when they move.
- **2.** Strength training causes the afterburn effect or EPOC (Excess Post-Oxygen Consumption). After a person preforms strength training, they will continue to burn calories for as much as 38 hours post workout. Strength training elevates the metabolism during the training and maintains the elevated metabolism. Who would not like to keep burning calories while watching TV after a workout?
- **3.** Muscle also takes up less space than fat. The less fat and the more muscle tissue a person has will equate to smaller clothes and a smaller waist line. It is important that we measure our success by how our clothes are fitting and how we look in the mirror over what the scale shows.



My suggestion? Start a 2-3 day a week strength training program and stick to it. You'll see noticeable results in the first two weeks and even better results within 12 weeks. Visit Poarch Recreation to get a workout program that is best for you.

# **Benefits of a Food Diary**

Want to hear a secret? The majority of the successful nutrition and fat loss clients I work with keep a food diary. Why, you ask?

Because, bottom line, a food diary hold's you accountable for what you put in your mouth, which means less in-between meal snacking and less late night bingeing. This allows me the opportunity to access their compliance to the plan and adjust any areas that are deficient.

Another important aspect of food logging is increasing awareness around food choices; time of day and how emotional eating can sabotage weight loss intentions.

For me, I always tend to snack right when I get home from work and before dinner is ready. It's those sneaky times when calories can really add up. By keeping a food diary, I identify this habit and work to change it by having a healthy snack in the afternoon at work so I'm not as hungry when I get home.

Even clients that want to maintain weight or improve muscle mass benefit from recording their food choices, quantity and timing. It's a very realistic way to see if you're eating enough of the right types of foods that are going to support your goals.

Here are 5 tips for keeping a food log:

- 1. Write as you go. Don't wait until the end of the day to record what you ate and drank. Do it as soon as possible after eating.
- 2. Focus on portion size. You don't have to get too technical, but it can be helpful to get an idea of serving sizes. Practice at home with measuring cups, measuring spoons, or food scales. And be aware that people tend to underestimate how much food they're served.
- 3. Use whatever type of food diary works for you. It doesn't matter whether you use scrap paper, a smartphone app, or a notebook. What matters is that you use it.



- 4. **Don't skip your indulgent days.** Don't just keep a record on days when you eat well, but also on more liberal eating days. That way you can get a better idea of when/what you tend to eat and identify with the reasons behind less than ideal eating habits.
- Cook at home. You'll have more control over what you consume, and you know what that food contains, and how much of it you're eating. That makes for a more detailed entry in your food diary.

Regardless of what your health goals are, keeping a detailed food log can be the first step in long-term health. Reach out to me if you have any questions.







> many different retail and entertainment venues to support our economic growth at exit 57.




