Newsletter Information & Deadlines

The *Poarch Creek News* is the official newsletter of the Poarch Band of Creek Indians. The newsletter is furnished to Tribal Members, widows/widowers of deceased Tribal Members, Tribal entities, and representatives of agencies providing funding, i.e. IHS, NRCS, and official representatives of other Federally Recognized Indian Tribes at no cost. Non-Tribal Members interested in receiving the *Poarch Creek News* must pay an annual subscription fee.

The *Poarch Creek News* is generated on a monthly basis by the Government Relations Department of the Poarch Band of Creek Indians at the direction/discretion of the Tribal Council to provide important news, updates, and information to Tribal Members. ***We reserve the right to edit or refuse any item submitted for publication.***

The *Poarch Creek News* is generated one month prior to the month of publication. The deadline to submit information to be published in the newsletter is the 10th of the month prior to the month of publication. If the 10th falls on a weekend or

holiday, the deadline is extended to the next business day.

Due to space limitations, submitted articles should be limited to 500 words or less. Photos are limited to one photo per article submission. When forwarding a photo for publication in the newsletter, please be aware of the quality of the photo you are sending. We all want to look our best when we see ourselves in print! Over the past year we have received several photos that were of poor quality and did not publish well. If possible, do not use photos from a newspaper or magazine. If there is a photo in a newspaper or magazine that you would like to use, please contact the publication and ask them for a digital copy of the original. When using copiers or scanners to scan your photo, please check your settings. When using a scanner that gives you the option, please set the resolution at 300 pixels per inch. If all else fails, you can bring or send the original photo to the *Poarch Creek News*; it will be scanned, saved, and returned to you.

Submissions such as obituaries, birth announcements, wedding & engagement announcements, and birthday & anniversary wishes are limited to Tribal Members & spouses, First Generation & spouses, and those living in a Tribal Member household.

Obituaries/Family Thanks will be published if submitted by the last business day of the second month immediately following the death.

Birth Announcements will be published as long as the information is received by the last business day of the month immediately following the birth.

Engagement / Wedding Announcements will be published as long as the information is received by the last business day of the month immediately following the engagement/wedding.

Birthday & Anniversary Wishes may be published the month before, the month of, or the month after the birthday/anniversary. Birthday wishes are limited to 30 words or less, excluding name and birth date.

KEVIN MCGHEE, TRIBAL COUNCIL MEMBER

Kevin McGhee made his first step into the political arena when he submitted his Letter of Candidacy for the At-Large position on this year's Tribal Election Ballot. He received the majority votes for this position and was elected to a three year term. He was sworn in by Judge Joseph Brogden on June 6, 2013 and has been actively involved in the leadership of the Tribe as a part-time Council member since that time.

Kevin is the son of Shirley Von and Eldnar McGhee. He is a lifelong resident of the Poarch Community. His favorite childhood memories include playing with his cousins at his Granny's (Treacy McGhee) house. He is married to Tawana McDuffie McGhee; they have three daughters, Stacey, Courtney, and Kennedy, and one grandson, three year old Kaiden McDuffie. "Marrying my best friend is one of the greatest accomplishments of my life, followed by raising three beautiful daughters and discovering how the world changes for you in ways you never expect when you become a grandparent. Family is very important to me and is a major

priority of my life."

Kevin earned his BBA (Bachelor's Degree in Business Administration) from Faulkner University in 2012. He is employed with PCI Gaming at Wind Creek Casino as Entertainment Center Manager. Prior to going to work with PCI Gaming, he worked for the Tribe in the accounting field. He started as a Bookkeeper in Federal Accounting in 1996 and was employed as the Housing Accounting Director when he left to work for PCI Gaming.

Who has been the most influential person in Kevin's life and what is he most proud of as a Tribal Member? "My mother, Eldnar McGhee, has always been

the most influential person in my life, she has shown me you should always be loyal to, and care for, your family and community. I am proud to be a member of the Poarch Band of Creek Indians. I am proud of my native heritage and how our ancestors fought seemingly insurmountable odds to get us to where we are today."

Although this is Kevin's first term on the Council, he hopes it is not his last. It is his goal to serve his people for a long time and be instrumental in the future growth of the Tribe and addressing issues that affect the well-being and life of Tribal Members. "I have not been actively involved in Tribal politics for long, but my interest increases as our Tribe continues to grow. I feel that it is important for the younger Tribal generation to get more involved in today's leadership to continue our growth and success." When asked to compare the issues facing today's Council to those faced by previous Councils, he states "Today's issues have become more complex. Our current Council not only addresses Federal, State, and Local governmental issues, but also addresses the internal Tribal issues and concerns that increase as we grow."

Kevin has been appointed to serve on the Governmental Affairs Legislative Committee and the Budget/Finance Legislative Committee of the Tribal Council. The Governmental Affairs Legislative Committee addresses the Tribe's legal stance with the Federal, State, and Local governments; the Budget/Finance Legislative Committee is tasked with providing funding and programs to better the lives of Tribal Members.

Where does he see the Tribe in ten years and what would he be doing if not serving on the Council? "In ten years I see our Tribe as a profitable business that continues to provide better and more stable lives to all Tribal Members. If I were not serving on the Council, I would be making myself more knowledgeable of Tribal affairs with the goal of serving on the Council. I would continue my employment with PCI Gaming/

Wind Creek Casino so that I could better provide for my family and I would be continuing my education to obtain a Master's Degree."

TRIBE DONATES TO AREA ORGANIZATIONS

The Poarch Band of Creek Indians Tribal Council presented checks totaling \$150,000 to four organizations, as part of its planned giving campaign. These contributions will fund local healthcare and community services. The Tribe's contributions will help to balance funding cuts in organizations as varied as the D.W. McMillan Hospital, Mennonite Disaster Relief, Volunteers of America, and the Hannah Grace Foundation.

"One of the most important things we can do is give back to the community," said Tribal Chairman Buford L. Rolin, "It is important that we help these organizations, they do so much for so many by helping those in need and improving the lives of people in the community and our State."

The Tribe's donations include:

- \$50,000 to the Mennonite Disaster Relief.
- \$50,000 to the Volunteers of America.
- \$25,000 to the D.W. McMillan Hospital.
- \$25,000 to the Hannah Grace Foundation.

"Most all rural hospitals in Alabama are currently experiencing significant financial challenges. This gift from PCI will enable us to replace our mammography equipment with a new "state of the art" digital mammography machine," said Chris Griffin, D.W.

McMillan Memorial Hospital Administrator. "We are truly thankful for PCI's generosity and for their willingness to be a healthcare partner with us, as we work to improve our technology and ultimately the quality of care for our patients. With words and songs, videos and photographs, the congregation of Atmore First Assembly of God always presents a touching program near the Fourth of July. This year's Celebration of Freedom was presented Sunday, June 30. Each year, all branches of the military are honored. Active duty servicemen and servicewomen are honored. Veterans are honored. And always a few veterans are singled out and honored for their service. Among those honored this year were four Tribal Members, Alton Jackson, Larry Jackson, Lee Van Martin, and Willis McGhee.

Coxswain Alton Jackson (deceased), United States Navy, 1944-1946, USS Ransom / NRB Nola, World War II veteran. He received the Good Conduct Medal, American Area Campaign Ribbon, Asiatic Pacific Campaign Ribbon (two stars), Philippine Liberation Campaign Ribbon (one star), Navy Unit Commendation, WWII Victory Medal, and National Defense Medal. His plaque accepted by his grandson, Larry William Jackson.

Corporal Larry Jackson (deceased), United States Army, 1966-1969, Battery B – 6th Battalion, 8th Artillery – 5th Army, served in Korea. Corporal Jackson received the Good Conduct Medal, National Defense Service Medal, and American Defense Medal. His plaque accepted by his widow, Linda Jackson, and his son, Larry William Jackson.

Chief Warrant Officer IV Lee V.E. Martin (deceased), United States Army, 1953-1975, NATO Communication Management, North Atlantic Treaty Organization, Office of Deputy Director General, 3rd Armored Division. He received the Army Good Conduct Medal (three times), Army Commendation Medal (two times), Legion of Merit; Joint Service Commendation; Meritorious Service Medal, National Defense Medal, and Army WWII Occupation Medal. His plaque was accepted by his daughter, Pam Martin.

Private First Class Willis McGhee (deceased), United States Army, World War II veteran, 1942-1945, 231st Station Hospital. He received the Good Conduct Medal, National Defense Medal, American Defense Medal, and WWII Victory Medal. His plaque accepted by his son, Kent McGhee.

WILL MARTIN ATTENDS ASPIRNAUT PROGRAM

Seven students from the USET region are at Vanderbilt University Medical Center this summer working on research projects during the six week Aspirnaut program. This program allows students to work hand in hand with scientists and researchers at Vanderbilt University.

The students selected this year are Taloa Berg, Mississippi Band of Choctaw Indians; Nicodemus Bushyhead, Eastern Band of Cherokee Indians; Nicklaus Shumake, Mississippi Band of Choctaw Indians; Deon Denson, Mississippi Band of Choctaw Indians; Mack Lackey, Eastern Band of Cherokee Indians; Xan Sadongei, Eastern Band of Cherokee Indians; and Will Martin, Poarch Band of Creek Indians.

Taloa Berg and Nicodemus Bushyhead will be joining the Aspirnaut™ program for their second year. Last year they were part of the inaugural program, sponsored by USET. Taloa recently graduated from Choctaw Central High School and has been accepted to Vanderbilt as an undergraduate for the fall semester. Nicodemus is a rising senior at Cherokee High School.

The remaining five students will attend Aspirnaut™ for the first time. Deon Denson is a rising junior at Choctaw Central High School (Mississippi). Nicklaus Shumake will be a freshman at the University of Southern Mississippi this fall. Mack Lackey and Xan Sadongei are rising juniors at Cherokee High School (North Carolina). Will Martin is a rising sophomore at the University of Alabama.

Deon Denson is working on making a video to help prevent diabetes in American Indian Youth. "I am recording, taking pictures, and getting interviews of other teens. I am going to edit them and add sound tracks to it," Denson told USET about his work. Denson says he wants to attend Cornell University and study veterinary medicine. Coming from Mississippi to Nashville, Tennessee, Denson adds he feels right at home, "It didn't feel any different. I guess I am use to it. I don't know how, I didn't come from a big place, but I just feel use to it."

Denson is working hand in hand with some research being performed by Nicodemus Bushyhead, who is working

with ARC-GIS to plot data points on exercising while working in a human behavioral study lab at Vanderbilt. "We're doing work to see where you go and what you do (while exercising) and raise awareness to where people are attracted to exercising. In this way we can raise awareness of diabetes, the importance of exercising, and build models where people are attracted to being active," Bushyhead stated.

Nicodemus, while in his second year attending Aspirnaut, has become a leader among the attendees. "Maybe it's because I speak up more or the others know I have been here before," Bushyhead added. His career goal is to become a pharmacist and open a pharmacy in Cherokee.

Nicklaus Shumake is working on sequencing data out of collagen. Shumake will attend the University of Southern Mississippi this fall. Xan Sangonei told USET he would like to continue his studies after graduating Cherokee High School to pursue mechanical engineering. Taloa Berg says she will pursue an educational path to become a general practitioner physician. Mack Lackey, who will be a junior at Cherokee High School, wants to attend medical school. Will Martin, from Poarch Band of Creek Indians, is attending the University of Alabama and is working with fellow undergraduate research interns separate from high school students.

The Aspirnaut™ Program at Vanderbilt University (VU) is working to encourage young rural students to reach their dreams while giving them resources and real life experiences in Science, Technology, Engineering, and Math (STEM) fields so that they may pursue careers as doctors, engineers, telecommunication specialists, math teachers and professors, and other related STEM career areas. The program works to beam information, resources, and research back into rural classrooms so that it may involve younger students in elementary schools, high schools and collegiate undergraduates. Over 800 students have been recipients of online conferencing and virtual laboratories. The Aspirnaut™ program was started by Dr. Billy G. Hudson at Vanderbilt University Medical Center as part of a vision to educate and give advantages to rural students. Dr. Hudson's wife Dr. Julie

Hudson, Vanderbilt University Assistant Vice Chancellor for Health Affairs, has a hands-on working relationship with the Aspirnaut™ Program and works closely with the students. Dr. Julie Hudson told USET leadership, “We think that the partnership works well because it uses the assets of a research university and extends those to rural schools, rural teachers, and rural leaders in education.”

The Aspirnaut™ Program has collected data on all of its participants and monitored their progress after leaving the program. There have been no dropouts recorded among the 43 high school students that have participated in the last four summers. Twenty seven are seeking some form of post secondary training or are enrolled in college according to Dr. Hudson. Hudson adds, “All but one or two of the 27 in college are enrolled in a STEM related field of study.” Hudson says that the remaining 16 students are still in high school and engaging in advanced courses in math and science. “Our data is showing that students are making positive progress in the classroom and planning for education pathways past high school,” Hudson commented.

For several USET members the goal is to improve the standard of living. The Aspirnaut™ Program works to gather a diverse group of students and create unique approaches in seeking solutions for challenges in science. The students gain experience and possibly a new foothold in gaining acceptance to first rate universities. Dr. Hudson says the hope is that these students will go into a field of science. Regardless of the career pathway they choose, whether they become leaders, teachers, or administrators, they will have critical thinking skills, understand how to

influence lawmakers on funding innovations in science that will make positive affects in their community, and become positive role models for the future. Collectively, this translates into a growing and highly trained workforce for Tribal Nations.

USET Executive Director Kitcki Carroll echoes Hudson’s remarks saying, “We are most excited about what has occurred up to this point. The relationship USET has with Vanderbilt is so important because it is a critical component to our overall Tribal Nation rebuilding efforts. The educational opportunities for our younger generations are paramount to accomplishing our goals of rebuilding Indian Country. We must always remember, in our efforts to rebuild our communities, that it is going to take all kinds of skill sets, all sorts of expertise.”

USET President Brian Patterson told Tribal Leadership it must do everything it can to provide resources to USET Tribal youth. “We know when we invoke the power of a good mind in principle throughout our Nations that we do so with the future generations in mind. We do so while talking of the future seven generations. For the seven generations to meet their challenges, we must prepare our leaders of today. We must give them all the strength, all the courage, all the compassion that we can so they can advance their generation and future generations,” Patterson said.

I had the opportunity to move back to the Pensacola area this past spring and welcomed the opportunity to be closer to my childhood roots. Having lived away from our Tribal area for so long, I became one of those “outsiders,” or, as I read one council member state, a “non-Indian” type of member that focus’ on the “us” and “them” of membership. As our Tribe prospers, the comments seem to slant more and more towards the “why don’t they give us more,” mentality. Many of the thoughts are expressed without really knowing what the Tribe actually does for all members.

So, upon moving back, I had some pre-judged opinions about how the Poarch Community operates. My first real interaction with fellow tribal members came on this last Election Day. The open and friendly atmosphere made me truly proud to be a part of such a unique group of people. New to the area, I found employment opportunities disappointing but Rebecca Mills with the TERO Commission found a temporary spot on the grounds crew at Wind Creek Casino.

Thus began my true education of what our Poarch Community is really all about. I have never been exposed to the level of consideration from an employer that Supervisor Larry Ramer has for his crew. He and fellow Tribal member Mike Barnhill operate by showing a



true concern for treating all employees fairly and honestly by following Wind Creek management’s example. Leadman, Daniel “Boone” McGhee, showed me the onsite duties and gave a lesson on how the Poarch Community takes care of each other. “Boone” calls sick Tribal members and all visitors to our casino were greeted with a friendly wave and smile. He is also an integral part of our stomp dancing tradition.

Perhaps the most important role of Larry Ramer is the direct supervision of a crew made up of over 75% Tribal members and First Generation employees. According to our 2011 annual report, Wind Creek itself has just over 21% Tribal member and First Generation members. The grounds crew is giving our younger members the opportunity to learn the value of good-old fashioned hard work. Older members such as “Boone” McGhee give an example of how our elders can pass on their life-gained skills to our youth.

Our Poarch Community is so much more than “us” and “them.” I am learning that our Community is all about helping all members to obtain a better life by giving opportunities our ancestors never received. If you have the chance, get involved with our Tribe. You will see that the gift of giving is much more fulfilling than the greed of need.

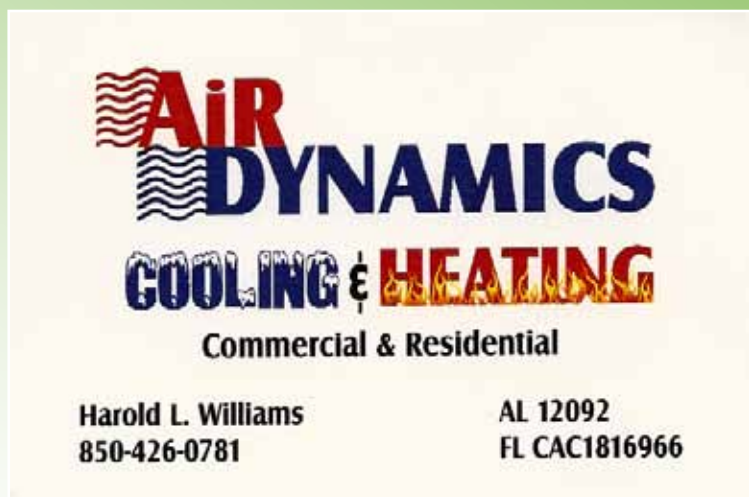

Strength Training Tips for Women

This article focuses on strength training for the ladies.

Strength training is important for women as it promotes fat loss, maintains bone mass, and increases metabolism.

But just what is *strength training*? The meaning of strength training is: *movement against a force*. When we perform movements in strength training exercises, we are increasing our metabolism and developing an oven to burn our fat. Strength training can come in many different forms: body weight exercises, exercise bands, weight lifting, suspension training, and kettlebells – just to name a few. Strength training is any sort of movement where your body is resisting a force.

Now, let's look at a few tips for women while strength training:

1. Make your lift worthwhile. Many women make the mistake of targeting small muscle groups or the area they want to tone up, but if you want to get quick results, my suggestion is to implement big money exercises into your routines like squats, deadlifts, push-ups and assisted pull-ups. You will tone up multiple muscle groups while losing fat quickly.
2. Forget crunches on the floor. Lying on the hard ground and doing crunches will not give you the nice flat stomach that you strive to have. Your flat stomach will come from doing full body strength training, high intensity interval training, and eating right.
3. Lift Three Days a Week. Over the years, I've seen many women spending their time doing cardio only workouts, as much as three days a week for up to 50 minutes each session – AND they get frustrated with the results they are getting. When I switch them to three days a week of strength training – for only 30 minutes – their bodies transform almost overnight. Three days a week of strength training will get you the results that you want in the least amount of time. Try it. You'll like the results. I guarantee it.



4. Nutrition. Eating correctly will help you get the most out of your training and help you achieve the goals you want. Remember "you can't out run the fork." Your daily nutrition should incorporate lean proteins, fruits, vegetables and water – taking into account portion control. Making smart food choices will help your body recover from your strength training and give you a sustained energy level throughout the day. And if you're like me – you need all the energy you can get to accomplish your daily tasks with a smile.

5 Quick Tips for Eating More Fruits and Veggies

I often find that people aren't eating

enough fruits and vegetables throughout the day, which can have a huge impact on the ability to lose body fat, gain muscle mass and optimize digestion. Additionally, the majority of the "veggies" that most American's are eating are French fries and ketchup – hardly a healthy vegetable choice. Therefore, I'm offering some quick and easy nutrition tips for you:

1. Keep fruit where you can see it – you're more likely to eat it if it's out on the counter or in the front of the fridge as opposed to hiding it in a drawer or cabinet.

2. Pick out a new vegetable every time you go shopping and plan to use it in a recipe. After all, variety is the spice of life. Often times the best tasting and cheapest fruits and veggies are whatever is "in-season". August happens to be full of fresh and tasty seasonal fruits and veggies, some of which are cucumbers, chilies, avocado's, cilantro, boysenberries, blackberries, cherries, eggplant and blueberries – which are my favorite!

3. Bag the potatoes – choose more leafy green and low starch vegetables for slower digestion, less calories and more nutrition. Examples would be large greens salads with fresh cherry tomatoes and shredded carrots or simply some steamed broccoli with butter.

4. Get some vegetables every meal, every day – try filling half your plate with veggies at every meal. Base your meals around lots of colorful veggies. Snack on fruits in between meals. Adding vegetables to every meal will ensure you're getting enough "bulk" in your diet, which helps with digestion and plenty of good nutrition.

Go ahead and head over to your local grocery store and shop the perimeter for local and in-season fruits and veggies to spice up your meals. Your wallet and your waistline will thank you.

Community Services Child Care Program

Lena White is the Family Services Department Child Care Coordinator. She provides intake services for applicants seeking assistance with paying childcare or afterschool services for their PCI Tribal Member child or for their PCI First Generation Indian Descent child. There are two childcare programs provided through the Family Services Department including a federally-funded program: Child Care and Development Fund (CCDF); and a tribally-funded program: Tribal Child Care Program (TCCP). The federally-funded CCDF program is available to tribal member families living within the Tribe's service area and is based upon the income of the household. **The tribally-funded TCCP program is for families exceeding the CCDF income guidelines and who live in the Tribe's service area; or for those tribal families who live outside of the Tribe's services area.**

Attention: Program Participants in the CCDF and Tribal Child Care Program

Child Care Renewals are DUE by September 13, 2013

The Family Services Department will begin taking applications on September 1, 2013 for families who are currently participating in CCDF or in the Tribal Child Care program, or who are families needing assistance with daycare services. The new fiscal year and certification period will begin on October 1, 2013 and end September 30, 2014.

Current participants and new applicants must:

- *Schedule an appointment with the Community Services Child Care Coordinator and complete a new, current application. Please call (251)-368-9136, ext. 2600 to set up your appointment time.*
- *BOTH parents must be able to provide documentation verifying they are both working a minimum of 20 hours per week or are attending at least 20 hours in an educational training program or a job training program.*
- *Provide documents to verify the household income.*

- *Provide copies of Tribal I.D. for Tribal Members or Letters of Indian Descent for First Generation Children.*

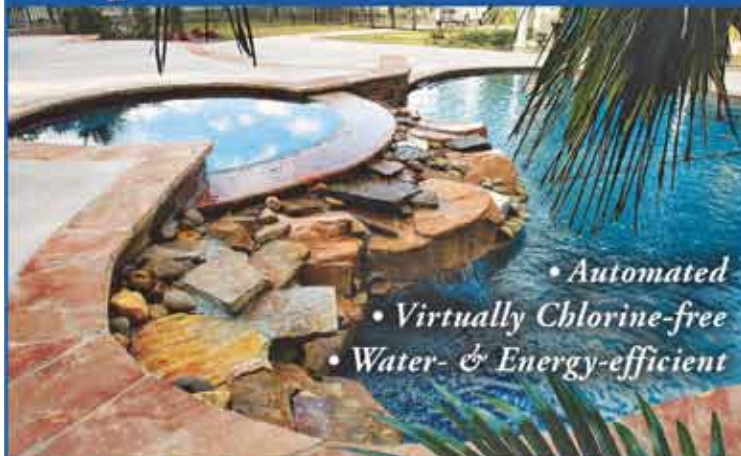

Children's Services for Fall 2013

After School Tutoring After school tutoring will begin **Monday, September 23, 2013**. The After School tutoring program is available to all eligible Tribal Member and 1st Generation students in grades 1-6 who have a C or below on their Report Card/Progress Report or the recommendation of a teacher.

Homework Club The Homework Club is an all-around academic program that offers tutoring services, homework help, computer lab usage, and special project help to Tribal Members and 1st Generation students in grades 1- 12. Homework Club hours are offered from 5:00-7:30 p.m., Monday-Thursday during the school year and will begin on **Monday, August 19, 2013**.

PLATO The PLATO program is available to 3rd grade through Adult. It is an online program that encompasses all academic areas including math, reading, english, science, history and many more. PLATO provides an individualized experience that includes pre-tests and post-tests in your student's area of study, including tutorials and examples. This program is available throughout the year and can be accessed from a home computer or any device with Internet access.

Close Up The Close Up program is a week long look at political life in Washington D.C. Selected students will be in the 9th-12th grade and must be 15 years old at the time of application. Applications will be made available beginning **August 1, 2013** and will be posted to the Tribe's website and/or you can pick one up at the PCI Education Department.

4-H The 4-H program features two monthly meetings with an emphasis on "learning by doing". Meetings are held on the 2nd and 4th Monday of each month with special field trips included. A 4-H Steer Show program is in the works and will be available for interested 4-H'ers to participate in beginning in August, 2013.

LEGAL UPDATE

Significant Tribal Legislation

Enrollment Code

The Tribal Council approved amendments to the Enrollment Code on June 20, 2013. Prior to the revisions, DNA testing may have been used as part of the investigation of a disenrollment report. The revisions remove DNA testing as part of the investigative process. Instead, the investigator of the disenrollment report is now required to schedule a meeting with the Tribal Member Respondent to review the findings from the investigation and allow the Tribal Member Respondent thirty (30) days to submit additional evidence to refute the findings. This additional evidence may be, but is not required to be, DNA evidence. Because mandatory participation in DNA testing during a disenrollment investigation is no longer required, the Tribal Council may issue sanctions only in the event of disenrollment claims made in bad faith.

State of Alabama v. PCI Gaming Authority et al. (Federal Court)

On February 19, 2013, the Alabama Attorney General on behalf of the State of Alabama filed a complaint against PCI Gaming Authority, individual Tribal Council members, and individual PCI Gaming Authority Board members (hereinafter collectively referred to as the “Tribe”) in the Circuit Court of Elmore County, Alabama. The suit alleges that the Tribe’s gaming activities are public nuisances and seeks to prohibit gaming on the Tribe’s trust lands.

The Tribe removed the State’s complaint to federal court on March 21, 2013, and filed a motion to dismiss the complaint on March 28, 2013. The State then amended its complaint in federal court to include both a state public nuisance claim and a federal public nuisance claim. The Tribe filed a motion to dismiss the amended complaint on May 9, 2013. The State filed a response on June 4, 2013, and the United States filed an amicus brief in support of the Tribe’s motion to dismiss two days later. The State of Michigan filed an amicus brief in support of the State of Alabama’s position on July 3, 2013. The Tribe will be filing a consolidated reply in support of its motion to dismiss on July 22, 2013.

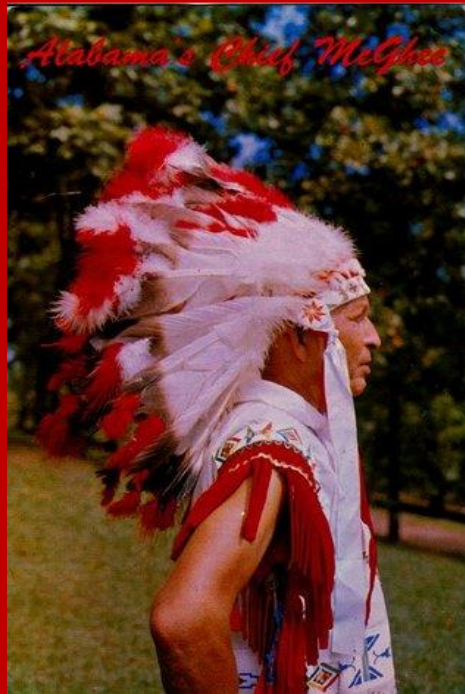
