Newsletter Information & Deadlines

The Poarch Creek News is the official newsletter of the Poarch Band of Creek Indians. The newsletter is furnished to Tribal Members, widows/widowers of deceased Tribal Members, Tribal entities, and representatives of agencies providing funding, i.e. IHS, NRCS, and official representatives of other Federally Recognized Indian Tribes at no cost. Non-Tribal Members interested in receiving the Poarch Creek News must pay an annual subscription fee.

The *Poarch Creek News* is generated one month prior to the month of publication. The deadline to submit information to be published in the newsletter is the 10th of the month prior to the month of publication. If the 10th falls on a weekend or holiday, the deadline is extended to the next business day.

Due to space limitations, submitted articles should be limited to 500 words or less. Photos are limited to one photo per article submission. When forwarding a photo for

publication in the newsletter, please be aware of the quality of the photo you are sending. We all want to look our best when we see ourselves in print! Over the past year we have received several photos that were of poor quality and did not publish well. If possible, do not use photos from a newspaper or magazine. If there is a photo in a newspaper or magazine that you would like to use, please contact the publication and ask them for a digital copy of the original. When using copiers or scanners to scan your photo, please check your settings. When using a scanner that gives you the option, please set the resolution at 300 pixels per inch. If all else fails, you can bring or send the original photo to the Poarch Creek News; it will be scanned, saved, and returned to you.

Submissions such as obituaries, birth announcements, wedding & engagement announcements, and birthday & anniversary wishes

are limited to Tribal Members & spouses, First Generation & spouses, and those living in a Tribal Member household.

Obituaries/Family Thanks will be published if submitted by the last business day of the <u>second month</u> immediately following the death.

Birth Announcements will be published as long as the information is received by the last business day of the month immediately following the birth.

Engagement/Wedding Announcements will be published as long as the information is received by the last business day of the month immediately following the engagement/wedding.

Birthday & Anniversary Wishes may be published the month before, the month of, or the month after the birthday/anniversary. Birthday wishes are limited to 30 words or less, excluding name and birth date.

Effective January 1, 2014, the official Tribal web site, www.pci-nsn.gov, will host a *Tribal Members Only Portal (TMOP)* for Tribal Members age 18 and above wherein confidential information will be posted. The portal will be located on the left-hand sidebar of the web site's home page.

You may initially access the TMOP by using an established username and password that will be provided to you prior to January 1st. Once you log on for the first time, you will be given the option to create your individual username and/or password.

We will need your correct contact information to set up the TMOP ID. We have access to Tribal Member names and roll numbers, but must have a valid email address to complete the TMOP identification process. If you do not have an email address and would like assistance in setting up a free GMAIL account, please let us know. To establish a TMOP account, please forward the following information to info@pci-nsn.gov:

Please know that the TMOP will not be an automated site; it will be up to individual users to resolve issues they have if they are unable to login to the Tribal Members Portal. We will be unable to provide assistance beyond confirming that you have the correct username and password to access this area of our website. Confirmation of correct username and password may take up to 24 hours.

Whether you are carving the turkey, enjoying the annual Pow Wow festivities, or shopping for the perfect gift for your loved one, I encourage you to take a moment and reflect on the previous years' many blessings. The Poarch Creek Indians have been very fortunate and greatly blessed over the years; and this past year was no exception. God has truly been so good to us. And though we have come far from those days of cooking chicken dinners to send Chief Calvin to D.C., we should never forget about our humble beginnings; those meager beginnings are part and parcel of who we are as the Poarch Band of Creek Indians: a persevering, tenacious people.

It makes me so happy to know that, through the decisions of the Tribal Council and the successes of the various Tribal entities, we are able to provide you, our Tribal Members, with many benefits that positively impact your quality of life. For example:

- In 2005, per capita "birthday checks" were first distributed in the amount of \$100. This year's total per capita distribution is \$18,450.
- Tribal Members are eligible for health insurance coverage (if uninsured) or a flex card (if insured).
- The education program provides



Stephanie Bryan, Vice Chair an allotment of up to \$100,000 for Tribal Members to acquire an education. To help ease the burden on the Tribal Member's household an education benefit is also extended to First Generation Indian Descendants up to \$40,000.

- The housing opportunities available to Tribal Members continue to expand with the addition of housing subdivisions, home rehabilitation programs, and various home ownership programs.
- Our newest construction endeavors are slated to open at the end of 2013 through the first quarter of 2014 and include the following:
 - o Health Clinic
 - o Assisted Living Facility
 - o SAIL Center
 - o Entertainment District at Wind Creek Atmore
 - o Wind Creek Wetumpka

As your Tribal Vice-Chair, I thank you for the opportunity that you have given me to serve you, the People; it is my utmost honor and privilege to do so. I assure you that this responsibility has not been taken lightly. I may not always make a decision that you agree with, but I promise you that the decisions I make are made with the best interests of the Tribe in mind.

My prayer for each of you is that you will have a joyous holiday season filled with laughter and love. The New Year is upon us, and with it brings continued prosperity for the Tribe. The year 2014 will certainly bring positive opportunities for all Tribal Members.

2013 WALK OF LIFE - THE WALK FROM TUSCUMBIA LANDING

The 2013 Walk of Life began at Tuscumbia Landing. This is a memorial that remembers and honors the Native American that were forcibly removed in the 1830's ...from Tuscumbia Landing. This Walk was the 11th year and Robert Thrower of the Poarch Creek Band of Atmore, Alabama has made each Walk. He is a traditional medicine man and told the crowd why we are here and left a feather tied in a tree. The friendly winds will blow it here and there for all to see in the next year. Curious ones will ask about the feather and we can explain it's a remembrance to honor the elders.

Before we walked, someone asked for a show of hands of newcomers. About half the crowd held up their hands; some came from as far away as Canada. This day was also the annual meeting of the Natchez Trace Parkway Association and some of members walked with us.

The City of Sheffield owns the land but the Walk follows the old Tuscumbia railroad 2.2 miles and ending as a celebration at the Oka Kapassa Festival in Spring Park, Tuscumbia. This year the entourage was followed by two shuttles and Sheffield's fire engine to provide first aid. None was needed. Because Colbert County used to be Chickasaw Homelands, the Chickasaws led the throng with elder Rose Jefferson out front. Each year something different seems to happen all by itself. This year a Choctaw brought his drum. He explained his drum song gathered people for all occasions. The drum set the pace that included John and Shelia Baker, two descendants of the Chickasaw Colberts. John carried a brand new infant on the walk in its "cradleboard."

After stopping at the halfway point to be served cold water by the area Cub Scouts, Rose Jefferson led the walkers into the Spring Park Arena. The Chickasaw musicians "Ingenuity" were playing their rendition of a Trail of Tears song. The Chickasaws then sang Amazing Grace in the Choctaw language and everyone in the park joined in English. Lastly, the Choctaw drum group singers sang their Choctaw Removal song. The tribal groups offered their ideas to make this celebration great.

The Walk of Life was powerful and inspiring and will continue to bring back the Native People each year to experience the famous hospitality of Tuscumbia, as well as bring attention to Tuscumbia Landing.

ATTENTION TRIBAL MEMBER HUNTERS-UPDATED

The Land and Natural Resources Legislative Committee announces the following:

- Hunting on Tribal Lands is open to Tribal Members and members of their household only.
- All State of Alabama rules and Poarch Band of Creek Indians (PBCI) Hunting Policy rules will apply at all times, there will be no exceptions.
- Tribal Hunting License requires the purchase of an Alabama Hunting License; cost is in addition to Tribal Hunting Licence fees.
- Tribal Hunting License fee: \$300.00
- Regular sign up: September 20, 2013 through November 30, 2013. A \$100 late fee will be applied to all licenses purchased after November 30, 2013.
- Tribal Hunting License fees will be accepted at the Tribal Government Accounting Department, Building 200, during normal business hours.
- A complete copy of the PBCI Hunting Policy and a calendar of dog hunting days will be given to hunters when dues are paid.

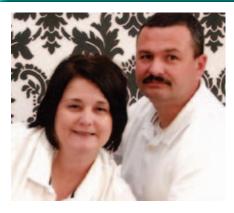

My title has changed to Patient Account Specialists working under Ms. Teresa Smith, Business Office Director. I really love my job here. I can help each tribal member as a whole. Here

I try to treat each and everyone the same. I am thankful for working in Contract Health. Here we send patients to outside providers. We pay the bill in a timely manner. If you get a bill from an outside provider, and you had a referral or a 72 hour notification please bring the bill into our office so we can process it. A lot of time we do not get the bill, the patient does and that is why it is important to know if there is an outstanding balance. I am thankful for my parents, William L. (Shorty) and Ruth Pierce Walker for what they taught me as a person and mother for support in getting my degree from college. If it was not for Selzer, and the boys behind me, my brother and my sisters and Poarch Creek, I would of not had the opportunity to serve you. So my best advice to you is to reach for your dream, no matter what anyone says - You can make it. I would like to take this opportunity to thank the Poarch Band of Creek Indians Tribe and their entire medical staff for everything they have done for me in the past year. I am very proud to be a Poarch Creek Indian and feel blessed to know how hard our Tribe works to take care of each and

every one of us.

In May of this year I was faced with a serious health issue. I was in a lot of pain and had major problems walking any distance. After several visits to "Doc" (Dr. Parker Estovold), and many tests and x-rays, I was referred to a vascular surgeon. The very first visit to Dr. Layne Yohiero, I was told what my problem was and that it could be fixed. A CT scan proved Doc's original suspicions. I had major

blockages. I had surgery at Baptist Hospital in Pensacola in mid-June. Dr. Yohireo placed stents in my groin area on both sides. It was like a miracle. Shortly after, and until today, I can walk miles with no leg or hip pain.

I work for CIEDA in the Maintenance Department and do have my own insurance. However, without our Tribe's help in taking care of all my out of pocket expenses (that my insurance did not cover), I would be in a financial bind today. The Tribe has offered to help me with my house payments by deferring my notes, which I declined. I was only out of work for three weeks and did not need this as I had time built up at work to get paid for my time off.

I get very upset when people here take our Tribe and what they do for us for granted. I am very proud of my heritage and our Tribe. I am also glad to have my job at CIEDA (5 years) and the opportunity to serve my Tribe. With our combined efforts and our Tribe we can do anything.

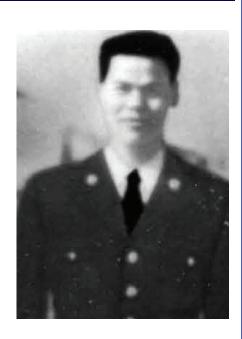

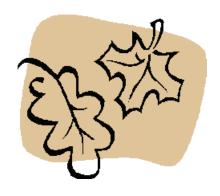

The Fall 2013 session of National Tribal Gaming Commissioners and Regulators (NTGC/R) was recently held September 17- 21, 2013 in Cherokee, NC. PCI Tribal Gaming Commissioners and staff have been attending this semi- annual event consistently for the past 6 years. The PCI TGC has been a member of NTGC/R for the past 5 years.

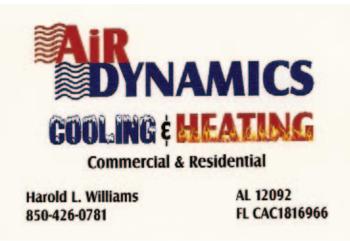
NTGC/R's purpose is to provide an atmosphere for Tribal Gaming regulators to meet, network, and share information in the ever-changing atmosphere of Indian Gaming Regulation. The 3 day conference was broken down into sessions appealing to all aspects of Indian Gaming regulation. This year's sessions included tracts specific to Commission, New Commissioners, Information Technology, Auditing, and Investigation/ Surveillance. The individual tracts featured lectures, training, and roundtable discussions from seasoned Indian Gaming professionals specific to each of the 5 above referenced categories. In addition to the training and networking opportunities, the event also included an update from National Indian Gaming Commission (NIGC) Chair Tracey Stevens and National Indian Gaming Authority Chair Ernie Stevens.

First time attendee and TGC lead gaming agent Carla Hammonds remarked that "NTGC/R was one of the best trainings that I have attended since being with the TGC. The information presented was very informative and especially interesting finding how other Compliance departments operate within their respective TGC's."

The next session of NTGC/R will be held in the Spring of 2014.

YOU CAN'T LOSE IF YOU DON'T SNOOZE!

On average, we are not getting enough

sleep. In fact, sleep experts suggest that Americans today sleep one hour less per night than we did just 20 to 30 years ago. Getting enough sleep is vital to our overall health. Not only is getting enough sleep vital to our overall health, it is needed to stay energetic. Did you know that sleep is the most effective way to lose weight, heal sore muscles, balance hormones, and perform optimally?

To improve sleep quality, people can make simple changes to their nightly routine or habits:

Dissecting Poor Sleeping Habits

1. Getting to bed too late.

A majority of our energy and sleep hormones are produced in tune with the cycle of the sun. Our bodies are designed to slow down from sunset until about 10:00 p.m. Physical repair takes place from around 10pm to 2am and psychogenic (mental) repair takes place from around 2:00 a.m. to 6:00 a.m. This means you must be asleep by 10pm most nights.

- 2. Poor nutrition, excessive caffeine usage and increased environmental and emotional stresses. These factors can affect our body's ability to turn on and off hormones that dictate the desire to either sleep or wake-up. Having altered hormonal rhythms during the day and night can cause poor sleep quality. Some examples of poor sleep quality are frequently waking during the night and being restless in sleep. When we do not sleep well, we have less energy and have less focus during the day. Thus it is importance to have a healthy lifestyle to promote a better quality of sleep.
- 3. Getting less than 8 hours of sleep on a regular basis. Some would suggest that our bodies are fundamentally the same as those of our ancestors. Therefore, if humans used to sleep 9-12 hours per night, then one could conclude that we need the same amount of sleep as they did back then. If you want to lose weight, feel better, look better and perform better, then figure out how to get to bed by 9 or 10pm. It's as simple as that.
- **4.** Waking up to go to work or train before 4am. Given that we need at least 8 hours of sleep each night, a 4am wake-up would require going to bed by 8pm the night before.



For many people this is unrealistic. The best solution is to get to bed by 10pm and sleep till 6am, however, if an early rise is a must, then you need to do whatever it takes to get in your 8 hours.

5. Using your cell phone, computer or watching television right before bedtime.

Exposure to bright light late into the evening can lead to a feeling of grogginess in the morning as well as the desire to hit the snooze button. Remedy this by limiting bright light exposure at least 1-2 hours prior to your desired bedtime.

Foam Rolling and its Many Benefits

Foam rolling is an important factor in training that is often overlooked. Foam rolling is using a 6" diameter and 3' foot long piece of foam and rolling your muscles on it. This practice of rolling your muscles has evolved into a huge part of training and has numerous benefits. Foam rolling has shown to improve the range of motion of joints; it allows the body to recover quickly from workouts, helps to avoid workout related injuries and improves overall performance in workouts.

Foam rolling increases the range of motion of joints in numerous ways:

- 1. It allows for the myofascial release of connective tissue. Myofascial tissue is a tough webbing of connective tissue that surrounds our muscles, protecting them, and allowing our muscles to stretch safely. However, this tissue can become tight and prevent movement from occurring. Foam rolling allows this tissue to release and thus the muscles will be able to move properly. A person should think of foam rolling as removing knots from a rope. When we take the knots out of the rope, the rope will begin to be stretched to its full length. It is important to foam roll before training and stretching exercises are performed, because it will allow you to get the maximum results you desire.
- 2. It facilitates recovery between workouts. Foam rolling increases blood flow to muscle tissue, which is vital for muscular recovery. The new blood coming into the muscles will bring the nutrients needed to repair the damaged tissue and flush out any bad bi-products. It is important that we focus as much on recovery between workouts as we do on the training. Our training is only as good as our recovery.
- 3. It can also increase our performance ability. By foam rolling, we allow ourselves to move better. As a result of having better movement, we will be able to train longer, harder and not break down as much. In other words, it will allow us to become more resilient! Being more resilient means a much lower chance of injury. If we can train longer, harder, and create injury avoidance, we will be able to lose body fat quicker and achiever our goals much faster.



No matter what your fitness goals are, it should be a goal to foam roll before every workout (daily if possible). You will see a big change in your joints' range of motion, increased performance, and a quicker recovery from workouts. The importance of recovery from a workout cannot be stressed enough. Having flexibility in your muscles will help to prevent serious injuries.

Foam rollers are available at Poarch Recreation. Give it a try! It might be the new thing that gives you the edge you've been looking for!

CHANGES TO MCGHEE-TULLIS TUITION ASSISTANCE PROGRAM

Please be advised that as of *August 1, 2013*, the Tribal Council of the Poarch Creek Indians approved revisions to the McGhee-Tullis Tuition Assistance Program. If you are currently participating in or plan to participate in this program, it is **VERY IMPORTANT** you read the entire policy to find out how the following revisions will affect you. Major policy changes include:

- Program eligibility age changed from ten (10) to four (4).
- Homeschooling under the guidance of a recognized umbrella organization now eligible for participation in the program.
- Elementary and Secondary students who are placed on academic probation by the Education Department will be required to attend tutoring sessions.
- For a loan to be repaid, the Tribal Member must complete the degree that the loan was used to finance, or if a Tribal Member did not complete a degree but completed an equivalent or higher educational level after the date of the loan, then the Tribal Member's loans may be repaid.
- Student loan repayment will now be made at one time up to a student's total limit.
- Students shall submit a written request for his or her academic achievement bonus and a final transcript within six (6) month of graduation.
- Cash awards for the academic achievement bonus shall be paid only upon graduation.

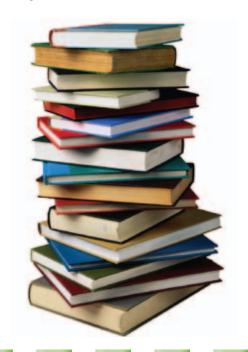

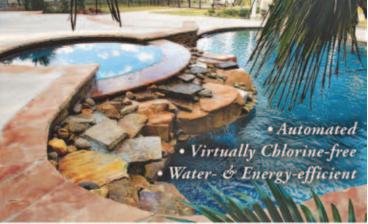

In retrospect to the upcoming Evening with the Elders, we share an article first published in the November 2011 issue of the *PCI Insider*.

The Archives speak about Great Grandfather Levi McGhee

"He just got behind it and kept a shoving it, shoving it, till he got as far as he did," Levi McGhee said about Chief Calvin McGhee. Levi McGhee's great grandson Travis Smith read these words of his great grandfather for the first time in the Office of Archives and Records Management.

Smith started working for the Poarch Band of Creek Indians Tribal Archivist Dr. Deidra Suwanee Dees on July 7, 2011 as a summer intern in the Youth Leadership Program. "As I was cleaning old documents for Dr. Dees, I came across an article about my great grandfather, Levi McGhee," Smith said. He had been interviewed along with his wife Treacy McGhee by Dr. Anthony Paredes in 1973. Smith observed that the interview had been "made with them on August 22,

1973, one day after Levi's 78th birthday. Levi was born on August 21, 1895," Smith said.

Travis Smith found it interesting to read Levi's recollections of Chief Calvin McGhee. Levi McGhee is the older brother of Chief McGhee. When Levi was asked about Calvin McGhee and his childhood, Levi said that Chief McGhee wasn't always the man he grew up to be, but when Chief McGhee was introduced to the holiness church, he began to change. Levi said that Chief McGhee saw the way the Indians were being treated and was not happy with it. This was the beginning of Calvin McGhee's journey to improve the way of life for the future Poarch Band of Creek Indians. Chief McGhee led the Creeks to organize ourselves into a viable political voice that reached all the way to Washington D.C. "While reading the interview," Smith said, "it seemed like I took a step back into the past. Levi and Treacy lived in the Hog Fork area, where they raised their 11 girls and 2 boys. As a child, Levi and his father worked with cattle. He and his father would 'pen 'em, mark them up, and brand them.' After they branded the

cattle, they would let them loose in the woods. 'When the big fellas got ready to sell them, they would take the ox and steers out at auctions,'" Smith said quoting his great grandfather.

Smith compared the work that Levi McGhee did with the kind of work that people do today. "We had wagons, and horses, and things like that. Sometimes walk." McGhee said. "When I read this I realized that it wasn't easy back then," Smith said. "I wouldn't dare walk from Poarch to town now but that was all Levi knew to do when he was growing up. He would walk if no car. He didn't really have a choice."

Smith was amazed that the interview documented "Levi at 83 years of age plowing his two acre garden with his mule named 'Kit." How many Creeks are plowing in an air-conditioned cab of the tractor at age 83 today?

Travis Smith grew up in Poarch not too far from where his grandfather grew up but his family did not tell him any stories about Levi McGhee, he said. Everything he learned about him came from this interview. Smith asked his mother about his great grandfather once he found the interview. His mother, Teresa Smith, is the Business Office Director in the Administration Health Department at the Poarch Band of Creek Indians. Smith said his mother told him about her mother working with Levi in fields. "My mother said her mother Eldnar McGhee had to help Levi in fields. They would pull weeds." Levi only made it to the fourth grade because his family needed him to work in the fields.

Smith said he found it interesting to come to know his great grandfather through the archives. It was also "interesting to see all the old letters and envelopes, old documents, how they survived all these years." He recognized the important work that goes into saving documents that tell people about our tribal history. If someone had not preserved these

documents, Travis Smith would not have been able to learn about his great grandfather and his way of life in the Hog Fork community. But because these documents were preserved, the legacy of Levi McGhee lives on in the Office of Archives and Records Management and in the Poarch Creek community.

Long Forgotten Tribal Council Minutes in the Archives!

Look what we found in the archives: long forgotten Tribal Council Minutes from the 1960s! These exciting documents were found in boxes in the Gail Thrower Collection at the Office of Archives and Records Management which moved to the CIE building at 100 Brookwood Road in September. Tribal Archivist Dr. Deidra Suwanee Dees and Records Coordinator Mrs. Ellen O'Barr invite you to come to the archives and take a look at these wonderful documents which help tell the story about tribal history.

Dr. Dees and Mrs. O'Barr are working with TERO workers Ms. Delores Kelley and Ms. Eldnar McGhee, and University of South Alabama interns Mr. Travis James Knee and Ms. Olivia Perry on processing our archival collections. This work has led to the rediscovery of many rare and treasured records that give us insight into the past. For example, on September 11, 1965, in beautiful handwriting that may be attributed to Buford Rolin, the Minutes state that "Chief Calvin McGhee called a Council meeting at the home of Mr. and Mrs. Curtis McGhee at 7:00 p.m." The writer says, "All old Council members that were present was Arthur Reed, John Phillips, Dave Presley, Leola Macac, Roberta Sells, Perloca Linton, Bertha Dickinson, Jessie C. Turner."

What type of business was the Tribal Council addressing at this meeting? You are invited to come by the Office of Archives and Records Management to
