The *Poarch Creek News* is generated one month prior to the month of publication. The deadline to submit information to be published in the newsletter is the 5th of the month prior to the month of publication. If the 5th falls on a weekend or holiday, the deadline is extended to the next business day.

We reserve the right to edit or refuse any item submitted for publication.

The *Poarch Creek News* is generated on a monthly basis by the Government Relations Department of the Poarch Band of Creek Indians at the direction/discretion of the Tribal Council to provide important news, updates, and information to Tribal Members; information and decisions that have been made by the Tribal Council, Authorities, Commissions and Tribal Government Departments.

It is also a place where Tribal Members can submit information celebrating their loved one's birthdays, births, and marriage announcements along with other achievements and accomplishments.

It is not the forum where individual Tribal Members can submit their personal views regarding matters of operations of Tribal Government or decisions or policies enacted by Tribal Council, Authorities and/or Boards.

The *Poarch Creek News* is not the

vehicle to submit policies issues/concerns by individual Tribal Members and/or groups.

The newsletter is furnished to the Head of Household of all Tribal Member homes, widows/widowers of deceased Tribal Members, and Tribal entities at no cost. Non-Tribal Members, including first Generation Descendants, interested in receiving the *Poarch Creek News* must pay an annual subscription fee.

Due to space limitations, submitted articles should be limited to 500 words or less. Photos are limited to one photo per article submission.

When forwarding a photo for publication in the newsletter, please be aware of the quality of the photo you are sending. Please submit in PDF or .jpg format; please set the resolution of .jpg to 300 pixels per inch. Original photos may be brought in or sent to the *Poarch Creek News*; photos will be scanned, saved, and returned.

Submissions are limited to information pertaining to, or of interest to, Tribal Members & spouses, First Generation & spouses, and those living in a Tribal Member household.

Obituaries/Family Thanks will be published if submitted by the last business day of the second month immediately following the death.

In Loving Memory submissions may be published the month before, the month of, or the month after the birthday of the deceased or the anniversary of the death of the deceased.

Birth Announcements will be published as long as the information is received by the last business day of the month immediately following the birth.

Engagement / Wedding Announcements will be published as long as the information is received by the last business day of the month immediately following the engagement/wedding.

Birthday & Anniversary Wishes may be published the month before, the month of, or the month after the birthday/anniversary. Birthday wishes are limited to 30 words or less, excluding name and birth date in the title of the birthday wish.

Thank you all so much for casting your vote for the candidates of your choice and allowing your voice to be heard. June's election was a historical event for our Tribe. We had record-breaking numbers at the polls and I was honored to become the first female elected as Tribal Chair in Poarch Creek history. When my name was announced, my immediate reaction was tears of joy and an immense feeling of humbleness. I feel truly blessed to have the opportunity to serve my people in this capacity and to know that you have put your confidence in my leadership abilities.

Furthermore, witnessing other women stepping into both Tribal and non-Tribal leadership roles was certainly encouraging for me in my decision to campaign for the Chair position.

I am humbled to be the first woman in our Tribe's history to be elected as the Tribal Chair. The Mvskoke (Creek) people are traditionally a matrilineal society and hold great respect for women. I hope to be a worthy role model for the youth of our Tribe, especially our young ladies. I pray that our younger generation will truly grasp the realization that each of them is capable of doing whatever they desire to do

regardless of gender.

The Poarch Creek Indians have grown by leaps and bounds over the last decade. Truly, the sky is the limit for our Tribe as long as we remain a unified and humble people. I strive to continuously improve the quality of life for my constituents. As a leader, there is no better feeling than to know I have been part of a decision that positively affects the quality of life for my people. I am ecstatic and eager to embark upon this journey for my Tribe and with all of you, my people. I pray that God will continue to be with our Tribe as we continue to build upon the foundation of our ancestors.

Much love to each and every one of you and your families. May God continue to bless our Tribe with growth and prosperity!

I would like to take this opportunity to personally thank each of you for your support last year in my election to the Poarch Creek Tribal Council. This past year has been a great learning experience for me.

For the past several years before, my election to Tribal Council, I served on the PCI Housing Authority; I am honored to continue to serve on the Housing Authority as the Tribal Council representative. We have been able to enhance programs and provide new housing programs that will assist our Tribal people with a better and safe living environment.

As we grow as a Tribe I see greater growth within our housing program that will better serve our Tribal communities as well as our Tribal livelihood.

Over the years we have had the opportunity to add additional housing subdivisions beyond the five core subdivisions (Willow Creek, Rolin Hills, Moniac, Red Oak and Fred Walker) such as the new "Walker" subdivision located in Pensacola, FL.

Currently under development is our newest project of two story townhouses, Moniac Townhouses,

located on Lynn McGhee Drive. The Housing Authority has developed a homeowner subdivision, Tullis Manor, and is currently developing another homeowner subdivision, Bell Creek, both of which are located in Poarch.

We have introduced many new housing programs to better assist Tribal families. We now have a Renovation Loan Program through Housing that is available for all Tribal Members in or outside the service area. This loan can be used to add up to \$50,000 in value to the homeowner's property. We have developed other programs such as Senior/Disabled Emergency Funds, Tribal Assisted Homeownership (TAHO), HVAC Heating/Cooling Loan, and Rehabilitation Loan.

I feel honored and proud to be among such great leaders of our Tribe, as well as a generation of leadership within my personal family, such as my great-grandfather, the late Chief Fred Walker; my great-uncle, Chief Calvin McGhee; and my uncle, the late Chairman Fred McGhee. I feel in my heart these individuals had nothing but the Tribal community in their heart and a vision for our Tribal heritage, rights, and community support.

We, the Council, are faced with many important issues through the process of maintaining our current stability and our sovereignty on trust lands. In my experience this past year I have gained more knowledge of the legal battles we as a Tribe are facing at the federal, state and local level, as well as issues within our Tribal communities. As we continue our growth, our communities should focus on the unity our Tribe has been built on.

I know that the biggest issue we are facing today is the Enrollment of our Tribe. I just want to let the General Council know that I take this issue very serious and want to make sure that the approach to this issue is done with the utmost respect and love to all Tribal Members involved whether there is an increase or decrease in blood quota.

In closing, I say again it is an honor to serve the General Council as a leader on the Tribal Council. I would also ask that all of you continue to pray for the Tribal Council as well as our Tribe. We are faced with many complex issues throughout Tribal and Governmental agencies.

HISTORY IS MADE-GENERAL COUNCIL ELECTS FIRST FEMALE TRIBAL CHAIR

In the exciting and historical election held Saturday, June 7, 2014, Stephanie A. Bryan was elected as the Poarch Band of Creek Indians (PBCI) first female Tribal Chair. Bryan remarked:

“I am so humbled that the General Council chose to put their faith and confidence in my leadership abilities. There is no better feeling as a leader than to know that I’ve been part of a decision that has positively affected the quality of life for my constituents. Words cannot express how honored I feel to be the first woman elected as the Tribal Chair for the Poarch Creek Indians. I’m ecstatic to be embarking upon this new journey on behalf of my people.”

Mrs. Bryan has served as the Vice Chair for the Poarch Creek Indians Tribal Council since 2006. Additionally, she has fulfilled various leadership roles on numerous boards, committees, and authorities including: Chair

of the PBCI Tribal Gaming Commission, member of PBCI Health and Family Services Committee, PBCI Budget and Finance Legislative Committee, PBCI Education and Labor Legislative Committee, National Indian Gaming Commission Working Group, and United South and Eastern Tribes Delegate. She will be assuming the position of Chair for the Poarch Band of Creek Indians which was previously held by Chairman Buford L. Rolin, who is retiring.

A swearing in ceremony will be held during the Tribal Council meeting on June 19, 2014 for the Tribal Council candidates who were elected into office on Saturday, June 7, 2014. Along with Mrs. Bryan, incumbents Arthur Mothershed and Garvis Sells will be sworn in as Tribal Council Members at Large.

2014 TRIBAL ELECTION RESULTS

A total of 1,394 General Council Members voted in the Tribal Election held on Saturday, June 7, 2014. There were 259 Absentee Ballots, 550 Walk-In Ballots counted and 585 General Council Members who voted in person on Election Day.

Not only was this a record breaking turnout, but history was made when the General Council elected Stephanie A. Bryan as the first female Tribal Chair.

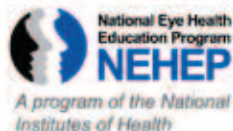

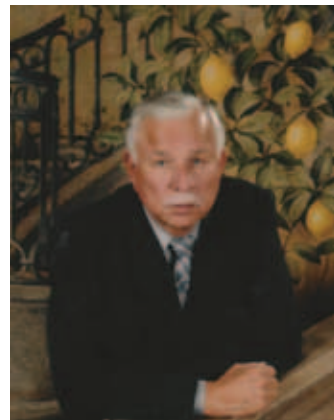

Changing The Guard





CHAIRMAN ROLIN HONORED

Poarch Band of Creek Indians Tribal Citizens, Tribal Employees, USET Tribal leadership, and Chairman Rolin.

(Bar Harbor, Maine) - - For more than 50 years Buford L. Rolin has been a leader to the Poarch Band of Creek Indians, and an advocate for American Indian and Alaska Native issues. Chairman Rolin has been an iconic figure in Indian Country when there have been issues and challenges to meet regarding Tribal healthcare policy and funding. Recently he has announced he will retire from Tribal leadership with the Poarch Band of Creek Indians... but not quit he says.

More than half a century ago Chairman Rolin was coming home to Alabama after completing his service to the United States armed forces, when the Chief requested a meeting with him. Rolin told USET, "For as far back as I can remember, Calvin McGhee, our first official Chief, had always called me "son". It always felt natural because his son and I were about the same age. But one day, just after I had gotten out of the (military) service, my parents called me and said, "Calvin wants to see

you." Of course I went, and the first thing he said was, "Son, I need your help." And that was the beginning of my life working for our Tribe."

Buford L. Rolin has served as Chairman of the Poarch Band of Creek Indians since 2006 and on its Tribal Council for more than four decades. Chairman Rolin has been a tireless advocate for Indian Country with service on the boards of the Native American Rights Fund, United South and Eastern Tribes (USET) the Tribal Co-Chair of the Tribal Leaders Diabetes Committee, National Indian Health Board (NIHB), and a board member for the National Congress of American Indians.

In 2000, President Bill Clinton, appointed Chairman Rolin to the White House Commission on Complementary and Alternative Medicine Policy. Rolin has received many awards over the years, among them the Jake Whitecrow Award in 2007 from the NIHB, and the Indian Health Service Director's Special

Recognition Award in 2013.

This past March, the Poarch Band of Creek Indians honored Chairman Rolin's lifetime of work by dedicating its new Health Clinic in his name. USET is honoring Chairman Rolin for his contributions as a leader to the organization. USET President Brian Patterson told Chairman Rolin, "USET is moved to take this moment, when our hearts are heavy with joy, to express its gratitude for the love and passion you have given to your Tribe, its citizens, the USET family, and to Indian Country. It is admirable and a privilege to be a Tribal leader and do great things for your Nation. But it is inspiring to learn from a great leader, like you, who demonstrates confidence and courage to be keenly aware that your accomplishments and good work instilled in the community will carry on a legacy of empowerment and provide for many generations to come. Anyone in leadership should all aspire to follow the example you have set."

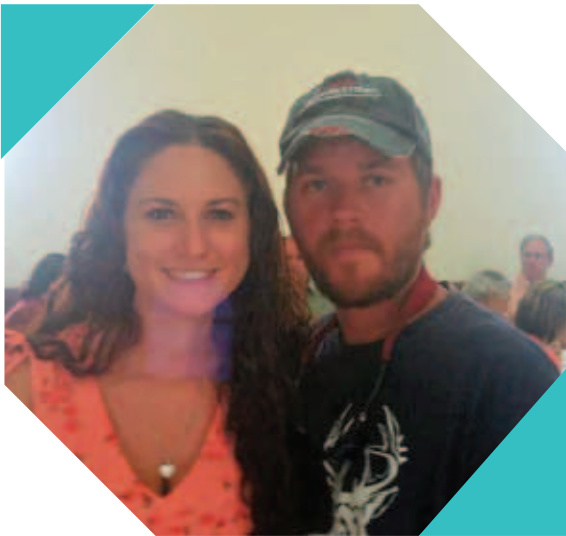

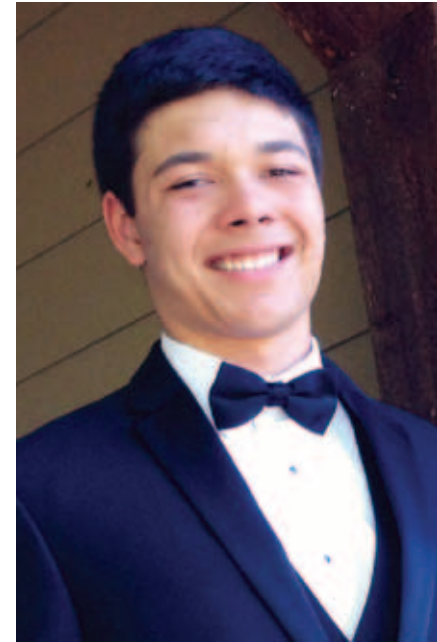
Tanner Liddy To Attend Aspirnaut Program at Vanderbilt University

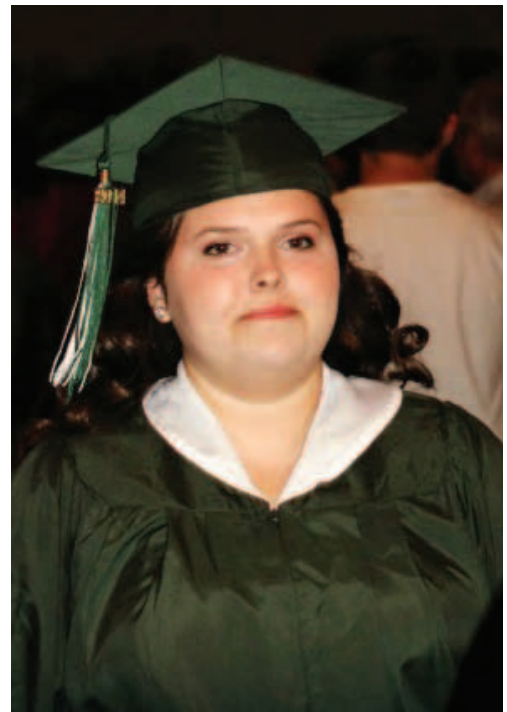

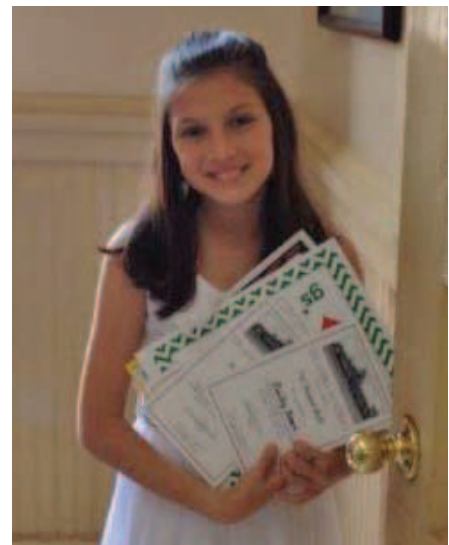
Bailey Jones Receives Several Awards

CREEK WAR OF 1813-1814

Many changes in land territories and boundaries within the present day Southeastern United States had taken place by 1813. When our Poarch Creek ancestors had moved down from their Upper Creek tribal towns around the junction of the Coosa/Tallapoosa Rivers and into the Tensaw area in the late 1790's, they had no concept yet of the name "Alabama". Instead they were inhabiting a region referred to as "Mississippi Territory" also known as the "Southwest Frontier".

The present day state of Florida was then Spanish territory. What we refer to today as the panhandle of Florida, was a portion of Spanish Territory known then as Spanish West Florida. The western boundary of this territory had reached all the way to the Mississippi River as late as 1810. Following the West Florida Rebellion of 1810 the western boundary of Spanish Florida moved eastward to the Pearl River in Mississippi, and by 1813, the year the Creek War began, the border had moved eastward to the boundary of the Perdido River for present day Northwest Florida.

It is important to have some understanding of this constantly changing geography when studying the Creek War of 1813-14. In July of 1813, a group of Upper Creek Warriors journeyed down to Spanish Florida into Pensacola, seeking gunpowder and lead

shot from the Spanish to prepare them for conflicts with American Government that would soon erupt into a national war.

Little did they know that on their return trip they would be attacked by local militia, resulting in the Battle of Burnt Corn Creek on July 27, 1813,

which in turn would lead to the Fort Mims Massacre. These events would quickly bring about the beginning of the Creek War of 1813-14.

In the next article we will examine the Battle of Burnt Corn in greater detail.

This month's Veteran of the Month is the late Don Manac. The article we are featuring this month was originally published in the November 2011 issue of the Poarch Creek News.

My Brother Proudly Served

As Veteran's Day approaches, Calvin Manac thinks about his late brother, Don Manac. Veteran's Day is a national holiday established to honor and remember all Veterans and to pay homage for their many sacrifices; Calvin remembers Don every day, but especially on Veterans Day.

Marine Corps Private First Class Don Manac served during the Vietnam War. During an act that many

have called "heroic" Don was mortally wounded doing what he did not think of as heroic, but as the right, and only, thing to do. His actions on that day, August 20, 1970, earned him a Silver Star. The Silver Star and the following citation were presented to his family.

"The President of the United States takes pride in presenting the Silver Star Medal posthumously to Private First Class Don Manac, United States Marine Corps, for service as set forth in the following CITATION:

For conspicuous gallantry

and intrepidity in action while serving with Company H, Second Battalion, Seventh Marines, First Marine Division in connection with combat operations against the enemy in the Republic of Vietnam. On August 20, 1970, Private First Class Manac was a member of a reaction force which was directed to relieve another Marine unit that had been pinned down by fire from a large North Vietnamese Army force. Arriving at the site of the beleaguered unit, the reactionary force came under intense automatic weapons fire and during the initial moments of the

engagement, two marines were seriously wounded. Observing that the casualties were lying in an open area, Private First Class Manac unhesitatingly moved across the fire-swept terrain to the side of his comrades and, seemingly heedless of the enemy rounds impacting around him, dragged them to a cover location. Having necessarily left their weapons behind, and determined to prevent their destruction or capture by the hostile force, he again braved the enemy fusillade as he retrieved the rifles but, before he could reach the safety of his platoon's defense, he was mortally wounded by automatic weapons fire. His heroic and determined actions inspired all who observed him and were instrumental in saving the lives of two fellow Marines. By his courage, bold imitative, and selfless devotion to duty in the face of grave personal

danger, Private First Class Manac upheld the highest traditions of the Marine Corps and of the United States Naval Service. He gallantly gave his life in the service of his country.' For the President, Will K. Jones, Lieutenant General, U.S. Marine Corps, Commanding General, Fleet Marine Force, Pacific."

Private First Class Don Manac gave the ultimate sacrifice for his fellow Marines, for his family, his Tribe, and his country. We are honored to share this story with you. Mvto to Calvin Manac for sharing this story of valor, pride and history with us.

Beginning May 1, 2014, all applications will be accepted in The Family Services Department waiting room located on the second floor of the Health Department.

If you previously participated in the 2014 Winter LIHEAP program, you do not need an appointment for Summer LIHEAP. You will need to fill out a one page application and present your current energy bill and current income to Family Services Department. You will not be allowed to turn in your application without this information attached.

If you did not participate in Winter LIHEAP, you will be required to fill out a full application and will be required to complete the interview process and submit all required documentation.

Priority is given to Senior households, clients receiving disability income, households with children under the age of 5, and households receiving Food Stamps or TANF benefits.

LIHEAP does NOT pay for any additional fees or services such as late fees, connection fees, outside lights, etc.

Approval amounts range from \$250-\$325. You will be responsible for any charges

that are not covered by LIHEAP. If your bill is less than the awarded amount, only the total amount of the bill will be paid.

Required Documentation

- Current energy or gas bill.
- Social Security cards for ALL members of the household. There will be no exceptions or approvals without SS cards. This is a federal requirement.
- Tribal ID for applicant/head of household.
- Current income verification for all household members that are over the age of 19, such as pay stubs, paychecks, letters of salary verification, etc.
- If anyone in the home over age 19 is unemployed, you must bring a statement verifying they are not working. The statement must be signed by three people who do not reside in your household and must include their phone numbers.
- Current verification if receiving state unemployment benefits.
- CURRENT Social Security or Disability Income Verification. We must have current income verification on file for all 2014 applications and services.

CRISIS ASSESSMENT PROGRAM

The purpose of the Crisis Assessment Program is to assess cases to determine need and to establish appropriate intervention goals to help the Tribal Member household become financially solvent. Please contact us to schedule an assessment if you are experiencing financial crisis situation before you take out a title loan. Title loans will destroy you financially!

Common issues addressed through this program include but are not limited to:

- Financial Management
- Major Medical issues not covered by insurance or the flex card
- Transportation
- Housing
- Other circumstances addressed on an individual basis

Timing is essential. Please do not wait until a crisis situation devastates you financially.

Please note it can take several weeks to complete and process program applications.

The Crisis Assessment process includes:

- Meeting with the Crisis Assessment Coordinator so that your current situation can be assessed and a case plan can be created.
- Taking a drug test.
- Meeting and working with the Financial Counselor to enhance financial management skills.
- Agreeing to get 2015 per capita monthly to secure financial solvency throughout the year.
- Proof of how you spent 2014 per capita.
- Payment, if approved, is rendered to vendors to cover financial expenses.

PHYSICAL THERAPY

We are very proud to announce that our Physical Therapy Department is now open. We have hired Brittany Martin as our Physical Therapist. Physical therapy (sometimes abbreviated to PT) is a health care profession primarily concerned with the remediation of impairment/disabilities and the promotion of mobility, functional ability, quality of life and movement potential. Some benefits to physical therapy include improving motion and mobility, avoiding surgery and prescription drugs, and recovery following surgery. PTs are healthcare professionals who diagnose and treat individuals of all ages, from newborns to the very oldest, who have medical problems or other health-related conditions, illnesses, or injuries that limit their abilities to move and perform functional activities as well as they would like in the daily lives. DIABETES AWARD

The prestigious American Diabetes Association Education Recognition Certificate for a quality diabetes self-management education program was recently awarded to the Poarch Creek

Indian Health Department's Diabetes Education Program. Programs apply for recognition voluntarily. Programs that achieve recognition status have a staff of knowledgeable health professionals who can provide participants with comprehensive information about diabetes management. Education Recognition status is verified by an official certificate from ADA and awarded for four years.

RADIOLOGY UPDATE

Radiology has contracted with the University of South Alabama teleradiology department to read all of our x-ray images. Teleradiology is the term used for internet based transmission of x-ray images from one location to another. Teleradiology improves patient care by allowing Radiologists to provide a diagnosis without actually having to be at the location of the patient.

DOT PHYSICALS

The clinic has received a directive from the State of Alabama that only Department of Transportation (DOT) certified physicians can perform DOT physicals. We have researched options and Dr. Dejardens has graciously agreed to obtain the DOT certification in June to become a certified DOT physician. We will resume these services in July.

AUDIOLOGY/HEARING SERVICE NOW AT HEALTH CLINIC

Audiology services are available on Mondays from 1pm – 5pm in our Primary Care Clinic. We offer hearing tests for all ages. Please note this service is not just about hearing aide testing but much more. If you or your children have experienced frequent ear infections, vertigo, decrease in hearing clarity, dizziness, ringing in ears, than this is a great service for you. If you need to make an appointment call NARO at 251-867-7711 or 251-937-8731.

FREE RETINAL SCREENING

Once yearly retinal screening appointment is carried out to identify early signs of diabetic retinopathy. If allowed to develop, diabetic retinopathy can lead to blindness. For this reason it is important to attend your retinal screening once a year. We do free retinal screenings each month and invite everyone to attend. THE COW THAT GOT DOCTORED¹

*As told to Deidra Suwanee Dees, Ed.D.
by Creek elder Mrs. Roberta McGhee Sells*

"Yeah, we was in the woods a lot of times. Back then the cows kept the undergrowth cut down. We'd turn out the cows to pen up hogs to clean out the hogs. The next day we'd have to go way across them woods to find those cows and bring them back home."

"My mama gave me a setting hen. I took care of her and raised her. I named her Anna. I was just a little girl. She got grown and she set, and she had several little biddies. My brother Mal had some cows and this Jersey cow got sick. He come over there—he always wanted the cream of the crop. He said to Mama, 'I want that ole hen with those biddies. I got that ole heifer out there. You can have her, but you have to doctor her up.'"

"Mama said, 'Mal, she ain't mine. She belongs to Bert.' He said, 'Well, Bert belongs to you, don't she?'"

"Mama said, 'You let him have her because you know how he is. When we doctor the calf and when we get her well, you can have her.' That kinda satisfied me a little bit."



Mrs. Roberta McGhee Sells served on the Tribal Council of Creek Nation East of the Mississippi in the position of Secretary from 1950-1977.

"We doctored that ole cow and doctored her. She had hollow horns and a hollow tail. We cut them horns off and filled up what was left with runtar, turpentine... We just made up a solution. Then we tied it up so she couldn't get it off. Then the tail was split and cut, and we filled it up with the solution. We got a piece of material and *wrapped it, wrapped it, wrapped it*. In a few days, the ole cow was really improved. I named her Singy. She got up and got grown."

"We always would have to turn the cows out to go to the woods to feed. And she was the leader of the bunch. She didn't get very big. My Mama

would get out on the back porch and she'd call, 'Coooooh, Singy!' Singy raised her head up and listened. The next time she hears that holler, she strikes out coming this-a-way and the others would follow. She was trained pretty good."

"She was the best milk cow. I remember she gave the best milk we ever had. You could sit in a chair and milk her, and she wouldn't never move. She brought us a lot of calves. We kept her all her life. I'm always bad about doing that anyway—keeping animals around. I got a old cow out there now—the only one I got—Singy's granddaughter. My son said, 'Mama, why don't we carry old Dolly to the sale pen.' I said, 'No sir! Dolly ain't the first cow and she ain't gone be the last one to die on this hill.'"

"Singy's passed on. Mal's passed on. I don't know what ever become of Anna and her biddies. Singy sure lived a long time. When she died, we buried her under that oak tree over yonder. He never knowed it, but I think I got the better end of the deal than Mal."

Small Decisions Make Big Things Happen

Who Needs Testosterone? YOU.

Testosterone is a small hormone that has a *big* impact. Testosterone allows you to maintain high energy levels. 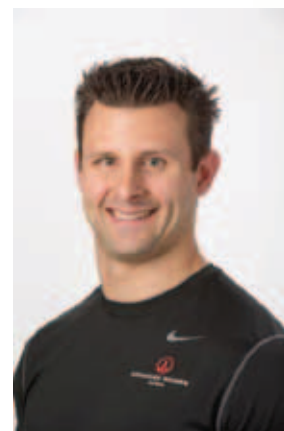

I'm STRESSED!! Lets Eat!

Life has a way of throwing us curveballs, which can lead to stress. Stress can lead to overindulgence in the wrong foods. When your stress levels rise, so does your desire for comfort foods. Foods like macaroni and cheese, mashed potatoes and gravy, cakes and other sweets, can seem like a good choice to make you feel better. However, rich and calorie dense foods only lead to increased extra body fat and a lethargic feeling after eating them.

Help yourself to feel better short term and long term by following these nutritional tips when you are feeling stressed:

- **Breakfast:**

Consistently eating breakfast is important in maintaining appropriate blood sugar levels. It also leads to better food choices throughout the day and keeps energy levels steady. Good breakfast choices include slow cooking oatmeal, eggs, low-fat Greek yogurt, fruit and fruit smoothies.

- **Lunch and Dinner:**

Cut back on stimulants like coffee and tea later in the day, as these can contribute to poor sleeping



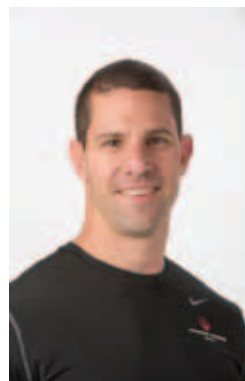
habits resulting in fatigue. Choose unsweetened tea or water with fresh squeezed lemon and lime for flavor.
