OVERVIEW

As a Federal Mandate, the ONC has initiated that all persons, practitioners, clinics and hospitals are required to have Electronic Health Records (EHRs) by 2015. EHRs enable information exchange between health care providers and public health authorities.

According to the Bureau of Labor Statistics and Department of Education, approximately 50,000 qualified health information technology workers will be needed to meet this mandate by 2015.

The CAHIIM accredited Health Information Technology program at Midland College offers an intensive online Continuing Education training program in six Health Information Technology Workforce roles to be completed in less than six months.

Midland College offers a certificate of completion. Upon completion, graduates are expected to sit for the national competency exam developed by the American Health Information Management Association (AHIMA). For more details, visit www.hitproexams.org.

Graduates will find employment with health care institutions, physician offices, and vendors of EHRs. Job placement assistance is available.

ADMISSION REQUIREMENTS

Health Information Technology / Management professionals

Associate degree or higher from a CAHIIM accredited college or two years of experience or combination.

Information Technology professionals

Minimum two years IT education or two years IT experience.

Military *

- Two years experience related to health information, database management, MIS, HIS, communications, technology, healthcare delivery, or electronic data interchange or
- Currently employed at the VA, DoD, IHS, or military base with healthcare or Information Technology experience.

Physician Office Setting

One year experience related to physician practice management, coding, billing, related experience.

Hospital Setting

- Associate degree or higher in a healthcare related field or
- Two years experience directly related to health information management or health-care Information Technology systems.
