## 2022 Tribal Council Election Calendar

**FRIDAY, APRIL 15, 2022** – Names of candidates and any proposed constitutional amendments, ordinances and/or resolutions will be posted.

**FRIDAY, APRIL 15, 2022** – Official List of Eligible Voters will be on display in Building 100 at the front desk (Thelma’s area).

*Pursuant to Title 22 Poarch Band of Creek Indians Election Code*

*22-7-5 Voter Eligibility*

*(a) Official List of Eligible Voters*

*The Election Board shall compile, in alphabetic order, an official list of Eligible Voters as of the date of publication. A copy of this list shall be posted at the tribal offices, for public review at least fifty (50) days prior to the election.*

**THURSDAY, MAY 5, 2022** – Last day to submit Letter of Candidacy and fees for Tribal Council to be a Write-in on Ballot. Any additional names of candidates will be posted within 10 days.

**MONDAY, MAY 23, 2022** – Walk-in voting starts and continues through Friday, June 3, 2022. Open daily from 9:00 a.m. to 6:00 p.m. except for Sunday and Monday, May 29-30, 2022.

**MONDAY, MAY 23, 2022** – Last day to request Absentee Ballot to be mailed out.

**FRIDAY, JUNE 3, 2022** – Deadline for Election Board to receive Absentee Ballots at 5:00 p.m.

**FRIDAY, JUNE 3, 2022** – Walk-in voting ends at 6:00 p.m.

**SATURDAY, JUNE 4, 2022** – Tribal Election Day. Polls open 8:00 a.m. – 7:00 p.m. at the Pickrell House (on Pow Wow grounds). Results will be announced at the Calvin McGhee Memorial on the Pow Wow Grounds and will be live streamed on the Tribe’s official Facebook page, will be posted at the PCCC front door, on the Pickrell House door, and will be published in the July issue of the Creek Corner.


# 2022 VOTER GUIDELINES & ELIGIBILITY

1. Only the Eligible Voter will be allowed inside the building.
2. The number of Voters in the building will be limited.
3. Voters are asked to remain 6 feet apart from other voters at all times (inside and on the porch of the building as well).
4. Hand sanitizers will be available after you sign in and as you exit the building.
5. Please touch only necessary items while inside the building.

Sec. 22-7-5 - Voter Eligibility (a) Official List of Eligible Voters The Election Board shall compile, in alphabetical order, an official list of Qualified Voters as of the date of publication. A copy of this list shall be posted at the Tribal offices, for public review at least fifty (50) days prior to the election. (b) Eligibility Disputes The Election Board shall determine the eligibility of any written claim to vote presented to it by one whose name does not appear on the official list of Qualified Voters as well as written challenge of the right to vote of anyone whose name is on the official list. It shall rule on all claims no later than ten (10) days before the election. Any claim not presented at least ten (10) days prior to the election shall not be allowed. The decision of the Election Board shall be final.

**Government Transparency:** Through social media, TMOP, Poarch Creek Connect, Rapid Cast, posting of Workshop and Tribal Council Meeting Minutes, Live streaming of Tribal Council and Community Meetings, and more dialogue at the Council Table, the Tribal Members in and outside the service area are better informed daily. Effective communication is the key to meeting the needs of our people.

As our Tribe continues to grow, we find ourselves planning for new developments and programs in many of our departments, in order to better assist our people. We now provide services at the Health Clinic to first generation up to the age of 26, extended hours at the Pharmacy and have made improvements at the Assisted Living Facility. ## DEWITT CARTER (INCUMBENT)

We are breaking ground on our eighth casino and entertainment center in Illinois. This has broadened the Tribe's portfolio. Also, despite the complications brought forth by the pandemic, we were able to complete the construction of two administrative buildings that add to the allure of our reservation.

By being a member of the Tribal Council, I was appointed to the Alabama Juvenile Justice State Advisory Group by Governor Kay Ivey. This allows me to compile the information to share with our Education Department in order to utilize funding to apply for grants.

During the storms of 2016 and 2020, I was also able to lend support to Tribal Members by transporting necessary fuel, supplies and equipment. As a result, power was restored to thousands of residents, including many Tribal members in Southern Louisiana. I am proud of this opportunity which enables me to help our Tribal Members! This is the most rewarding aspect of being a member of the Tribal Council. . My exceptional communication skills have allowed me to fully understand issues impacting our community. While I do not have all of the answers, I will continue to address all of the concerns that are brought to my attention by vocalizing your thoughts in order to resolve matters in a beneficial manner to the tribal community as a whole.
