

WOMAN'S HISTORY

March is Women's History Month, and this year the National Women's History Alliance has chosen the theme "Women Providing Healing, Promoting Hope." The women featured below have done an amazing job of doing just that.

Nancy Smith, MSN, CCRN, CNL, has served as our Director of Nursing and Infection Control Specialist for 9 years. She has been instrumental in our creating safety protocols related to COVID-19, and our testing capabilities. Nancy currently serves on the PBCI COVID-19 Vaccination Team. She is a graduate from the University of Alabama and holds her Master's Degree in Nursing. Nancy loves working with the Tribal Community and has seen a great strength and resilience in our staff and our community as we fight this pandemic together. She loves the vaccine team and meeting people from all parts of the enterprises by taking vaccines on the road. She urges everyone to roll up their sleeves and take the jab.

Sandra Day has worked as a Registered Nurse for the past 44 years, primarily in Community/Public Health. In April 1998, she became the PBCI Health Department Community Health Director. In this role, she has served as the vaccine coordinator for pediatric and adult vaccine programs. The PBCI Health Department began preparing for the COVID-19 Vaccinations in the fall of 2020 and held the first vaccine clinic on December 28, 2020. Since then, they have administered 6,913 individual doses of the vaccine in the local community. As part of the PBCI COVID-19 Vaccination Team, she has participated in vaccine clinics as well as distributing helpful information about the vaccine and the dangers of COVID-19. The initiation of the COVID-19 Vaccine Program was a massive, yet successful, undertaking brought on by the tireless efforts of multiple team members of the Poarch Band of Creek Indians Emergency Management and Healthcare programs in carrying out "Operation Warp Speed."


Selina Chee graduated from the University of Louisiana Monroe Pharmacy School in 2005. She has since been certified in immunizations through the American Pharmacist Association. In 2006, she completed her pharmacy residency specializing in community pharmacy. She, along with Sandra Day, has led the PBCI COVID-19 Vaccination Team since December 2020 for Operation Warp Speed. Selina has served in many capacities for the Vaccination team, including vaccinator, screener, documenter, and training others to become vaccinators.

Shelley Pierce started as the PBCI Health Department Receptionist and worked her way up to the Administrative Assistant for the Health Director. She now works as a Loan Analyst for the Tribe. Shelley was involved in the PBCI COVID-19 Vaccination Team from its start in December 2020. She scheduled vaccines at first, and then took over the COVID-19 Vaccination Scheduled Website. She participated in countless vaccine clinics, assisted with staffing them and the logistics for the traveling clinics.

April Sells is the PBCI Tribal Emergency Management Director. She, along with her staff, became involved with the vaccination process in February 2021 with the mass vaccination clinic. She served as the mass vaccination clinic manager, but now helps in any way she can with the COVID-19 vaccine clinics. April has always been an amazing team player. “We have done so many clinics that we can set up and manage these clinics in our sleep. When I see a job that needs to be filled I step in. We have worked so closely with the Health Department that we know each other well, and can step in and not slow down.”

Other key employees who have worked or are currently working with the PBCI COVID-19 Vaccination team are: Kelli Ramer, Heather Weaver, Logan Smith, Terry Sweat, and Wayne Colbert. We appreciate all of the work you all are doing to keep us and our community safe! ☺



POARCH CREEK FIRE RESCUE

With the approval of funds by Tribal Council, Poarch Creek Fire Rescue was able to purchase a new 2022 KME Fire Apparatus to be the primary pumper at Station #2 at 845 Poarch Road, Atmore, Alabama. Engine 102, also known as E102, was named after former Fire Chief Ronnie Jackson. Chief Jackson spent over 35 years employed by the Tribe and was one of the founding members of the Poarch Creek Volunteer Fire Department, which is now a full-time, paid fire department operating 24 hours per day, 7 days per week, 365 days per year.

Local citizens may not be able to tell the difference between E102 and 706, which is the primary pumper at Station #1 at 5971 Jack Springs Road, Atmore, Alabama, as they are the same make and model fire apparatus with only a few modifications between the two. E102 was purchased at NAFECO and was built specifically to the department's specifications in Nesquehoning, Pennsylvania. NAFECO delivered E102 to Poarch Creek Fire Rescue in August of 2021.

Citizens within the Tribal community may see the department pumpers out and about from

time-to-time and notice a small difference on the apparatus. In honor of Chief Jackson's support to veterans, the department teamed up with Landis Design Company to have decals made for E102 and 706. The decals are located on the tops of each apparatus cab. Chief Jackson has always been a strong supporter of military veterans. This was a small way for the department to show their respects to our country's veterans.

Due to the COVID-19 pandemic still heavily affecting the Tribal community, Poarch Creek Fire Rescue has not yet been able to have a proper

dedication of E102 to the department and to Chief Jackson. The department hopes to host a dedication of E102 to former Chief Jackson when the pandemic eases up on the Tribal community.

Poarch Creek Fire Rescue is very pleased and proud of E102 and without the approval of funds by the Tribal Council, the purchase of this apparatus would not have been possible. ☯

Graduating Seniors must complete an application, 40 hours of community service, attend a (2) day course on your Poarch Creek Indian History and Culture, and successfully pass a drug and alcohol screening. If you do not meet all of the requirements, you will not be able to attend.

This trip is TENTATIVE due to COVID 19 and the Tribe's travel policy.

The Family Services Department is committed to meeting the Tribe's mission of "Prosperity and Self Determination" by providing comprehensive services to promote the safety, permanency and well-being of tribal member children and families. Individual and family assessments conducted by dedicated staff will be utilized to evaluate needs and approve appropriate services from many grant-funded programs, as well as Tribal funded programs. The Department will also provide wrap-around services to meet the needs of tribal members from infancy through adulthood. Pursuant to the Poarch Band of Creek Indian Tribal Code, § 8-6-11, the Family Services Department keeps confidential all personal identifying information and records regarding any clients we serve. All information and records are kept strictly confidential and are not subject to public use or inspection.

PCI Family Services Department serves as the social work providers for our Tribal Community. The Family Services Department's core investments in the Tribal Care System include:

- A commitment to provide safe, sanitary and healthy environments for tribal members
- A commitment to developing basic need resources and to providing resource advocacy
- A commitment to develop an internal infrastructure for efficient delivery of tribal services
- Fostering tribal and family connections
- Building quality adult and child welfare practices
- Focusing on Prevention and Family Preservation



UTILITIES PROJECT UPDATES

DWIG (Drinking Water Infrastructure Grant)

This grant will provide the funding for many new projects including:

- » *Increase the production rate at the west well from 400 to 800 gpm: Design is under way.*
- » *New sampling stations: Quotes are currently being obtained.*
- » *New meter reading software: Project is being scoped to utilize the available funding.*
- » *Replace all aged-out meters: Assessment is under way to begin procurement.*
- » *New water line extension to the new tank: Design complete and is out to bid.*
- » *SCADA upgrade: Specifications are nearly complete and going to bid early March.*

Current Projects:

- » *New water storage tank located by the Travel Plaza: Construction is complete and the tank is erected. Painting and electrical is under way and is schedule to be filled for use this spring. This tank addition will support future area growth.*
- » *Tullis Manor Lift Station Discharge Rehab: The discharge piping and check valves at the Tullis Manor lift station are being replaced due to lightning strike damage and the new piping and valves will be above ground instead of under concrete like the existing.*



Upcoming Projects for the Year:

- New sewer force main from Rolin Hills to the WWTP: Needs are being evaluated and consultations have started for design team selections. The project is already funded but opportunities for funding assistance are being investigated under the Bipartisan Infrastructure Bill.
- Phase 3 of Canoe water lines replacement: Project scope is established and expected to complete the water line upgrades in Canoe. Funding for this project has been secured, however, funding assistance is being explored through the Bipartisan Infrastructure Bill. ☈
