- » 300 words or less.



HOUSING POLICY CHANGES

PER RESOLUTIONS DATED OCTOBER 21, 2021

Housing Rehabilitation Program

This is a loan program.

Summary of approved changes:

- Tribal Members living outside of the Tribe's designated services area can apply for the Housing Rehabilitation Program.
- TAHO participants are not eligible to participate in the Rehabilitation Program
- There is no penalty for an early payoff for the Housing Rehabilitation loan.
- An updated Grievance Procedure was added to this policy for those applicants wishing to grieve a denial of services through the Housing Rehabilitation Program.

Emergency Rehabilitation Program for Tribal Seniors and Disabled Persons

Commonly known as the Senior Emergency Program; This is a no-payback program

Summary of approved changes:

- Participants who have a long-term lease in a house in need of rehabilitation services must:
- 1. Submit a copy of their Lease Agreement to the Housing Department
- 2.The Housing Department will determine if the rehabilitation work should be performed by the Landlord/Homeowner and will assist the Participant in submitting the Emergency Rehabilitation request to their Landlord/Homeowner.
- 3.If the Emergency Rehabilitation work is determined to be approved through the Housing Department, a Rehabilitation Program Property Owner's Participation Agreement and a Lease Addendum must be completed by the Participant and the Landlord/Homeowner. Housing Department staff will assist the Participant in getting these forms signed.
- A total of \$15,000.00 per lifetime of Emergency Rehabilitation services are allowed per Tribal Member household regardless of how many eligible Tribal Members reside in the household.
- 4.The total funding of \$15,000.00 may be spread out over a period of time. For example, replacement of plumbing may cost \$10,000.00 for an approved household. That Tribal Member household would be eligible to utilize the remaining \$5,000.00 if approved for a different emergency rehabilitation service at a later time.
- An updated Grievance Procedure was added to this policy for those applicants wishing to grieve a denial of services through the Emergency Rehabilitation Program for Tribal Seniors and Disabled Persons Policies and Procedures

The Tribally-Assisted Home Ownership Program

Commonly known as the TAHO Program; This is a loan program

Summary of approved changes:

- A person listed as the Successor for a TAHO home must be at least the age of 21.
- If a TAHO Participant fails to make payments on their TAHO loan, the balance owed will become a Tribal Obligation Default. The policy change in this section ensured that the language regarding Tribal Obligation Defaults was changed to be consistent with the current General Welfare Assistance Program Policies and Procedures.
- TAHO Participants may apply for a Renovation Loan after then have lived in their TAHO home at least 6 (six) months.
- TAHO Participants are required to recertify with the Housing Department annually. There are penalties implemented if the TAHO participant does not recertify annually. The policy was updated to increase the penalty of not recertification, and, after the 4th month of not recertifying, the TAHO Participants monthly payment will adjust to 30% of the last reported adjusted household income.
- An updated Grievance Procedure was added to this policy for those applicants wishing to grieve a denial of services through the Tribally Assisted Home Ownership Program.

The Heating and Cooling System Loan Program Policies and Procedures

Commonly known as the A/C Loan Program

Summary of approved changes:

- One (1) Heating and Cooling Loan is allowed per Tribal Member household every five (5) years.
- Participants in this program must complete a Promissory Note.
- Funds for this loan must be paid back within five (5) years, however, there is no penalty for paying the loan back early.
- There are Resale Restrictions in place should a Participant in this program decide to sell their home prior to paying off this loan program.
- 1.The Participant must repay the Tribe any balance due on this loan at the time of sale, unless:
- 2. The sale of or transfer of the home is to another Tribal Member who:
 Is willing to fully assume payment of the loan and sign a Promissory Note, and
 Is qualified for the Heating and Cooling Loan Program
- An updated Grievance Procedure was added to this policy for those applicants wishing to grieve a denial of services through the Heating and Cooling System Loan Program Policies and Procedures.

Required Documents for all persons listed on application:

- Copy of 2020 Tax Returns
- Social Security Card(s)
- Tribal ID Card and/or Letter of 1st Gen Descent
- Drivers License
- Custody, Homeless, and/or Substandard Living Verfication
- Other documents as requested by the Housing Department

Other Requirements:

- Credit score of 550 or higher
- Lives in Tribal Services Area
- Haven't participated in any homeownership program in the last 5 years
- Qualifies for Low, Very Low, or Over Income
- Haven't withdrawn from or declined TAHO program in the last 12 months

SPAY/NEUTER EVENT


The Environmental Department will be giving out spay/neuter vouchers for cats and dogs beginning:

SOCIETY OF ALABAMA ARCHIVISTS MEETS TRAIL OF TEARS FILM

"Exciting news! After over forty-two years of being lost, the 'Trail of Tears' film was found!" Director/ Tribal Archivist Dr. Deidra Suwanee Dees said to archivists at the virtual Society of Alabama Archivists Annual Meeting on October 22, 2021. She and Alabama A&M University Archivist Ms. Veronica Henderson shared their journey of rediscovery spanning more than eight years.

Ms. Henderson explained that James Buford Robison studied film at Alabama A&M University. After graduation, Robison worked in the University's Telecommunications Center with Dr. Hayward Handy and Dr. Elizabeth Sloan Ragland, leading the research journey to produce a documentary for Alabama Public Television.

Ms. Henderson said, in 1978, Robison learned about the Tribe and contacted our Tribal Council. Working together, the Center began developing the documentary on the 1830 Indian Removal Act, known as the "Trail of Tears."

Dr. Dees explained the Removal Act was intended to remove the five southeastern Indigenous nations to land west of the Mississippi to make room for the new Euro-American Nation. This life-shattering event disrupted the course of American history.

Creeks hand-sewed authentic 1800s clothing, and Robison/crew developed scripts and shot film of

Creeks reenacting the forced march west. These scenes of removal were enacted by Creeks who, ironically, are descendants of those who were not removed.

Before the film was televised, Robison left employment at the University and the film became lost. For almost forty-three years, the film remained lost except in the memory of participants.

As the number one requested item, our Team worked diligently with Ms. Henderson and Director Elvin Jenkins to find the film. The work paid off! In March of 2020, while COVID was intensifying, Mr. Jenkins announced they rediscovered this treasured jewel!

Joyfully, the film was digitized and shown to the Tribal community in the safe environment of the Internet. For the first time, we were able to view the Trail of Tears film of our family members.

Office of Archives and Records Management staff, Mr. Chad Parker and Ms. Cheryl Thrower, also attended the Annual Meeting. Networking with other archivists around the State is a great way to learn about Creek records, and perhaps could lead us to records showing whether the film was ever broadcast.

Staff showed a segment of the film and answered questions, hoping to use our successful journey as a model for others to follow. "It has been a distinct honor," Dr. Dees said, "to make acquisition of this important film that tells the factual story of what really happened on the 'Trail of Tears.'" Mvto.

WHEN'S THE MEDICARE OPEN ENROLLMENT PERIOD?

Every year from October 15 - December 7.





Medicare health and drug plans can make changes each year—things like cost, coverage, and what providers and pharmacies are in their networks. October 15 to December 7 is when all people with Medicare can change their Medicare health plans and prescription drug coverage for the following year to better meet their needs.









HOW DO PEOPLE KNOW IF THEY NEED TO CHANGE PLANS?

People in a Medicare health or prescription drug plan should always review the materials their plans send them, like the "Evidence of Coverage" (EOC) and "Annual Notice of Change" (ANOC). If their plans are changing, they should make sure their plans will still meet their needs for the following year. If they're satisfied that their current plans will meet their needs for next year and it's still being offered, they don't need to do anything.

Dr. Selina Chee is originally from Louisiana and has been in the healthcare field for 16 years. Currently, she serves as the Chief Pharmacist for the Buford L Rolin Health Clinic. Before coming to work for Poarch, Dr. Chee worked at the Dispensary of Hope, Ascension Saint Thomas, and Reeves-Sain Drug Store. She decided to get into the medical field because of her overwhelming desire to serve her community. One of the things she loves most about her job is that there is never a dull moment. We asked Dr. Chee what she feels the most pressing medical issue facing our community is, and she replied that COVID-19 is the most pressing medical issue at this time. She also offered this general medical advice to the community, "It is important to keep a list of your current medications and allergies with you in case of emergencies."



Ray Young, PharmD is a Staff Pharmacist at the Buford L Rolin Health Clinic. He wanted to give something back to Native people in hopes of learning and preserving the heritage. Ray Young has been in the healthcare field for 13 years, and obtained his Doctorate of Pharmacy from the University of Mississippi. His favorite part of his job is the patient and staff interaction. In his spare time, he works with abandoned dogs that he's adopted. Ray believes the most pressing medical issue facing our community is diabetes. His general medical advice is, "Deny pleasures of foods, drink, and vices to preserve your longevity and teach young ones your rich heritage and inner strength. Seek to set an example, and always hold yourself to a high standard."




Susan Hayes obtained her Bachelor of Science – Pharmacology from the University of Arizona and has been in the medical field for 32 years. She has worked for several Native American tribes including the Shoshone-Paiute, the Fort Belknap reservation, and the Navajo. She started at the Buford L Rolin Health Clinic in a contract position and now serves as a full-time Staff Pharmacist. The close connection between clinic staff and the community is one of her favorite parts of the job. She also appreciates how supportive members of the Health department staff are. Susan believes the most pressing medical issue facing our community is COVID-19. Her general medical advice is, "Get vaccinated for COVID and don't smoke or vape."

- Less than 1% of bacteria cause disease. Most are beneficial for our good health and the health of The Earth's ecosystems. Most viruses cause disease.
- Bacteria have cell walls and all of the equipment needed to survive and reproduce. Viruses must invade a 'host' for reproduction and survival.
- Antibiotics may be used to treat some bacterial infections, but they do not work against viruses. Some severe bacterial infections may be prevented by vaccination. Antiviral medications are not effective against bacteria.
- The symptoms of infection from bacteria or viruses are similar. Your health professional will help you determine whether it is caused by virus or bacteria. Antibiotics will not treat viral infection, may cause side effects and contribute to bacterial resistance.
- If you have a virus, the treatment is rest, drink fluids and treat the symptoms.
- If you have a bacterial infection, follow your health provider's instructions.
- Please do not make this determination without your health provider's assistance.

BENEFIT TIMELINE TO COMMERCIAL TOBACCO CESSATION

We have all heard that smoking commercial tobacco has health consequences. There are 69 known carcinogens in commercial tobacco cigarette smoke, including things like arsenic, cyanide, ammonia, formaldehyde, and carbon monoxide Smoking one cigarette can have a measurable increase in carbon monoxide levels and a decrease in oxygen levels.

In total, there are about 7,000 known chemicals in commercial cigarette tobacco smoke. Several hundred are harmful, and about 70 can be downright deadly. Smokeless tobacco has a similar risk profile, and vaping can cause acute, life-threatening pulmonary failure in even young, healthy individuals due to lipid emulsions used in some products. The good news is that quitting commercial tobacco has many shortand long-term benefits. For example:

At **20 minutes** after stopping, your blood pressure and body temperature return to normal.

At **8 hours** after quitting, your carbon monoxide levels drop and oxygen levels return to normal.

24 hours post-quitting your odds of a life-threatening cardiac event decreases.

At **48 hours**, your nerve ending fibers start to regenerate, and you can tell a noticeable improvement in taste and smell.

72 hours after quitting, lung function and energy increase.

At **14 days to 3 months**, your circulation and lung function improves more so that moving about becomes less tiring.

From 4 weeks to 9 months, coughing, sinus congestion, feeling tired, and shortness of breath decrease.

At **1 year**, you have cut your heart disease risk in half compared to a current smoker.

5 years after quitting, your risk of cancers of the throat, mouth, and esophagus are cut in half vs. an active smoker.

10 years after quitting, your odds of lung cancer are half that of a regular smoker.

15 years after your quit date, you have no more risk of heart disease or death in general than someone who has never smoked.

The benefits of those around you are dramatic, as well. All this coupled with the cost savings you would realize over a relatively short time makes kicking the habit more attractive than ever. See your pharmacist or physician in the clinic for information on how we can help you achieve access to these benefits and more! With proper planning, all that is required is motivation and a desire to succeed.

VACCINATIONS - ADDRESSING COMMON CONCERNS

Why vaccinate?

To prevent diseases and poor outcomes of infections. The immune system is the body's way of preventing diseases. Vaccines reduce our risk of infection by working with the body's natural defenses to help safely develop immunity to diseases.

What are antigens?

Antigens are parts of germs that cause the body's immune system to go to work. Vaccines use small amounts of antigens to help our immune systems to recognize and learn to fight the diseases.

Are vaccines safe?

Yes. The Centers for Disease Control and Prevention (CDC) and the US Food and Drug Administration (FDA) take many steps to make sure that all vaccines are safe and effective before and after the public begins using them.

Am I going to get sick from a vaccine?

Like any medicine, vaccines can cause side effects. Some side effects that can occur are low-grade fever, pain at injection site, and feeling tired. These will only last a few days. You can take acetaminophen and diphenhydramine if needed. Rest and fluids will also help.

What is a "breakthrough" case?

A "breakthrough" case is when a fully vaccinated person gets the disease that he/she was vaccinated against. No vaccine provides 100% protection against infection. The vaccine helps the body learn to fight the infection, so if you were to catch the infection then it will be less severe.

It is better to prevent a disease than to treat it after it occurs.

Vaccines are safe and effective. There are vaccination schedules for children and adults.


