*\*Section 33-2-7(c) Appeal of Denial of Application of Title 33 (Tribal Employment Rights) of the Tribal Code states, "Within fifteen (15) days of receipt of the TERO Director's issuance or denial of an application, the applicant may request a hearing before the TERO Commission on the application to appeal the preference category or a denial of an application. The TERO Director shall have the burden of proof by the preponderance of evidence to justify the preference category or the denial of an application. The principal(s) of the business shall be present at the hearing and shall have the opportunity to present evidence in support of their case. In addition, any person wishing to present information to the TERO Commission shall be entitled to do, by requesting an opportunity to participate, no less than one (1) day prior to the hearing. The determination of eligibility as to certification or registration of a business enterprise is vested exclusively in the TERO Commission whose decision shall be final and binding and not subject to any further appeal."*
